1	A BILL to amend and reenact §30-8-3, §30-8-6 and §30-8-9 of the Code of West Virginia, 1931,
2	as amended, all relating to the practice of optometry; establishing the Accreditation
3	Council on Optometric Education as an accrediting body; defining ophthalmic surgery;
4	removing obsolete areas of the code; and requiring certain procedures to be approved by
5	an accredited body.

Be it enacted by the Legislature of West Virginia:

ARTICLE 8. OPTOMETRISTS.

§30-8-3. Definitions.

1 As used in this article:

2 (a) <u>"Accreditation Council on Optometric Education (ACOE)</u>" is the accrediting body for

3 professional optometric degree (O.D.) programs, optometric residency programs, and optometric

4 <u>technician programs in the United States and Canada and is recognized as an accrediting body</u>

5 by the U.S. Department of Education (USDE) and the Council on Higher Education Accreditation

6 <u>(CHEA)</u>

7 "Appendages" means the eyelids, the eyebrows, the conjunctiva and the lacrimal8 apparatus.

9 (b) "Applicant" means any person making application for a license, certificate or temporary
 10 permit under the provisions of this article.

11 (c) "Board" means the West Virginia Board of Optometry.

(d) "Business entity" means any firm, partnership, association, company, corporation,
limited partnership, limited liability company or other entity owned by licensees that practices
optometry.


(e) "Certificate" means a prescription certificate issued under section fifteen of this article.
 (f) "Certificate holder" means a person authorized to prescribe certain drugs under section
 fifteen of this article.

18 (g) "Examination, diagnosis and treatment" means a method compatible with accredited

- 19 optometric education and professional competence pursuant to this article.
- 20 (h) "License" means a license to practice optometry.
- 21 (i) "Licensee" means an optometrist licensed under the provisions of this article.
- 22 <u>"Ophthalmic Surgery" means an invasive procedure in which human tissue is cut, ablated</u>
- 23 or otherwise penetrated by incision or other means to treat diseases of the human eye.
- 24 <u>"Ophthalmic surgery" does not include those procedures described under §30-8-9 of this code or</u>
- 25 other procedures within the education and training at or through accredited schools or colleges of
- 26 Optometry.
- (j) "Ophthalmologist" means a physician specializing in ophthalmology licenced licensed
 in West Virginia to practice medicine and surgery under article thereof this chapter or osteopathy
 under article fourteen of this chapter.
- 30 (k) "Permittee" means a person holding a temporary permit.
- 31 (I) "Practice of optometry" means the examining, diagnosing and treating of any visual
 32 defect or abnormal condition of the human eye or its appendages within the scope established in
 33 this article or associated rules.
- 34 (m) "Temporary permit" or "permit" means a permit issued to a person who has graduated
 35 from an approved school, has taken the examination prescribed by the board, and is awaiting the
 36 results of the examination.
 - §30-8-6. Rulemaking.
- 1 (a) The board shall propose rules for legislative approval, in accordance with the 2 provisions of §29A-3-1 *et seq.* of this code, to implement the provisions of this article, including:
- 3 (1) Standards and requirements for licenses, certificates and permits;
- 4 (2) Procedures for examinations and reexaminations;
- 5 (3) Requirements for third parties to prepare and/or administer examinations and 6 reexaminations;
- 7 (4) Educational and experience requirements;

appendage within the scope established in this article or associated rules: (2) Administer or prescribe any drug for topical application to the anterior segment of the human eve for use in the examination, diagnosis or treatment of diseases and conditions of the human eye and its appendages: *Provided*, That the licensee has first obtained a certificate; (3)(A) Administer or prescribe any drug from the drug formulary, as established by the board pursuant to section six of this article, for use in the examination, diagnosis or treatment of diseases and conditions of the human eye and its appendages: *Provided*, That the licensee has first obtained a certificate; (B) New drugs and new drug indications may be added to the drug formulary by approval of the board: (4) Administer epinephrine by injection to treat emergency cases of anaphylaxis or anaphylactic shock; (5) Prescribe and dispense contact lenses that contain and deliver pharmaceutical agents and that have been approved by the Food and Drug Administration as a drug; (6) Prescribe, fit, apply, replace, duplicate or alter lenses, prisms, contact lenses, orthoptics, vision training, vision rehabilitation; (7) Perform the following procedures: (A) Remove a foreign body from the ocular surface and adnexa utilizing a nonintrusive method; (B) Remove a foreign body, external eye, conjunctival, superficial, using topical anesthesia; (C) Remove embedded foreign bodies or concretions from conjunctiva, using topical anesthesia, not involving sclera; (D) Remove corneal foreign body not through to the second layer of the cornea using topical anesthesia; (E) Epilation of lashes by forceps;

29	(F) Closure of punctum by plug; and
30	(G) Dilation of the lacrimal puncta with or without irrigation;
31	(8) Furnish or provide any prosthetic device to correct or relieve any defects or abnormal
32	conditions of the human eye and its appendages;
33	(9) Order laboratory tests rational to the examination, diagnosis, and treatment of a
34	disease or condition of the human eye and its appendages;
35	(10) Use a diagnostic or therapeutic laser; and
36	(11) A licensee is also permitted to perform those procedures authorized by the board
37	prior to January 1, 2010 all procedures employed by Doctors of Optometry which are within the
38	education and training at or through schools or colleges of optometry accredited by the
39	Accreditation Council on Optometric Education (ACOE) or its successors or equivalents.
40	(b) A licensee may not:
41	(1) Perform surgery except as provided in this article or by legislative rule; Perform
42	ophthalmic surgery unless the procedure is within the scope of education and training from an
43	accredited school or college of optometry.
44	(2) Use a therapeutic laser;
45	(3)(2) Use Schedule II controlled substances. However, an oral pharmaceutical certified
46	licensee may prescribe hydrocodone and hydrocodone containing drugs for a duration of no more
47	than three days;
48	(4)(3) Treat systemic disease; or
49	(5)(4) Present to the public that he or she is a specialist in surgery of the eye.
	NOTE: The purpose of this bill is to update the practice of optometry. The bill establishes the Accreditation Council on Optometric Education as an accrediting body. The bill removes obsolete areas of the code. Finally, the bill requires certain procedures to be approved by an accredited body.
