1 A BILL supplementing and amending the appropriations of public moneys out of the Treasury
 2 from the balance of moneys remaining as an unappropriated surplus balance in the State
 3 Fund, General Revenue, to the Department of Commerce, Department of Commerce –
 4 Office of the Secretary, fund 0606, fiscal year 2022, organization 0327, by supplementing
 5 and amending the appropriations for the fiscal year ending June 30, 2022.

6 Whereas, The Governor submitted the Executive Budget Document to the Legislature on
 7 January 12, 2022, containing a statement of the State Fund, General Revenue, setting forth
 8 therein the cash balance as of July 1, 2021, and further included the estimate of revenue for the
 9 fiscal year 2022, less net appropriation balances forwarded and regular and surplus
 10 appropriations for the fiscal year 2022, and further included recommended expirations to the
 11 unappropriated surplus balance of the State Fund General Revenue; and

12 Whereas, It appears from the Governor’s Statement of the State Fund, General Revenue,
 13 there now remains an unappropriated surplus balance in the Treasury which is available for
 14 appropriation during the fiscal year ending June 30, 2022; therefore

15 *Be it enacted by the Legislature of West Virginia:*

16 That the total appropriation for the fiscal year ending June 30, 2022, to fund 0606, fiscal
 17 year 2022, organization 0327, be supplemented and amended by adding a new item of
 18 appropriation as follows:
