### **House Bill 4836**

BY DELEGATES HANSHAW (MR. SPEAKER) AND SKAFF

[BY REQUEST OF THE EXECUTIVE]

[Introduced February 25, 2022; Referred to the Committee  
on Finance]

1 A BILL supplementing and amending the appropriations of public moneys out of the Treasury in  
2 the State Fund, General Revenue, by decreasing items of appropriation to the Department  
3 of Economic Development - Office of the Secretary, fund 0256, fiscal year 2022,  
4 organization 0307; and by increasing items of appropriation to the Department of  
5 Commerce - Office of the Secretary, fund 0606, fiscal year 2022, organization 0327 for  
6 the fiscal year ending June 30, 2022.

7 WHEREAS, The Governor submitted the Executive Budget Document to the Legislature  
8 on January 12, 2022, containing a statement of the State Fund, General Revenue, setting forth  
9 therein the cash balance as of July 1, 2021, and further included the revised estimate of revenue  
10 for the fiscal year 2022, less net appropriation balances forwarded and regular and surplus  
11 appropriations for the fiscal year 2022; and

12 WHEREAS, It appears from the Governor's Statement of the State Fund, General  
13 Revenue, there now remains an unappropriated balance in the Treasury which is available for  
14 appropriation during the fiscal year ending June 30, 2022; therefore

15 *Be it enacted by the Legislature of West Virginia:*

16 That the total appropriations for the fiscal year ending June 30, 2022, to fund 0256, fiscal  
17 year 2022, organization 0307 be supplemented and amended by decreasing existing items of  
18 appropriation as follows:
