1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
 2 designated §61-11-26c, relating to providing for the automatic expungement of certain
 3 criminal convictions and records that are eligible for expungement.

Be it enacted by the Legislature of West Virginia:

ARTICLE 11. GENERAL PROVISIONS CONCERNING CRIMES.

§61-11-26c. Limitation on expungement for certain motor vehicle traffic control offenses.

1 (a) Notwithstanding any provision of this code to the contrary, criminal convictions and
 2 records that are eligible for expungement under the following provisions of this code are eligible for
 3 automatic expungement under this section:

4 (1) Expungement of criminal records for those found not guilty of crimes or against whom
 5 charges have been dismissed pursuant to §61-11-25 of this code: *Provided*, That the provisions
 6 for filing of and proceedings upon a civil petition therein are not applicable to an automatic
 7 expungement pursuant to this section;

8 (2) Criminal convictions and records eligible for expungement pursuant to §61-11-26 of this
 9 code: *Provided*, That the provisions of subsections (d), (e), (f), (g), (h), (i), and (j) of §61-11-26 of
 10 this code are not applicable to an automatic expungement pursuant to this section;

11 (3) Criminal convictions and records eligible for expungement pursuant to §61-11-26a of
 12 this code: *Provided*, That the provisions for filing of and proceedings upon a civil petition therein
 13 are not applicable to an automatic expungement pursuant to this section; and

14 (4) Criminal convictions and records eligible for expungement upon a full and unconditional
 15 pardon pursuant to §5-1-16a of this code.

16 (b) Beginning July 1, 2023, on a monthly basis, the Department of Homeland Security shall
 17 identify cases that are eligible for automatic expungement and proceed pursuant to this section to
 18 expunge the eligible convictions and records. The department shall have access to criminal and
 19 juvenile court records to accomplish the purposes of this section. Circuit clerks, magistrate clerks,
 20 municipal court clerks, county prosecutors and law-enforcement agencies shall cooperate with the

21 department and when requested by the department, shall provide reasonable assistance to the
22 department in identifying cases that are eligible for mandatory expungement.

23 (c)(1) If the department determines that expungement of a criminal conviction or criminal or
24 juvenile records is mandated under this section, or receives an expungement order from a court, it
25 shall promptly notify all courts and law-enforcement agencies where records pertaining to the case
26 are located or maintained, and any court where the case was terminated, disposed of, or
27 concluded.

28 (2) A court or law-enforcement agency which receives a notice of expungement from the
29 department shall provide the department with written confirmation of the completion of the
30 expungement within 60 days of receipt of the notice: a court shall also provide the department with
31 a certified copy of an order granting the expungement. Where an expungement of an adjudication
32 of delinquency is granted, all arrest records associated with any charge in that case must also be
33 expunged.

34 (d) Sealing of records. —The order of expungement shall also order the sealing of all
35 records in the custody of the court and expungement of any records in the custody of any other
36 agency or official, including law-enforcement records. Every agency with records relating to the
37 arrest, charge, or other matters arising out of the arrest or conviction that is ordered to expunge
38 records shall certify to the court within 60 days of the entry of the expungement order that the
39 required expungement has been completed. All orders enforcing the expungement procedure
40 shall also be sealed.

41 (e) Disclosure of expunged matters. —

42 (1) Subject to the exceptions set forth in this section, upon expungement, the proceedings
43 in the matter shall be considered, as a matter of law, never to have occurred. The court and other
44 agencies shall reply to any inquiry that no record exists on the matter. The person whose record is
45 expunged shall not have to disclose the fact of the record or any matter relating to the record on an
46 application for employment, credit, or other type of application: *Provided*, That any person

47 applying for a position in which he or she would be engaging in the prevention, detection,
48 investigation, prosecution, or incarceration of persons for violations of the law shall disclose any
49 and all convictions to his or her prospective employer, regardless of whether the conviction or
50 convictions have been expunged pursuant to this section.

51 (2) A person for whom an order of expungement has been entered pursuant to this section
52 may not be found guilty of perjury or otherwise giving a false statement under any provision of this
53 code because of that person's failure to recite or acknowledge the arrest, indictment, information,
54 trial, or conviction, as long as the person is in compliance with subdivision (1) of this subsection.

55 (3) Notwithstanding any provisions of this code to the contrary, any person required by
56 state or federal law to obtain a criminal history record check on a prospective employee are
57 authorized to have knowledge of any convictions expunged under this section.

58 (f) Inspection of sealed records. — Inspection of the sealed records in a court's possession
59 may thereafter be permitted by the court only upon a motion by the person who is the subject of the
60 records or upon a petition filed by a prosecuting attorney that inspection and possible use of the
61 records in question are necessary to the investigation or prosecution of a crime in this state or
62 another jurisdiction. If the court finds that there is a legitimate reason for access and the interests
63 of justice will be served by granting a petition to inspect the sealed record, it may grant access
64 under the terms and conditions determined by the court.

65 (g) A court shall notify the department of the entry of any expungement order. If an order
66 expunging part or all of a juvenile criminal history is granted by the court, all indicia of arrest,
67 including police and court records, and any electronic records relating to the arrest, and any other
68 items specified in the order shall, within 60 days of receipt of the order, shall be sealed, designated
69 to retain control over all expunged records, and who shall insure that the records or the information
70 contained therein is not released for any reason except as specified in this section. In response to
71 requests from nonlaw-enforcement officers for information or records on the person who was
72 arrested, law-enforcement officers and departments shall reply, with respect to the arrest and

73 proceedings which are the subject of the order, that there is no record. The Department shall
74 promptly notify the court if it is unable to comply with any order issued pursuant to this section.

75 (h) Nothing in this section precludes an individual from filing a petition for expungement of
76 records that are eligible for automatic expungement under this section if an automatic
77 expungement has not occurred.

78 (i) An individual does not have a cause of action for damages as a result of the failure to
79 identify an individual's case as eligible for automatic expungement.

80 (j) Nothing in this section may be construed to allow a person granted relief pursuant to this
81 section to be eligible for reinstatement of any retirement or employment benefit which he or she
82 lost or forfeited due to the conviction or convictions expunged.

83 (k) The Department of Homeland Security shall propose rules for legislative approval in
84 accordance with the provisions of §29A-3-1 et seq. of this code to carry out the provisions of this
85 section.

86 (l) As used in this section:

87 "Department" means the Department of Homeland Security; and

88 Words or terms that are defined in §61-11-26(p) of this code have the same meaning as
89 defined therein.

NOTE: The purpose of this bill is to provide for the automatic expungement of certain criminal convictions and records that are eligible for expungement.
