FISCAL NOTE A BILL to amend and reenact §30-1-10 of the Code of West Virginia, 1931, as amended, relating to
 establishing an Occupational Licensing Legal Fund from existing revenue; creating special
 revenue fund; providing for transfer of money from excess receipts of occupational
 licensing boards; specifying authorized uses of fund; providing that expenditures are
 subject to appropriation by Legislature; requiring transfer of balance excess to General
 Revenue Fund; and providing for notification to the Legislative Auditor.

Be it enacted by the Legislature of West Virginia:

ARTICLE 1. GENERAL PROVISIONS APPLICABLE TO ALL STATE BOARDS OF EXAMINATION OR REGISTRATION REFERRED TO IN CHAPTER.

§30-1-10. Disposition of money fines; legislative audit; review of board's fee structure.

1 (a) The secretary of every board referred to in this chapter shall receive and account for all 2 money which it derives pursuant to the provisions of this chapter which are applicable to it. With 3 the exception of money received as fines, each board shall pay all money which is collected into a 4 separate special fund of the State Treasury which has been established for each board. This 5 money shall be used exclusively by each board for purposes of administration and enforcement of 6 its duties pursuant to this chapter. Any money received as fines shall be deposited into the General 7 Revenue Fund of the State Treasury. When the special fund of any board accumulates to an 8 amount which exceeds twice the annual budget the average actual annual expenses over the past 9 five years, excluding zero-dollar years, of the board or \$10,000, whichever is greater, the State 10 Treasurer shall:

(1) Transfer the excess amount to the state General Revenue Fund Occupational Licensing Legal Fund created in subsection (c) of this section; and

13 (2) Notify the Legislative Auditor that the transfer has been made.

(b)(1) Every licensing board which is authorized by the provisions of this chapter shall be
subject to audit by the office of the Legislative Auditor.

16 (2) Within a reasonable time after the State Treasurer notifies the Legislative Auditor of a 17 transfer required to be made under this section, the Legislative Auditor shall conduct a review of 18 the fee structure of the applicable board to determine if the amount of the board's fees generate 19 excessive revenue, when compared to the board's normal expenses. If the Legislative Auditor 20 finds that excess revenue is generated, he or she shall report his or her findings to the Legislature's Joint Standing Committee on Government Organization, along with 21 22 recommendations on how the fees can be adjusted to generate only the amount the board 23 reasonably needs to operate under this chapter.

24 (c) Beginning July 1, 2023, the Occupational Licensing Legal Fund is hereby created in the 25 State Treasury. The fund shall be administered by Treasurer and shall consist of all moneys made 26 available from any source, including, but not limited to, all amounts transferred into the fund by the 27 boards as required by subsection (a) of this section or transfers from any source, any moneys that 28 may be appropriated and designated for the fund by the Legislature, and all interests or other 29 return earned from investment of the fund. Expenditures of the fund shall be used to pay legal fees and court costs to the West Virginia Attorney General, or other counsel, incurred within the 30 31 operation of the licensing boards covered under this chapter and are not authorized from 32 collections, but are to be made only in accordance with appropriated from the Legislature and in 33 accordance with §12-3-1 of this code and upon the fulfillment of the provisions set forth in §11B-2-34 1 et seq. of this code. Any balance, including accrued interest and other returns, remaining in the 35 fund at the end of each fiscal year shall not revert to the General Revenue Fund but shall remain in 36 the fund and be expended as provided by this section: *Provided*, That before this fund may be 37 used for outside counsel, the Office of the Attorney General must indicate that the office lacks the 38 required expertise or staff to adequately represent the board. 39 (d) When the balance in the Occupational Licensing Legal Fund exceeds \$2,000,000, the 40 State Treasurer shall transfer the excess to the General Revenue Fund and notify the Legislative

41 <u>Auditor that the transfer has been made.</u>

NOTE: The purpose of this bill is to establish a special revenue fund out of existing receipts to pay legal fees and court costs to the West Virginia Attorney General, or other counsel, incurred within the operation of the occupational licensing boards.
