1	A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section
2	designated §18C-10-1, relating to creating the West Virginia National Merit Scholarship
3	Program; setting forth definitions; defining powers and duties of the West Virginia Higher
4	Education Policy Commission; establishing requirements; authorizing rulemaking; and
5	creating special revenue fund.

Be it enacted by the Legislature of West Virginia:

ARTICLE 10. WEST VIRGINIA NATIONAL MERIT SCHOLARSHIP PROGRAM.

§18C-10-1. West Virginia National Merit Scholarship Program; definitions; powers and duties of commission; requirements; funding.

1 (a) *Title*. This article may be cited as the West Virginia National Merit Scholarship Program.

2 (b) *Findings*. The legislature finds that a large percentage of graduates from the state

3 <u>colleges and universities do not work in the state after graduation. This is particularly true for</u>

4 students who are recipients of the prestigious National Merit Scholarship. There is a need to

5 influence increased numbers of students to remain in West Virginia for college and ultimately for

6 work, especially those students who are recognized as the highest academic achievers.

7 <u>(c) Definitions.</u>

- 8 <u>(1) "Eligible institution" means:</u>
- 9 (A) A state institution of higher education as defined in §18B-1-2 of this code;
- 10 (B) A state institution ceases to be an eligible institution if it meets either of the following
- 11 <u>conditions:</u>
- 12 (i) It loses regional accreditation; or
- 13 (ii) It changes its status as a private, not-for-profit institution;
- 14 (C) Any other public regionally accredited institution in this state approved by the
- 15 <u>commission.</u>
- 16 (2) "National Merit Scholarship" means that honor achieved by recipients of the
- 17 scholarship from the National Merit Scholarship Corporation. For purposes of this article, the

18	student must be selected as a National Merit Scholar and not merely qualify as a finalist.
19	(3) "Tuition" means the quarter, semester or term charges imposed by an eligible state
20	institution of higher education, including room and board for on-campus housing and on-campus
21	meal plans, and, additionally, all mandatory fees required as a condition of enrollment by all
22	students. For the purposes of this article, the following conditions apply:
23	(A) West Virginia University, Potomac State College and West Virginia University Institute
24	of Technology are considered separate institutions for purposes of determining tuition rates; and
25	(B) The tuition amount paid by undergraduate health sciences students at West Virginia
26	University is considered to be the same as the amount of tuition paid by all other West Virginia
27	University undergraduate students.
28	(3) "Enrolled" means either currently enrolled or in the process of enrolling in an eligible
29	institution.

105	(E) Be a United States citizen or legal immigrant to the United States;
106	(F) Meet additional objective standards the commission considers necessary to promote
107	academic excellence and to maintain the financial stability of the fund; and
108	(G) Enroll in an eligible institution. A student enrolled at an eligible institution who receives
109	a National Merit Scholarship Program award may retain and renew the scholarship to complete his
110	or her undergraduate education at that institution or any other eligible institution under the
111	following circumstances:
112	(i) The institution at which the student is enrolled loses its status as an eligible institution
113	pursuant to the provisions of §18B-7-3(b)(1) of this code; and
114	(ii) The student meets all other renewal requirements of this code and of commission rules.
115	(g) The commission shall promulgate a legislative rule in accordance with the provisions of
116	§29A-3A-1 et seq. of this code.
