1	A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article,
2	designated §27-18-1, §27-18-2, §27-18-3, §27-18-4, §27-18-5, §27-18-6, and §27-18-7,
3	all relating to establishing the behavioral health crisis services system act; defining terms;
4	designating a crisis hotline center; detailing requirements of the crisis hotline center;
5	providing funding for mobile crisis teams and detailing responsibilities of mobile crisis
6	teams; requiring funding for crisis receiving and stabilization services; establishing a trust
7	fund for the purpose of creating and maintaining a statewide 9-8-8 suicide prevention and
8	mental health crisis system; and establishing a fee to support the statewide 9-8-8 suicide
9	prevention and mental health crisis system.

Be it enacted by the Legislature of West Virginia:

ARTICLE 18. BEHAVIORAL HEALTH CRISIS SERVICES SYSTEM.

§27-18-1. Title.

1 This Article shall be known as the Behavioral Health Crisis Services System Act.

§27-18-2. Definitions.

- 2 <u>"9-8-8 Administrator" means the Administrator of the 9-8-8 Suicide Prevention and Mental</u>
- 3 <u>Health Crisis Hotline.</u>
- 4 <u>"9-8-8 Crisis Hotline Center" or "hotline center" means a state-identified center</u> 5 participating in the National Suicide Prevention Lifeline Network to respond to statewide or
- 6 regional 9-8-8 contacts.
- 7 <u>"9-8-8 Suicide Prevention and Mental Health Crisis Hotline" means the National Suicide</u>
- 8 Prevention Lifeline ("NSPL") or its successor maintained by the Assistant Secretary for Mental
- 9 Health and Substance Use under the Public Health Service Act, 42 U.S.C. §290bb-36c.
- 10 "Community Mental Health Centers" and "Certified Community Behavioral Health Centers"
- 11 means facilities as defined under the Public Health Services Act, 42 U.S.C. §1395x and
- 12 <u>Community Behavioral Health Organizations as licensed and certified by the state.</u>

13	"Crisis receiving and stabilization services" are facilities providing short-term (under 24				
14	hours) with capacity for diagnosis, initial management, observation, crisis stabilization and follow				
15	up referral services to all persons in a home-like environment.				
16	"Federal Communications Commission" regulates interstate and international				
17	communications by radio, television, wire, satellite, and cable in all 50 states, the District of				
18	Columbia and U.S. territories. An independent U.S. government agency overseen by Congress,				
19	the Commission is the United States' primary authority for communications law, regulation, and				
20	technological innovation.				
21	"Mobile Crisis Teams" include behavioral health professionals and peers that provide				
22	professional onsite community-based intervention such as de-escalation, stabilization, etc. for				
23	individuals who are experiencing a behavioral health crisis.				
24	"National Suicide Prevention Lifeline" ("NSPL") is a national network of local crisis centers				
25	providing free and confidential emotional support to people in suicidal crisis or emotional distress				
26	24 hours a day, 7 days a week. Membership as an NSPL center requires nationally recognized				
27	certification which includes evidence-based training for all staff and volunteers in the management				
28	of calls.				
29	"Peers" are individuals employed on the basis of their personal lived experience of mental				
30	illness and/or addiction and recovery who meet the state's peer certification requirements where				
31	applicable.				
32	"Substance Abuse and Mental Health Services Administration" is the agency within the				
33	U.S. Department of Health and Human Services that leads public health efforts to advance the				
34	behavioral health of the nation.				
35	"Veterans Crisis Line" ("VCL") means Veterans Crisis Line maintained by the Secretary of				
36	Veterans Affairs under 38 U.S.C. §1720F(h).				
	§27-18-3. Establishment of Crisis Hotline Center.				

1 The state shall establish and designate a crisis hotline center or centers to provide crisis

2	intervention services and crisis care coordination to individuals accessing the 9-8-8 suicide
3	prevention and behavioral health crisis hotline within the state, 24 hours a day, seven days a week.
4	At least one hotline center shall be established by January 1, 2022, and meet the following
5	requirements:
6	(1) The designated hotline center shall have an active agreement with the administrator of
7	the National Suicide Prevention Lifeline ("NSPL") for participation within the network.
8	(2) The designated hotline center shall meet NSPL requirements and best practices
9	guidelines for operational and clinical standards.
10	(3) The designated hotline center shall provide data, report, and participate in evaluations
11	and related quality improvement activities as required by the 9-8-8 system administrator.
12	(4) To ensure cohesive, coordinated crisis care, the designated hotline center shall utilize
13	technology including chat and text that is interoperable between and across crisis and emergency
14	response systems used throughout the state (911, EMS, other non-behavioral health crisis
15	services, and others as necessary) and with the administrator of the National Suicide Prevention
16	Lifeline.
17	(5) The designated hotline center shall have the authority to deploy crisis and outgoing
18	services, including mobile crisis teams, and coordinate access to crisis receiving and stabilization
19	services or other local resources as appropriate and according to guidelines and best practices
20	established by the NSPL. The designated center shall also actively collaborate with mental health
21	and substance use disorder treatment providers including hospital emergency departments and
22	inpatient psychiatric settings, local Community Mental Health Centers, including Certified
23	Community Behavioral Health Clinics and Community Behavioral Health Centers, crisis receiving
24	and stabilization centers, and mobile crisis teams throughout the state to coordinate linkages for
25	persons contacting 9-8-8 with ongoing care needs, establishing formal agreements where
26	appropriate.

30	(7) The West Virginia Suicide Prevention Council, having primary oversight of suicide
31	prevention and crisis service activities and essential coordination with designated 9-8-8 hotline
32	centers, shall work in concert with the NSPL and VCL networks for the purposes of ensuring
33	consistency of public messaging about 9-8-8 services.
34	(8) The designated hotline center shall meet the requirements set forth by NSPL for
35	serving high risk and specialized populations as identified by the Substance Abuse and Mental
36	Health Services Administration, including training requirements and policies for transferring such
37	callers to an appropriate specialized center or subnetworks within or external to the NSPL
38	network. This shall include, but not be limited to, LGBTQ youth, minorities, rural individuals, and
39	other high-risk populations well as those with co-occurring substance use, and for providing
40	linguistically and culturally competent care.

- 16 (C) Is continuously appropriated for the purposes of the fund.

§27-18-7. Hotline Services.

1 In compliance with the National Suicide Hotline Designation Act of 2020, the State of West

- 2 Virginia shall establish a monthly statewide 9-8-8 fee on each resident that is a subscriber of
- 3 <u>commercial landline telephone, mobile telephone and/or IP-enabled voice services at a rate that</u>

4 provides for the robust creation, operation, and maintenance of a statewide 9-8-8 suicide

5 prevention and behavioral health crisis system and the continuum of services provided pursuant to

6 <u>national guidelines for crisis services consistent with the following requirements:</u>

7 (1) The revenue generated by a 9-8-8 fee should be sequestered in trust as specified in

8 §27-18-6 to be obligated or expended only in support of 9–8–8 services, or enhancements of such

- 9 <u>services.</u>
- (2) The revenue generated by a 9-8-8 fee must only be used to offset costs that are or will
 be reasonably attributed to:
- (A) Primarily ensuring the efficient and effective routing of calls made to the 9-8-8 suicide
 prevention and behavioral health crisis hotline to the designated hotline center including staffing
 and technological infrastructure enhancements necessary to achieve operational and clinical

15	standards and best practices set forth by NSPL;
16	(B) Personnel, including recruitment of personnel that reflect the demographics of the
17	community served; specialized training of staff to serve at-risk communities, including culturally
18	and linguistically competent services for LGBTQ+, racially, ethnically, and linguistically diverse
19	communities; and the provision of acute behavioral health, crisis outreach and stabilization
20	services by directly responding to the 9-8-8 national suicide prevention and behavioral health
21	crisis hotline;
22	(C) Provision of data, reporting, participation in evaluations and related quality
23	improvement activities as required by the 9-8-8 administrator; and
24	(D) Administration, oversight and evaluation of the fund.
25	(3) The 9-8-8 fee may be adjusted as needed to provide for continuous operation, volume
26	increases and maintenance.
27	(4) An annual report on the revenue generated by the 9-8-8 fee shall be made to the Joint
28	Committee on Government and Finance and the Federal Communications Commission.

NOTE: The purpose of this bill is to create the Core State Behavioral Health Crisis Services System.
