- 1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article,
- 2 designated §49-10-1, §49-10-2, and §49-10-3, all relating to codifying the Parents' Bill of
  3 Rights.

Be it enacted by the Legislature of West Virginia:

## ARTICLE 10. PARENTS' BILL OF RIGHTS.

	<u>§49-10-1.</u>		Short		title.	
1	This article shall be known and may be cited as the "Parents' Bill of Rights".					
	<u>§49-10-2.</u>	Fundamental	rights	of	parents.	
1	<u>(a) The</u>	liberty of a parent to direct th	e upbringing, educa	ation, and care, inc	luding medical	
2	<u>care, of the par</u>	care, of the parent's child is a fundamental right.				
3	<u>(b) The</u>	(b) The parental right to direct education includes, but is not limited to, the right to choose,				
4	<u>as an alternativ</u>	as an alternative to public education, private, religious, or home schools, and the right to make				
5	reasonable choices within public schools for one's child.					
6	(c) The parental rights guaranteed by this article shall not be denied or abridged on					
7	account of disability.					
8	(d) Neither the State nor any agency or locality thereof, nor any government official or					
9	person acting under color of law, shall infringe this right without demonstrating that the					
10	governmental compelling interest as applied to the parent and the child is of the highest order as					
11	long recognized in the history and traditions of this state, is narrowly tailored, and is not otherwise					
12	served by a less restrictive means.					
13	(e) A parent may bring suit against the state, any agency or locality thereof, any					
14	government official, or any person acting under color of law based on any violation of this article					
15	and seek appropriate relief, including, but not limited to, injunctive relief, monetary damages,					
16	reasonable attorneys' fees, and court costs. A parent may also raise this article as a defense					
17	before any court or administrative tribunal.					
	§49-10-3. Applicability.					

- 1 (a) *In general.* -- This article shall apply to any state or local law, rule, or ordinance and the
- 2 implementation of that law, rule, or ordinance, whether statutory or otherwise, and whether
- 3 adopted or effective prior to or after the effective date of this article
- 4 (b) Rule of construction. -- Statutory law adopted after the date of the
- 5 enactment of this article is subject to this article unless such law explicitly excludes such
- 6 application by reference to this article.

NOTE: The purpose of this bill is to codify a Parents' Bill of Rights.
