1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article. designated §9A-7-1, §9A-7-2, §9A-7-3, §9A-7-4, §9A-7-5, §9A-7-6, §9A-7-7, and §9A-7-8, 2 all relating to establishing a pilot program to provide grants to veterans who relocate to 3 4 West Virginia to reside and work; creating the program; defining terms; creating the 5 Welcome Home Grant Program Fund; specifying distribution of grant awards; requiring 6 management and implementation by the Department of Veteran's Affairs; requiring annual 7 reporting; and specifying a date for the termination of the pilot program unless extended by 8 the Legislature.

Be it enacted by the Legislature of West Virginia:

#### ARTICLE 7. WELCOME HOME GRANT PROGRAM.

The Legislature finds that it is imperative to attract hardworking people to West Virginia to live and work. The Legislature recognizes that West Virginians have a proud history of military service and is home to a significant number of United States veterans from all branches of military service, men and women who have served their country honorably and are the very example of work ethic, dedication, and citizenship needed in this State. Thus, the Legislature seeks to incentivize United States veterans throughout the country to relocate themselves and their families to West Virginia to live and work, through the Welcome Home Grant Program established herein. Creation of the Welcome Home Grant §9A-7-2. Program. There is hereby established a Welcome Home Grant Program, to be administered by the Department of Veteran's Affairs, as a pilot program with the purpose of providing incentives in the form of cash grants to assist in relocation costs for veterans who relocate themselves and their families to West Virginia. Definitions. §9A-7-3.

As used in this article:

3	(1) Served on active duty and was discharged or released from active duty with an
