A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article,
designated §18B-2D-1, relating to establishing the American Campuses Act; prohibiting
foreign missions of China to state higher education institutions; prohibiting involvement
with Communist Chinese recruitment and propaganda programs; and setting forth
reporting requirements for state institutions of higher education.

Be it enacted by the Legislature of West Virginia:

2D. THE AMERICAN ACT. ARTICLE CAMPUSES §18B-2D-1. Prohibiting foreign missions of China at state higher education institutions; prohibiting involvement with Communist Chinese recruitment and propaganda programs; required reporting. (a) Definitions. As used in this article: 1 2 (1) "Communist Chinese recruitment program" means a program established by the 3 government of China, including Thousand Talents Program, the Overseas High-Level Talent 4 Recruitment Program, and the National High-End Foreign Experts Recruitment Plan, to recruit or 5 partner with scientists, scholars, and other experts by offering them benefits or privileges, such as 6 concurrent or short-term appointments at Chinese institutions or Chinese research laboratories. 7 (2) "Designated foreign mission of China" means any entity or operated designated by the 8 office of foreign missions in the federal department of state as a foreign mission, as defined in 22 9 U.S.C. §4302(a), of the People's Republic of China within the United States, including the 10 Confucius Institute U.S. Center, the Asia Society Chinese Language Partner Network, and the 11 Center for Language Exchange and Cooperation. 12 (3) "Government of China" means any of the following: (A) The Communist Party of China. 13 14 (B) The People's Republic of China or any governmental unit of the People's Republic of China or of a province, region, or other political subdivision of the People's Republic of China. 15

16 (C) Any instrumentality of the People's Republic of China or of the Communist Party of

18	(4) "Participate" means a person's entering into a written agreement with a Chinese
19	institution, Chinese research laboratory, or the government of China that confers upon the person
20	benefits or privileges associated with, or membership in, a Communist Chinese recruitment
21	program.
22	(b) No state institution of higher education shall establish or recognize a designated foreign
23	mission of China after July 1, 2024. If any designated foreign mission of China has been and
24	continues to be established at or recognized by any state institution of higher education, that
25	institution shall develop and implement a plan to ensure that the designated foreign mission of
26	China does not remain established at or recognized by the college or university after September
27	<u>15, 2024.</u>
28	(c) Each state institution of higher education shall identify, report to the Higher Education
29	Policy Commission or the Council for Community and Technical College Education, and
30	immediately end any cultural exchange programs consistent with those identified by the federal
31	department of state as Chinese Communist Party propaganda tools. Such report to the Higher
32	Education Policy Commission or the Council for Community and Technical College Education
33	shall be made no later than July 1, 2024.
34	(d) Each state institution of higher education shall identify and report to the Higher
35	Education Policy Commission or the Council for Community and Technical College Education the
36	amount and source of funding received from any designated foreign mission of China by no later
37	than July 1, 2024.
38	(e) No state institution of higher education, nor any employee, contractor or student
39	thereof, shall participate in a Communist Chinese recruitment program. Any state institution of
40	higher education with an employee, contractor or student participating in a Communist Chinese
41	recruitment program shall terminate the employee's, contractor's, or student's participation in the
42	Communist Chinese recruitment program. If the participation is not terminated, the state

43 institution of higher education shall terminate its affiliation with the employee, contractor or 44 student. 45 (f) A state institution of higher education may provide a six month extension of the deadline 46 by which to terminate participation in the Communist Chinese recruitment program if the institution 47 believes that an employee, contractor or student is attempting to comply with the termination 48 requirement under §18B-2D-1(e) of this code, and the institution is confident that participation in 49 the Communist Chinese recruitment program for the period of the extension will not pose a risk to 50 research or reputational interests of the system. 51 (g) Not later than August 1, 2024, a state institution of higher education shall inform all 52 employees and contractors affiliated with the institution and students enrolled in the institution of 53 the prohibition set forth in this article, and shall require that employees, contractors and students 54 disclose to the state institution of higher education, if applicable, the individual or entity's 55 participation in any Communist Chinese recruitment program and provide a complete copy of any 56 related contract. 57 (h) Not later than September 15, 2024, the Higher Education Policy Commission and 58 Council for Community and Technical College Education shall submit reports to the Legislative 59 Oversight Commission on Education Accountability identifying any state institutions of higher 60 education with programs consistent with those identified by the United States state department as 61 Chinese Communist Party propaganda tools and the methods institutions have used to comply 62 with this article. If the commission and council conclude that no institution has, or has had, a 63 program consistent with one described in this article, the reports shall state this.

NOTE: The purpose of this bill is to establish the American Campuses Act. The bill prohibits foreign missions of China to state higher education institutions; prohibits involvement with Communist Chinese recruitment and propaganda programs; and sets forth reporting requirements for state institutions of higher education.
