A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new chapter, designated §49A-1-101, §49A-1-102, §49A-1-103, §49A-1-104, and §49A-1-105, related to the creation of standards for the protection of children online; definitions; the liability of publishers and distributers of material harmful to minors; rule-making authority; and severability.

Be it enacted by the Legislature of West Virginia:

CHAPTER 49A. CHILD ONLINE PROTECTION AND LIABILITY.

ARTICLE 1. LIABILITY FOR PUBLISHERS AND DISTRIBUTORS OF MATERIAL HARMFUL TO MINORS.

§49A-1-101. Legislative findings.

The Legislature finds that pornography is creating a public health crisis and is a corroding influence on minors and due to advances in technology, the widespread availability of the Internet, and limited age verification requirements, minors are exposed to pornography at too early of an age. Pornography contributes to the hyper-sexualization of minors. The Legislature finds that pornography may lead to low self-esteem, body image disorders, an increase in problematic sexual activity at younger ages, increased desire among minors to engage in risky sexual behavior, and difficulty in forming or maintaining positive, intimate relationships. The Legislature further finds that pornography may impact brain development and function, contribute to emotional and medical illnesses, shape deviant sexual arousal, and promote problematic or harmful sexual behaviors and addiction. It is the intent of the Legislature to provide a civil remedy for damages against commercial entities that distribute material harmful to minors.

§49A-1-102. Definitions.

- 2 (1) "Commercial entity" includes corporations, limited liability companies, partnerships,

| 18 | simulated, or animated display or depiction of any of the following, in a manner patently offensive |
| 19 | with respect to minors: |
| 20 | (i) pubic hair, anus, vulva, genitals, or nipple of the female breast; |
| 21 | (ii) touching, caressing, or fondling of nipples, breasts, buttocks, anuses, or genitals; or |
| 22 | (iii) sexual intercourse, masturbation, sodomy, bestiality, oral copulation, flagellation, |
| 23 | excretory functions, exhibitions, or any other sexual act; and |
| 24 | (C) the material taken as a whole lacks serious literary, artistic, political, or scientific value |
| 25 | for minors. |
| 26 | (6) "Minor" means any person under 18 years old. |
| 27 | (7) "News-gathering organization" means any of the following: |
| 28 | (A) an employee of a newspaper, news publication, or news source, printed or on an online |

| 39 | (A) use of a digitized identification card as defined in this section; |
| 40 | (B) verification through an independent, third-party age verification service that compares |

| 16 | (10) "Substantial portion" means more than 33-1/3% of total material on a website, which |

| | §49A-1-103. Liability for publishers and distributors; age verification; retention of data; |
| | exceptions; cause of action allowed by Attorney General; statute of limitations. |
| 1 | (a) A commercial entity that knowingly and intentionally publishes or distributes materia |
| 2 | harmful to minors on the Internet from a website that contains a substantial portion of such |

3 material shall be held liable if the entity fails to perform reasonable age verification methods to 4 verify the age of an individual attempting to access the material. 5 (b) A commercial entity or third party that performs the required age verification shall not 6 retain any identifying information of the individual after access has been granted to the material. 7 (c) A commercial entity that is found to have violated this section shall be liable to an 8 individual for damages resulting from a minor's accessing the material, including court costs and 9 reasonable attorney fees as ordered by the court. An express civil cause of action for individuals 10 harmed by a violation of the requirements of this article is hereby created. 11 (d) A commercial entity that is found to have knowingly retained, used, shared, or sold any 12 identifying information, or other data, of the individual after access has been granted to the 13 individual shall be liable to the individual for damages resulting from retaining the identifying 14 information, including court costs and reasonable attorney fees as ordered by the court. 15 (e) This section shall not apply to any bona fide news or public interest broadcast, website 16 video, report, or event and shall not be construed to affect the rights of a news-gathering 17 organization. 18 (f) No Internet service provider, affiliate or subsidiary of an Internet service provider, search 19 engine, or cloud service provider shall be held to have violated the provisions of this section solely 20 for providing access or connection to or from a website or other information or content on the 21 Internet, or a facility, system, or network not under that provider's control, including transmission, 22 downloading, storing, or providing access, to the extent that such provider is not responsible for 23 the creation of the content of the communication that constitutes material harmful to minors. 24 (g) The Attorney General may bring a civil action against a commercial entity or other 25 person to recover damages or a civil penalty for violating this article, and if a court of competent 26 jurisdiction finds that the defendant has engaged in a violation of this article, it may assess a civil 27 penalty of not less than \$25,000 for each violation of this article in addition to any other damages

that may have been incurred.

(h) The Legislature hereby creates a statute of limitation for the filing of any civil action under this section of five years after the discovery of the violation of the provisions of this article.

No civil penalty pursuant to this section may be imposed for violations occurring more than five years before the action is brought.

§49A-1-104. Rule-making authority.

- (a) The Secretary of the Department of Human Services is authorized to propose rules for legislative approval necessary to implement this article in accordance with §29A-3-1 et seq. of this code.
- 4 (b) The rules:

- (1) Shall establish processes or means by which a commercial entity may meet the age
 verification requirements of this article;
 - (2) Shall establish requirements for providing confirmation of the receipt of any information provided by a person seeking to verify age under this article;
 - (3) Shall establish requirements for retaining, protecting, and securely disposing of any information obtained by a commercial entity or its agent as a result of compliance with the requirements of this article;
 - (4) Shall require that information obtained by a commercial entity or its agent in order to comply with the requirements of this article are only retained for the purpose of compliance and may not be used for any other purpose;
 - (5) Shall require if the department permits an agent to process verification requirements required by this article, that the agent have its principal place of business in the United States of America.

§49A-1-105. Severability.

If any provision or clause of this article or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this article which can be given effect without the invalid provision or application, and to this end the provisions of this
