1	A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article,
2	designated §21-5J-1, §21-5J-2, §21-5J-3, §21-5J-4, §21-5J-5, §21-5J-6, §21-5J-7, §21-
3	5J-8, §21-5J-9, and §21-5J-10, all relating to creating a paid parental leave pilot program;
4	providing findings and purpose; definitions; paid parental leave and requirements for
5	claiming benefits; requiring employer to continue group health insurance coverage for
6	employee; employment benefits and seniority position upon return from leave; benefits not
7	to accrue during period of leave; employers required to respond to survey to Department of
8	Labor; requiring department to report to Joint Committee on Government Organization;
9	authorizing emergency rule-making authority; and providing December 31, 2028, sunset.

1	(a) An employee is entitled to a total of 12 weeks of paid leave during any 12-month period					
2	to care for and bond with his or her child during:					
3	(1) The first 12 months after the child's birth, for a child born during the period July 1, 2024,					
4	through July 1, 2028.					
5	(2) The first 12 months after adoption of a child which occurs during the period July 1					
6	2024, through July 1, 2028.					
7	(b) The paid leave provided under this article is in addition to accrued annual or sick leave.					
8	(c) An employee who takes paid leave under this article forfeits his or her right to take

- 17 percent of his or her average weekly wage, up to a maximum of \$1,000 per week, while on leave
- 18 pursuant to this section.

§21-5J-4. Filing a claim for benefits; notification of eligibility or ineligibility; payment of benefits.

- 1 (a) To receive benefits under this article, an employee may file a claim with his or her
- 2 employer in a form and manner required by the department, and shall include the following
- 3 documentation supporting the request for leave:
- 4 (1) For birth, the child's birth certificate.
- 5 (2) For adoption, the child's new adoption birth certificate or decree of adoption by a court
- 6 <u>of competent jurisdiction.</u>
- 7 (b) The employer shall submit all claims to the department within three business days of
- 8 <u>receipt.</u>

9 (c) The department shall notify the employer and the employee of the employee's eligibility

- 10 <u>or ineligibility for benefits under this article within seven days of receiving a claim.</u>
- 11 (d) If an employee is ineligible, the department shall specify the reason for ineligibility.
- 12 (e) Payment of benefits to the employee shall be prorated to the date of eligibility.
- <u>§21-5J-5. Paid parental leave pilot program fund.</u>
- 1 (a) There is hereby created in the State Treasury a special revenue account to be known

2	as the Paid Parental Leave Pilot Program Fund. The fund shall be administered by the
3	department. The fund shall consist of all moneys deposited into the fund pursuant to §60-8A-3 of
4	this code; any moneys that may be designated for deposit in this fund by an act of the Legislature;
5	any moneys appropriated and designated for the fund by the Legislature; any moneys able to be
6	transferred into the fund by authority of the commissioner from other funds; and gifts, donations,
7	and interest or other returns earned from investment of the fund.
8	(b) Expenditures from the fund shall be for the purpose of paying benefits to eligible
9	employees under this article, and are not authorized from collections, but are to be made only in
10	accordance with appropriations by the Legislature and in accordance with the provisions of §12-3-
11	<u>1 et seq. of this code and upon the fulfillment of the provisions set forth in §11B-2-1 et seq. of this</u>

13	(c) Any balance, including accrued interest and other returns, remaining in the fund on
14	December 31, 2028, shall revert to the General Revenue Fund.
