# West Virginia Legislature Journal of the House of Delegates Eighty-Second Legislature Second Extraordinary Session

### Charleston, Sunday, September 18, 2016

[MR. SPEAKER, MR. ARMSTEAD, IN THE CHAIR]

Pursuant to the Proclamation of His Excellency, the Governor, issued the 16<sup>th</sup> day of September, 2016, and hereinafter set forth, convening the Legislature in Extraordinary Session on the eighteenth day of September, 2016, the House of Delegates assembled in its Chamber in the Capitol Building in the City of Charleston at 6:00 p.m. and was called to order by the Speaker, the Honorable Tim Armstead.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

Delegate Cowles arose to suggest the absence of a quorum, the Clerk opened the machine for the roll to be taken (Roll No. 740), and 90 members being present, the Speaker declared the presence of a quorum. The absent being as follows:

Absent: Blackwell, Eldridge, Flanigan, Hicks, Manchin, Moore, R. Smith, Sobonya, Storch and Trecost.

Delegates Blackwell, Manchin and Sobonya each arrived after the quorum call.

#### **Messages from the Executive**

The Speaker laid before the House of Delegates the Proclamation of His Excellency, the Governor, convening the Legislature in extraordinary session, which was read by the Clerk, as follows:

#### A PROCLAMATION

#### By the Governor

I, EARL RAY TOMBLIN, by virtue of the authority vested in the Governor by Section 7, Article VII, of the Constitution of West Virginia, do hereby call the West Virginia Legislature to convene in Extraordinary Session at 6:00 p.m. on the eighteenth day of September, Two Thousand Sixteen, in its chambers in the State Capitol, City of Charleston, for the sole purpose of considering and acting upon the following business:

**FIRST:** A bill expiring \$21,000,000.00 of fiscal year 2016 surplus funds from two separate accounts (*i.e.*, \$13,700,000.00 from the unappropriated balance in Lottery Net Profits and \$7,300,000.00 from the unappropriated balance in the State Excess Lottery Revenue Fund) and expiring \$55,000,000.00 from the Revenue Shortfall Reserve Fund to the State Fund, General

Revenue, and appropriating \$85,000,000.00 from the State Fund, General Revenue, into the Civil Contingent Fund to pay obligations and ongoing expenses incurred by the State as a result of the federally-declared disaster and State of Emergency of the twenty-third day of June, Two Thousand Sixteen; and

**SECOND:** Legislation authorizing and appropriating the expenditure of public funds to pay the expenses for the Extraordinary Session.

**IN WITNESS WHEREOF**, I have hereunto set my hand and caused the Great Seal of the State of West Virginia to be affixed.

#### **Speaker Pro Tempore Anderson in the Chair**

Mr. Speaker, Mr. Armstead, addressed the House regarding the flooding that occurred across the state in June and thanked those that assisted in the relief efforts.

Mr. Speaker, Mr. Armstead then requested to be excused from voting on all questions regarding H. B. 201 under the provisions of House Rule 49.

The Speaker Pro Tempore replied that any impact on the Delegate would be as a member of a class of persons possibly to be affected by the passage of the bill, and refused to excuse the Gentleman from voting. The Speaker Pro Tempore announced that other members with similar requests could inform the Clerk and would also be directed to vote. Delegate P. Smith noted such request to the Clerk.

#### Mr. Speaker, Mr. Armstead, in the Chair

#### **Bills Introduced**

The following bill was introduced, pursuant to House Rule 92 as follows:

## By Mr. Speaker, Mr. Armstead, and Delegate Miley [By Request of the Executive]:

**H. B. 201** — "A Bill expiring funds to the unappropriated surplus balance in the State Fund, General Revenue, for the fiscal year ending June 30, 2017, in the amount of \$13,700,000 from the balance of moneys remaining as an unappropriated balance in Lottery Net Profits, in the amount of \$7,300,000 from the balance of moneys remaining as an unappropriated balance in the State Excess Lottery Revenue Fund, and in the amount of \$55,000,000 from the Department of Revenue, Office of the Secretary – Revenue Shortfall Reserve Fund, fund 7005, fiscal year 2017, organization 0701, and making a supplementary appropriation of public moneys out of the Treasury from the balance of moneys remaining as an unappropriated surplus balance in the State Fund, General Revenue, to the Governor's Office – Civil Contingent Fund, fund 0105, fiscal year 2017, organization 0100, by supplementing and amending the appropriation for the fiscal year ending June 30, 2017."

At the respective requests of Delegate Cowles, and by unanimous consent, reference of the bill (H. B. 201) to a committee was dispensed with and it was taken up for immediate consideration, read a first time and ordered to second reading.

Delegate Cowles moved that the constitutional rule requiring the bill to be fully and distinctly read on three different days be dispensed with.

On this question, the yeas and nays were taken (Roll No. 741), and there were—yeas 93, nays none, absent and not voting 7, with the absent and not voting being as follows:

Absent and Not Voting: Eldridge, Flanigan, Hicks, Moore, R. Smith, Storch and Trecost.

So, four fifths of the members present having voted in the affirmative, the constitutional rule was dispensed with.

The bill was then read a second time and ordered to engrossment and third reading.

Having been engrossed, the bill was then read a third time.

#### Messages from the Senate

A message from the Senate, by

Senators Boso, Leonhardt and Beach, announced that the Senate had convened in extraordinary session, pursuant to the Proclamation of the Governor, with a quorum present, and was ready to enter upon the business for which the Legislature had been called together.

#### H. B. 201 was then put upon its passage.

On the passage of the bill, the yeas and nays were taken **(Roll No. 742)**, and there were—yeas 92, nays 1, absent and not voting 7, with the nays and absent and not voting being as follows:

Nays: McGeehan.

Absent and Not Voting: Eldridge, Flanigan, Hicks, Moore, R. Smith, Storch and Trecost.

So, a majority of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (H. B. 201) passed.

Delegate Cowles moved that the bill take effect from its passage.

On this question, the yeas and nays were taken **(Roll No. 743)**, and there were—yeas 92, nays 1, absent and not voting 7, with the nays and absent and not voting being as follows:

Nays: McGeehan.

Absent and Not Voting: Eldridge, Flanigan, Hicks, Moore, R. Smith, Storch and Trecost.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (H. B. 201) takes effect from its passage.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

#### **Remarks by Members**

Delegate Ireland asked and obtained unanimous consent that the remarks of Mr. Speaker, Mr. Armstead, regarding the flooding that occurred across the state in June be printed in the Appendix to the Journal.

#### **Leaves of Absence**

At the request of Delegate Cowles, and by unanimous consent, leaves of absence for the day were granted Delegates Eldridge, Flanigan, Hicks, Moore, R. Smith, Storch and Trecost.

At 6:35 p.m., the House of Delegates adjourned until 12:00 Noon, Monday, September 19, 2016.
