Delegate Householder moved to dispense with the constitutional rule requiring the bill to be fully and distinctly read on three different days.

On this question, the yeas and nays were taken **(Roll No. 792)**, and there were—yeas 91, nays 2, absent and not voting 7, with the nays and the absent and not voting being as follows:

Nays: Dillon and Kump.

So, four fifths of the members present having voted in the affirmative, the constitutional rule was dispensed with.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (S. B. 1006) takes effect from its passage.

At the respective requests of Delegate Householder, and by unanimous consent, reference of the bill (S. B. 1014) to a committee was dispensed with, and it was taken up for immediate consideration, read a first time and ordered to second reading.

Delegate Householder moved to dispense with the constitutional rule requiring the bill to be fully and distinctly read on three different days.

On this question, the yeas and nays were taken (**Roll No. 795**), and there were—yeas 82, nays 11, absent and not voting 7, with the nays and the absent and not voting being as follows:

Nays: Dillon, Fluharty, Garcia, Hamilton, Hornbuckle, Kump, Lewis, Pushkin, Rowe, Williams and Young.

Absent and Not Voting: Bridges, W. Clark, Fast, Hansen, Horst, Summers and Vance.

So, four fifths of the members present having voted in the affirmative, the constitutional rule was dispensed with.

The bill was read a second time.

Delegate Fluharty moved to amend the bill on page 3, Section 21, following the period by inserting a new sentence to read as follows:

"Any person that fraudulently represents that he or she is serving as a presidential elector who was not lawfully elected or appointed shall be guilty of a felony and be subject to imprisonment in a state correctional facility for a period of one to three years and be subject to a fine of up to \$5,000."

On the adoption of the amendment, the yeas and nays were demanded, which demand was sustained.

The yeas and nays having been ordered, they were taken **(Roll No. 796)**, and there were yeas 14, nays 79, absent and not voting 7, with the yeas and the absent and not voting being as follows:

Yeas: Fluharty, Foggin, Garcia, Griffith, Hamilton, Hornbuckle, Kump, Lewis, Martin, Nestor, Pushkin, Rowe, Williams and Young.

So, a majority of the members present not having voted in the affirmative, the amendment was rejected.

The bill was then ordered to third reading and read a third time.
