# Messages from the Senate

A message from the Senate, by

The Clerk of the Senate, announced that the Senate had passed, without amendment, to take effect from passage, a bill of the House of Delegates, as follows:

**H. B. 113**, Prohibiting payment to residential substance use disorder treatment facilities that do not meet certain requirements.

A message from the Senate, by

The Clerk of the Senate, announced that the Senate had reconsidered the effective date, and made the following bill effective May 22, 2024:

S. B. 1011, Expiring funds from Department of Revenue, PEIA Rainy Day Fund.

Delegate Householder moved that the bill take effect May 22, 2024.

On this question, the yeas and nays were taken (**Roll No. 834**), and there were--yeas 78, nays 12, absent and not voting 10, with the nays and the absent and not voting being as follows:

Nays: Brooks, T. Clark, Coop-Gonzalez, Dillon, Foggin, Foster, Kirby, Longanacre, Martin, E. Pritt, Stephens and Toney.

Absent and Not Voting: Bridges, W. Clark, Fast, Hansen, Hardy, Horst, Nestor, Ross, Vance and Westfall.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (S. B. 1011) takes effect May 22, 2024.

*Ordered,* That the Clerk of the House communicate to the Senate the action of the House of Delegates.

Delegate Householder moved that the House of Delegates adjourn sine die.

Subsequently,

Delegate Householder obtained unanimous consent to have the motion to adjourn withdrawn.

Delegate Pinson asked that the House stand in recess for 10 minutes to consider getting a motion for reconsideration in place. The Speaker noted that it could be done at that time, there was nothing on the floor.

Delegate Foster moved to reconsider his vote from yesterday on concurrence in the Senate amendment to **S. B. 1001**, Supplementing and amending appropriations to Department of Health and Department of Human Services.

There being no objections, the motion by Delegate Foster was reformed to first reconsider the motion whereby the House asked the Senate to recede from its position, and this motion was adopted.

The question then before the House being that the House request that the Senate recede from its position with respect to S. B. 1001, the same was put and rejected.

During debate on the motion that the House reconsider its action with respect to the motion to concur in the Senate amendment, Delegate Longanacre moved the previous question, which demand was sustained.

On this question, the yeas and nays were taken (**Roll No. 835**), and there were--yeas 61, nays 28, absent and not voting 11, with the nays and the absent and not voting being as follows:

Nays: Anderson, Burkhammer, Coop-Gonzalez, Dean, Ellington, Ferrell, Fluharty, Foggin, Garcia, Griffith, Hamilton, Hillenbrand, Holstein, Hornbuckle, Kirby, Lewis, Lucas, Phillips, Pinson, Pushkin, Rowe, Statler, Summers, Tully, Williams, Winzenreid, Worrell and Young.

Absent and Not Voting: Bridges, W. Clark, Fast, Hansen, Hardy, Horst, Kump, Nestor, Ross, Vance and Westfall.

So, a majority of the members present having voted in the affirmative, the motion for the previous question was adopted.

The motion to reconsider the action by the House on the motion to concur in the Senate position was then adopted.

The motion that the House concur in the Senate amendment on S. B. 1001 was adopted.

The bill, as amended, was then put upon its passage.

The question being on the passage of the bill, the yeas and nays were taken (**Roll No. 836**), and there were--yeas 87, nays 2, absent and not voting 11, with the yeas and the absent and not voting being as follows:

Nays: Coop-Gonzalez and Worrell.

Absent and Not Voting: Bridges, W. Clark, Fast, Hansen, Hardy, Horst, Kump, Nestor, Ross, Vance and Westfall.

So, a majority of the members elected having voted in the affirmative, the Speaker declared the bill (S. B. 1001) passed.

Delegate Householder moved that the bill take effect from its passage.

On this question, the yeas and nays were taken (**Roll No. 837**), and there were--yeas 89, nays none, absent and not voting 11, with the absent and not voting being as follows:

Absent and Not Voting: W. Clark, Fast, Hansen, Hardy, Horst, Kump, Nestor, Ross, Vance and Westfall.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (S. B. 1001) takes effect from its passage.

*Ordered,* That the Clerk of the House communicate to the Senate the action of the House of Delegates.

Pursuant to House Rule 48, Delegate Summers arose to explain her vote on S. B. 1001.

#### Miscellaneous Business

Consent was obtained for the comments of Delegate Summers regarding her vote on S. B. 1001 to be printed in the Appendix to the Journal.

Delegate Householder moved that the House of Delegates adjourn *sine die*.
