The meeting was called to order by Mr. Gallagher, Co-Chairman.

The minutes of the June 28, 1993, meeting were approved.

Debra Graham, Committee Counsel, reviewed the rule proposed by the Division of Motor Vehicles, Motor Vehicle Alcohol Test and Lock Program, and stated that the Division had agreed to technical modifications. Jane Cline, Commissioner of the Division, responded to questions from the Committee.

Mr. Minard moved that the proposed rule be approved as modified. The motion was adopted.

Ms. Graham explained the rule proposed by the West Virginia Board of Examiners for Speech-Language Pathology and Audiology, Regulations Governing the Licensure of Speech-Language Pathology and Audiology, and stated that the Board had agreed to technical modifications. Peter Americo, a member of the Board, answered questions from the Committee.

Mr. Faircloth moved that the proposed rule be approved as modified. The motion was adopted.

Ms. Graham reviewed her abstract on the rule proposed by the West Virginia Board of Examiners for Speech-Language Pathology and Audiology, Regulations Governing the Licensure of Speech-Language Pathology and Audiology Assistants, and stated that the Board has agreed to technical modifications.

Mr. Faircloth moved that the proposed rule be approved as modified. The motion was adopted.

Mr. Macnaughtan stated that an emergency rule filed by the Division of Environmental Protection, Sewage Sludge Management Regulations, does not comply with the intent of the underlying statute. He stated that the Secretary of State's Office will be making a decision on the emergency rule within the next few days. Mr. Macnaughtan moved that the Committee send a letter to the Secretary of State requesting that the Secretary of State disapprove the emergency rule under the provisions of <u>W. Va. Code</u>, $\S29A-3-15a$, which require the disapproval of an emergency rule where "the agency has exceeded the scope of its statutory authority in promulgating the emergency rule." The motion was adopted.

The meeting was adjourned.
