The meeting was called to order by Mr. Ross, Co-Chairman.

The minutes of the January 9, 10, 12 and 20, 2000, meetings were approved.

Debra Graham, Committee Counsel, explained the rule proposed by the *Department of Agriculture-Traditional Cheese Production*, 61CSR4, and stated that the Department has agreed to technical modifications.

Mr. Anderson moved that the proposed rule be approved as modified. The motion was adopted.

Ms. Graham reviewed her abstract on the rule proposed by the *Department of Administration-Purchasing*, 148CSRI, and stated that the Department has agreed to technical modifications. She responded to questions. She stated that in her opinion the proposed rule exceeds the scope of Department's authority, and that the Committee should recommend the Department withdraw the proposed rule. Jack Buckalew, Deputy Secretary, stated that he could not respond to questions concerning the proposed rule.

Mr. Hunt moved that the proposed rule be moved to the foot of the agenda. The motion was adopted.

Ms. Graham explained the rule proposed by the West Virginia State Board of Examiners for Licensed Practical Nurses-Policies and Procedures for Development and Maintenance of Educational Programs in Practical Nursing, 10CSR1, and stated that the Board has agreed to technical modifications. She, Lanette Anderson, Assistant Executive Secretary, and Nancy Wilson, Executive Secretary, responded to questions from the Committee.

Ms. Minear moved to modify subdivision 9.1.c of the proposed rule to clarify when a criminal history records check should be administered by a sponsoring agency and what effect a criminal history may have on admission and licensure. The motion was adopted.

Mr. Unger moved that the proposed rule be approved as modified. The motion was adopted.

Ms. Graham reviewed her abstract on the rule proposed by the West Virginia State Board of Examiners for Licensed Practical Nurses-Policies Regulating Licensure of the Licensed Practical Nurse, 10CSR2, and stated that the Board has agreed to technical modifications. She and Ms. Wilson responded to questions.

Mr. Hunt moved that section 13 of the proposed rule relating to complaint procedures be modified to comply with the provisions of Enrolled House Bill 4062 which passed during the 2000 Legislative Session. The motion was adopted.

Mr. Hunt moved that the proposed rule be approved as modified. The motion was adopted.

Ms. Graham explained the rule proposed by the West Virginia State Board of Examiners for Licensed Practical Nurses-Legal Standards of Nursing Practice for the Licensed Practical Nurse, 10CSR3, and stated that the Board has agreed to technical modifications.

Mr. Minard moved that the proposed rule be approved as modified. The motion was adopted.

Ms. Graham reviewed her abstract on the rule proposed by the West Virginia State Board of Examiners for Licensed Practical Nurses-Continuing Competence, 10CSR6, and stated that the Board has agreed to technical modifications.

Mr. Hunt moved that the proposed rule be approved as modified. The motion was adopted.

Ms. Graham explained the rule proposed by the *Department of Administration-West Virginia Design-Build Review Board*, 148CSR9, and stated that Department has agreed to technical modifications. She also stated that the proposed rule was unnecessary, and that she had recommended to the agency that it withdraw the proposed rule. Mr. Buckalew stated that the Department intends to withdraw the proposed rule.

Ms. Graham reviewed her abstract on the rule proposed by the *Department of Administration-Rules for Selecting Design-Builders Under Design-Build Procurement Act, 148CSR11*, responded to questions and stated that the Department has agreed to technical modifications. She responded to questions.
