Delegate Hamrick, from the committee of conference on matters of disagreement between the two houses, as to

Eng. House Bill No. 2995, Permitting certain animal euthanasia technicians who have been certified by other states be certified animal euthanasia technicians in West Virginia.

Submitted the following report, which was received:

Your committee of conference on the disagreeing votes of the two houses as to the amendment of the Senate to Engrossed Committee Substitute for House Bill 2995 having met, after full and free conference, have agreed to recommend and do recommend to their respective houses, as follows:

That both houses recede from their respective positions as to the amendment of the Senate striking out everything after the enacting clause, and agree to the same as follows:

ARTICLE 10. VETERINARIANS.

§30-10-12. Requirements to be a certified animal euthanasia technician.

- 1 (a) To be eligible to be a certified animal euthanasia technician a person must:
- 2 (1) Apply at least thirty days prior to the date the next written examinations are scheduled,
- 3 using a form prescribed by the board;
- 4 (2) Have a high school diploma or GED;
- 5 (3) Pay application and examination fees;
- 6 (4) Complete the certified animal euthanasia technician's program established by the
- 7 board;
- 8 (5) Pass the written and practical skills examinations;
- 9 (6) Pass the prescribed background check; and

10 (7) Complete all the other requirements established by the board.

11 (b) A certified animal euthanasia technician may practice animal euthanasia at a legally
12 operated animal control facility.

13 (c) A person certified as an animal euthanasia technician by the board prior to July 1,
14 2010, shall for all purposes be considered certified under this article and may renew pursuant to
15 the provisions of this article.

16 (d) A person certified by another state or jurisdiction with certification requirements
17 equivalent to, or exceeding, the certification standards of this state may be issued a certification
18 under this section upon the submission of a completed application and the appropriate fees, as
19 established by the board in legislative rules.;

And,

That both houses recede from their respective positions as to the title of the bill and agree to the same as follows:

Eng. Com. Sub. for House Bill No. 2995 -- A BILL to amend and reenact §30-10-12 of the Code of West Virginia, 1931, as amended, relating to qualifications for certification as an animal euthanasia technician; authorizing issuance of animal euthanasia technician certificate to certain persons certified by another state or jurisdiction; setting requirements for issuance of certificate; and authorizing application and fees to be prescribed by the Board of Veterinary Medicine in legislative rule.
