# **OVERVIEW OF ACTIVITIES AND RESPONSIBILITIES OF THE WEST VIRGINIA BOARD OF LICENSED DIETITIANS 2006 - 2007**

The requirement to hold an active/valid license to practice dietetics in the State of West Virginia - West Virginia Code – Chapter 30. Professions and Occupations – Article 35 - Board of Dietitians - commenced on July 1, 1997. The law, effective 90 days after March 9, 1996, mandated the formation of a Board as the WVBOLD. The WVBOLD is a regulatory and disciplinary body. It is the sole authority for the issuance of licenses to practice dietetics in the State of West Virginia. The purpose of the Board is to protect the public interest through its licensure and professional discipline of dietitians and to provide a professional environment that encourages the delivery of quality nutritional information and medical nutrition therapy within the State of West Virginia. The Board consists of five (5) members who are appointed by the Governor, by and with the consent of the Senate. Four of the members are experienced registered and licensed dietitians and one member is a layperson.

The WVBOLD maintains a code of ethics; establishes professional continuing education requirements and standards; establishes licensure and renewal requirements of duly qualified applicants; established procedures and guidelines for the suspension or revocation of a license; adopts procedural and interpretive rules in accordance with the provision of Chapter 29 of the code; adopts an official seal; establishes the appropriate testing vehicle for licensure examinations; issues and renews licenses; issues interim provisional permits to duly qualified applicants; imposes and collects fees for the issuance and renewal of permits or licenses; suspends revokes and reinstates license; conducts hearings on licensing issues and any other matter properly within the jurisdiction of the Board; utilizes available mechanisms/methods to protect the health and well-being of the public in nutrition related issues; maintains a record of proceeding of the Board and submits a biennial report to the Governor describing activities of the Board.

- Title 31 – Legislative Rule – Series 5 – Continuing Professional Education Requirements.**

Licensed and registered dietitians are proficient in the science of nutrition. They are required to hold degrees in nutrition, dietetics, public health or related fields such as biochemistry, medicine or a nutrition specialty in family and consumer sciences issued by well-respected, accredited colleges and universities. After or

during their education, they must perform supervised internships and pass an extensive examination administered by the Commission on Dietetic Registration and earn professional education credits throughout their careers to maintain registration and licensure.

The need for qualified providers of nutrition advice has become more focused within the past 20 years. Like the specialization of medicine, the science-based nutrition field has necessitated a higher understanding and communication of nutrition prescriptions and advice to those in need of this service.

The RD status means that the individual possesses the skills and knowledge to translate nutrition science into practical meal planning. The individual can assist with eating disorders; work with healthcare teams to assist patients/clients to change eating plan pre- or post-surgery; assist in goal setting for athletic performance on various levels; prescribe and counsel patients and families with a myriad of disease entities and to assist physicians and healthcare providers in assessing a patient's needs and prescribing a nutrition therapy to best benefit the patient.

While the credential RD is significant it, unlike the credential LD, cannot be significantly regulated in the State of West Virginia. Initials after a name do not necessarily qualify someone to provide nutrition services. Licensure and registration provide the only assurance the public has to judge that the individual is proficient in the science of nutrition.

Licensure in West Virginia provides the vehicle to file a complaint should anyone have reason to believe the person is not providing accurate nutrition advice or falsely claiming to be a qualified dietitian. The State of West Virginia, with licensure, can regulate the term "licensed dietitian" or "dietitian". States without licensure experience self-proclaimed persons claiming to be experts with little if any actual nutrition training or with only mail-order credentials. When an individual needs trusted, accurate, timely and practical nutrition advice, they should be able to identify the qualified professional.

WVBOLD utilizes the examination by the Commission on Dietetic Registration as one component to examining an applicant's qualifications, prior to issuance of a WV license.

By law, in West Virginia, the examination as a route to licensure was waived for those who were:

- (a) Currently registered with CDR as a Registered Dietitian.
- (b) BS or higher with a major in human nutrition, dietetics, food systems management or equivalent and engages in the practice of dietetics or nutrition three (3) of the previous ten (10) years.
- (c) Licensed in another state with comparable requirements.



**Exemptions include: Anyone from marketing, distributing or providing information about food, food materials or dietary supplements.**

**In 1997, 33 individuals were “Grandfathered”, in accordance with waiver (b) as stated above. Under the reciprocity waiver (c), one Kentucky licensed dietitian was later granted a WV license. In 2007, only 19 of those “Grandfathered” remain licensed. Many have retired from their chosen profession, i.e.: County Home Demonstration Agents or WIC Nutritionist. Some have relocated and a couple found they did not require a license in their capacity. Two allowed their licensure to expire and, after some time, applied for renewal. By law, they were deemed ineligible for licensure. WVBOLD handles the “Grandfather” status renewals as a routine renewal, giving due diligence to CEU credits.**

**Licenses are issued throughout the year. Renewal applications must be postmarked June 30<sup>th</sup> of each year. It is not unusual for the WVBOLD to personally contact those not having complied with renewal within the first week of each July. Out-of-state dietitians are often surprised and pleased to have this personal service.**

**WVBOLD monitors licensure compliance with continuing competence requirements of twenty hours in each designated two year reporting period. A reporting of Continuing Professional Education Credits serves to ascertain the completion of the twenty hours by licensees each two years. The applicant renewing licensure is charged with the responsibility of reporting educational activities (date and event) on the CEU Form, to accompany their renewal application. A visual scanning is performed by the Board Chairman and Board Secretary prior to issuance of the (renewed) license. At the completion of the Renewal Period, a listing of all licensees required to submit the CEU credits in that given year is compiled. The list is submitted to a Huntington-based company, with whom the WVBOLD has an agreement. 10% of the list is randomly selected to have a full audit of their CEUs. This is conducted by Board Member and Professional Inquiries Liaison - Betty Forbes – Director of Dietetic Education at West Virginia University.**

**WVBOLD is committed to collaboration with other health related licensing agencies and organizations in West Virginia and nationally. The purpose is to identify needs and to improve public access to and information about education, licensure, practice, discipline and accountability for healthcare professionals.**

**WVBOLD developed (with assistance of the WV Treasurer’s Office) a website; maintains a toll-free public telephone line (the number is published in all telephone blue page directories in West Virginia and promotes the use of the credential “LD” as a means for the public to identify those qualified to deliver nutrition advice and counseling.**

**The American Dietetic Association – WV Media Representative sent press releases to all West Virginia newspapers encouraging them to recognize the term “LD” as the qualified provider of nutrition information.**

**A complaint form is found on the website. Efforts are ongoing to refine the process and procedures for complaint management. While complaints are rare, numerous telephone calls are received from other healthcare professionals and the public with questions concerning acceptable duties of other nutrition workers, i.e.: Certified Dietary Managers, Diet Technicians, etc.**

**The presence of the WVBOLD has increased public awareness of the services of a qualified dietitian tremendously. By the number of telephone inquiries received, one can safely say that the public needs are being addressed. Nursing Homes, Personal Care Homes, Exercise Entrepreneurs and hospitals utilize the Board telephone to determine what duties can be performed by their lesser qualified staff members.**

#### **OFFICERS OF THE BOARD AND RESPONSIBILITIES:**

**The Board maintains an office at 723 Kanawha Blvd., East – Room 105 – Union Building, Charleston, WV 25301.**

**In accordance with State law, open meetings are conducted. Board meetings are posted in the State Register. The agenda for each meeting is also posted with the Office of the Secretary of State. Notice of each meeting and the agenda are posted on the office door.**

**The Board Chairman is elected every year to preserve order and conduct all proceedings by parliamentary rules and demand conformity thereto by members, appoints all committees and signs required documents. While the Board office is not staffed with an Executive Director or Secretarial Services, the Board Chairman travels to the office three times weekly (additional times when necessary). The office telephone rolls-over to the Board Chairman's home office, where she handles daily verification of license, inquiries as to licensure requirements, inquiries from the public about selecting a qualified dietitian and request of State agencies. During renewals, the Board Chairman is in the office on a daily basis. A listing of those individuals holding a valid licensure (with appropriate information) time, provides a ready access to inquiries. NOTE: A listing on the website will lessen some of the calls.**

**The Vice-Chairman also serves as the Board Treasurer. This person is elected every year to act as Chairman in the absence of the elected Chairman and calls special or emergency meetings of the Board by joint action with the Chairman. As Treasurer, this position maintains all financial records to be in compliance with the requirements of the State of West Virginia.**

**The Board Secretary is elected every year to maintain the database, prepare documents as licenses and reports, process meeting minutes and is most active in the annual renewal process.**

**The Professional Inquiries Liaison fields questions pertaining to Continuing Education Credits, talks with the public concerning the educational route to licensure and audits the 10% annually chosen, at random, for the auditing of their CEUs.**

**The Lay Member is a vital part of the WVBOLD. The person currently in this position is cognizant of the need for the licensure of the profession of dietetics. He was formerly a healthcare foodservice representative of one of the largest companies in the United States and remains in the healthcare field. The person in this position represents the citizens of the State of West Virginia in all actions of the Board. He votes on new applicants, discusses the needs for changes in procedures and speaks to the public needs.**

**Board members of the WVBOLD are active participants in meetings and activities across the country on matters of licensing, professional regulation and changing healthcare as it relates to dietetics and nutrition.**

**Two members of the WVBOLD hold membership in the Association for West Virginia Boards. This enables a healthy exchange of ideas and discussions on key issues facing boards in West Virginia.**

**Board members attend the Annual Training Seminar for WV State Licensing Boards by the State Auditor's Office. They find this most helpful in the operation of the Board.**

**The WVBOLD Board Chairman lead a national movement to form a national organization of the 44 states currently enforcing some form of regulation of the practice of dietetics. Other professional groups, i.e: Boards of Licensed Practical Nurses, etc. meet twice each year to keep abreast of changes and to strength the efforts to protect the health and well-being of its citizens. It is believed that an organization of like-kind would serve WVBOLD, West Virginia and the nation well.**

**The Board Chairman also served on the American Dietetic Association's Political Action Board 2002-2005. She served as Chairman 2003-2004 and currently is on its Advisory Committee. She represents the West Virginia Dietetic Association at ADA's Political Policy Workshop each March in Washington, DC. During these meetings she is privileged to hear presentations by U. S. Congressmen/women and Senators relating to national healthcare. In this position, the WVBOLD keeps abreast of issues surrounding not only dietetics but, the entire healthcare delivery system.**

**Four Board members are members of and some attend the annual meetings of the American Dietetic Association (FNCE), West Virginia Dietetic Association, Educational Alliance Meetings and serve on other healthcare coalition groups, such as National Diabetes, National Renal and American Heart Association – to name only a few.**

**The Board Vice-Chairman is actively involved – St. Mary’s Medical Center – in providing educational experiences for dietetic interns from Marshall University.**

**The Board Secretary participates with collaborative committees at Thomas Memorial Hospital.**

**The Board Professional Inquiries Liaison member – as stated earlier – serves the Board well with her experience as Director of Dietetic Education at WVU.**

**The Lay Board Member is in the healthcare business, visiting hospitals on a regular basis. He makes a point to “just quietly” investigate the status of dietitians.**

**The WVBOLD maintains close working relationships, often making decisions that do not require formal Board actions. The Board Chairman and Board Secretary meet at the Board Office periodically to conduct all secretarial type duties, such as issuing licenses, licensure verification and processing mail. The Board Chairman and Vice-Chairman (also Board Treasurer) have frequent contact in regards to routine Board business for various State offices request. The Board Chairman has contact with the Professional Inquiries Liaison, cognizant that this individual is best qualified to assist callers in the Continuing Professional Education arena and to advise the many callers who are considering the dietetic profession. The Lay Board Member is a very involved individual, with contact 2-3 times weekly.**

**All applications are voted on by ALL Board Members prior to issuance of a license. This keeps Board members quite involved in the daily business of the Board. Board members act in a volunteer role for such actions. This eliminates the need for formal Board meetings during certain periods of time. Actions requiring Board votes is, again, voted on at the scheduled Board meeting.**

**The Board is grateful that the WV Legislature, a few years ago, mandated an Annual Training Seminar for West Virginia State Licensing Boards by the State Auditor’s office. This has proven to be most beneficial to the WVBOLD. We look forward to the Seminars. The 2007 Seminar covered the procedure for utilizing the Archives and also the requirements for the Roster.**

**NOTES OF 2006 - 2007:**

**WV Treasurer’s Office E-Government was utilized for the 2007-2008 Renewal. The process went well. Dietitians appear to be more comfortable with this year’s process.**

**Minutes of Board Meetings are posted promptly on the web site.**

**WVBOLD maintains an expeditious manner in which applications and licensure verifications are processed. It is not unusual to hear “surprise” from offices calling for verifications or other inquiries when they are told that their request will be handled within thirty minutes and applications processed within a few hours after receipt.**

**Formal Complaints: None received. Dietitians continue to call to the Board with questions regarding the Scope of Practice for dietitians and for pharmacists. No formal complaints have been filed.**

**The Board continues to give assistance to WV hospitals, nursing homes and the WV Department of Health and Human Resources, who maintain a few state hospitals. The Board has been contacted by the WV Dept. of Health and Human Resources or a listing of licensed dietitian that they could create a bid listing of dietitians in a certain area. Other institutions have requested and received the same service. It is the intent of the WVBOLD to continue to grow with the professional needs of dietitians as related to the public interest, to attend training as offered by the State of West Virginia and to fully comply with State codes.**

**To be in compliance with the Department of Risk rule that a Safety Orientation (different topics) is to be presented at each Board meeting, the WVBOLD presented: Leaving the building carefully due to the close proximity of Kanawha Boulevard to the sidewalk ----- (In preparation for the October 8, 2007 Board Meeting, The Riggs Corporation, was contacted to ascertain an exit from the building in case the front door was blocked. The building manager stated that the exit was in the basement. Two Board members attempted to locate the exit. The only door to the outside was locked with a padlock and had no emergency lighting. The Riggs Corporation was, again, contacted in November. Construction is to begin the first week in December to correct the emergency exiting. A follow-up will take place the first of 2008.**

**It should be noted that all WVBOLD members, except the Chairman (who is a full-time volunteer), are engaged in demanding full-time positions – in leadership roles. Finally, the Board does not employ clerical or managerial staff. Much of the work is done, without compensation, as a dedication (“labor of love”) to the licensing of the profession and ultimately as a service to the citizens of the great State of West Virginia.**

**Approval of Minutes:** Minutes from the meeting of 5/2//06 were approved by e-mail prior to the meeting and again by a verbal vote at the meeting.  
Frank motioned to approve and Rick seconded.

### **Kate Campbell**

Kate Campbell from the Attorney Generals Office met with the Board to discuss the concerns over the ability to “Fine” an institution and/or an individual for practicing Dietetics in the State of WV without a valid license.

Some of the questions asked were:

1. Q - When can you use the misdemeanor section in the law? Can it be applied to an individual who is not licensed but yet is working as a dietitian in the state?

A – You must contact the Prosecutors Office in the specific county that the infraction is taking place. You can not institute a fine yourself (as a board).

2. Q – What can you do about a previously licensed dietitian who does not renew his/her license and continues to practice?

A - This would be covered under the section of the law that implements civil fines under the disciplinary rules.

3. Q – When a dietitian falls into Lapse status do they need to complete a new entire Application or only if they are lapsed 3 years or more?

A - The Board may go ahead and request a complete application – because the fees would be the same.

4. Q - What do we do if there is an impending complaint about someone – do we list their names on the website as a matter of public information?

A – The person/persons should be referred to by a complaint number until you have found probable cause. At that point it would be acceptable to list specific names.

5. Q – How likely would it be that a County Prosecuting Attorney would accept a case of prosecuting an unlicensed dietitian practicing without a license.

A – Unless you have a specific relationship with the Prosecuting Attorney – it most likely would not “top” the list of their priorities.

6. Q – What other options are there?

A – Is section 30-35-13 you may enjoin the individual. This would be a civil matter. You can include a Draft letter that would be filed if the person did not obtain licensure. You generally would have more luck following this procedure. Ultimately the goal would be to have the individual become licensed.

7. Q – What should we do in the future?

A – Kate suggested that we have the Attorney General’s Office review the laws and rules and assess if any changes need to be made. This would then need to be taken back to the Legislature.

## **Treasurer’s Report:**

The information for the July report is not yet available. Frank has not yet received the 13<sup>th</sup> month figures. (Remember – the June related expenses are not taken out until July – even though they are actually expenditures for the previous year.)

Credit Card Charges – Frank receives a statement from e-government to describe the credit card charges. The current renewal period had \$3,850.00 on credit card payments and we paid \$83.60 for this service.

A quorum was established.

**Approval of Minutes:** Minutes from the meeting of 8/14/06 are not available at this time. They have been sent to Kate Campbell for her review.

### Lela Miller

Lela Miller from the Treasurer's Office met with the Board to review the On-line renewal.

Lela began by asking what the board members thought about the new on-line renewal process. The following were points of discussion:

1. Frank voiced that he liked the on-line renewal process. This means that the Board Treasurer does not have to deal with depositing all the checks.
2. Frank also reported that he felt the fees for the credit card charges were very reasonable.
3. There was one slight glitch one day with Verizon – this was remedied very quickly when Helen contacted Lela to inform her of the problem. This problem occurred when PayPal joined with VeriSite. Now they have this corrected so that if the system goes down, the dietitian will not be able to get into the registration area. A banner will come across the screen that tells them the site is down and they need to return to the site at a later time to renew.
4. The "Grandfathered" Dietitians did not have a CDR # that was needed and could not renew on line. This can be resolved in the future. (There are very few "Grandfathered" Dietitians still practicing.)
5. There will need to be additional lines available for listing Employer and Address. We ask those Dietitians who work at more than one facility or consult to more than

- one facility to list each employer. There were not adequate lines this year. The Board requested that these Dietitians submit a separate listing.
6. There may not be enough room to list CEU's. There needs to be more than 20 lines for separate pieces of data. Someone may go to 20 one-hour sessions while others go to multiple day seminars and only have a few separate items to list.
  7. A suggestion was made to add "See Mailing Label" by the Date of Original Licensure. We had several dietitians list the date that they were completing or mailing the form.
  8. The wording by Employer and Telephone number needs clarified. The Board does not want the individual's telephone number. They will make a decision if the number should be for the Immediate Supervisor, the Department Director or the Director of Human Resources. This will be specified on future forms. If there is an issue or investigation that is needed, we need to have a contact name and number other than the dietitian.
  9. We have discussed our desire with Lela to let the Treasurer's Office house our data base. Once this is complete, we can set up a way where prospective employers can go to the website and verify a license. There may be a fee involved with this. The individual dietitians would also be allowed to make some changes to the data base i.e. name changes, address changes, employer changes. These could be color coded/flagged when changes are made. The change would not become permanent until someone from the Board who had Administrative Privileges accepts those changes.
  10. Once the data base is housed, there will be some standard reports that can be built into the data base that will be available. i.e. Mailing Labels, LD by county, etc.
  11. We received a couple of complaints about the lock box. We left the box open for several days after the filing period. The Lock Box could have a forward put on it, but then the Board would have to return the renewal and request a late fee. It was decided that we would not want a forward, we would want the renewal returned to the dietitian and he/she would then have to be responsible for resubmitting the renewal with the late fee. If they failed to do this, they would be moved to lapse status.
  12. Frank asked Lela some questions about bills etc. His concern was over the appropriations and the 13<sup>th</sup> month expenditures. Lela explained that we are now considered a "Special Revenue Fund" and can house up to 200% of our yearly appropriations. Lela asked if our bills could be paid directly from E-Government. At this time Frank forwards the bills to Linda Lyter. Lela said that Linda could receive a copy of the e-government bills and immediately put a FIMS # .
  13. The next step is to have our data base as current as possible and copy it to a disk for Lela. We would then stop making changes to our data base until it was set up at the Treasurer's Office. Lela will then update the file at the state level.
  14. We need to obtain an on-line connection for the Board Office. Lela suggested Suddenlink and the broadband connection.
  15. Lela said that we need to ask our "specialist" if we can charge for on-line verification for anyone other than the LD.
  16. Lela can add/delete fields to our data base as we see a need.

### **Treasurer's Report:**

## **Policy and Procedures: Concealed Weapons-No Tolerance**

The West Virginia Board of Licensed Dietitians strictly prohibits and does not tolerate weapons at the West Virginia Board of Licensed Dietitians' facility, the their property, or at any board sponsored event.

Weapons include visible and concealed weapons, including those for which the owner has necessary permits. Weapons can include firearms, knives with blades longer than three inches, explosive material or any other objects that could be used to harass, intimidate, or injure another individual, employee, supervisor, or board member.

Workers or board members who violate this policy may be subject to disciplinary up to and including termination.

### **Reporting Procedure:**

If you have any questions, problems, or complaints regarding a violation of this policy, or discrimination in general, you must communicate your concern to a board member. If you feel uncomfortable doing so or if your board member is the source of the problem, condones the problem, or ignores the problem, report this to the attorney attached to the West Virginia Board of Licensed Dietitians in the Attorney General's Office.

If neither of these alternatives is satisfactory to you then you can direct your questions, problems, complaints or reports to Attorney General. You are not required to directly confront the person who is the source of your report, question, or complaint before notifying any of those individuals listed.

# **West Virginia Board of Licensed Dietitians Policy and Procedures: Pregnancy Discrimination-No Tolerance**

The West Virginia Board of Licensed Dietitians prohibits, forbids, and does not tolerate discrimination against anyone on the basis of pregnancy. All employees, supervisors, board members and job applicants are guaranteed the same employment opportunities. No person, or employee, no matter his or her position has the authority, expressed, actual, apparent or implied, to discriminate against a pregnant employee or employment applicant of the West Virginia Board of Licensed Dietitians.

The West Virginia Board of Licensed Dietitians will not deny a job or remove a pregnant employee from a position because the employee is pregnant, considering pregnancy, experiencing any pregnancy related problems. All decisions regarding a pregnant employee's placement in or continuation in a job will be based on the same consideration that governs all employment decisions-the employee's ability to satisfactorily perform the essential duties of the job in question.

## **Reporting Procedure:**

If you have a pregnancy-related question, problem, or complaint, you must communicate your concern to a board member. If you feel uncomfortable doing so or if your board member is the source of the problem, condones the problem, or ignores the problem, report this to the attorney attached to the West Virginia Board of Licensed Dietitians in the Attorney General's Office.

If neither of these alternatives is satisfactory to you then you can direct your questions, problems, complaints or reports to Attorney General. You are not required to directly confront the person who is the source of your report, question, or complaint before notifying any of those individuals listed.

# **West Virginia Board of Licensed Dietitians Policy and Procedures: Carelessness in Workplace**

The West Virginia Board of Licensed Dietitians prohibits, forbids, and does not tolerate carelessness, substandard or hazardous work practices within the facility, on its property or while conducting board business.

The West Virginia Board of Licensed Dietitians expects and demands that its employees perform their board/employment duties with care and attention to the citizen needs the safety and welfare of fellow workers and board members, and to The West Virginia Board of Licensed Dietitians quality standards and requirements. Employees/board members who are careless or negligent in performing their job duties will be subject to discipline. Carelessness or negligent behavior or actions may result in discipline up to and including immediate discharge. Employees/board members who fail to respond to The West Virginia Board of Licensed Dietitians effort to correct carelessness may be subject to discipline up to and including discharge..

## **Reporting Procedure:**

If you have any questions, problems, or complaints regarding a violation of this policy, or discrimination in general, you must communicate your concern to a board member. If you feel uncomfortable doing so or if your board member is the source of the problem, condones the problem, or ignores the problem, report this to the attorney attached to the West Virginia Board of Licensed Dietitians in the Attorney General's Office.

If neither of these alternatives is satisfactory to you then you can direct your questions, problems, complaints or reports to Attorney General. You are not required to directly confront the person who is the source of your report, question, or complaint before notifying any of those individuals listed.

This (employee handbook, memorandum, statement, application, written offer of employment) is not a contract, express or implied, guaranteeing employment for any specific duration. Either you or The West Virginia Board of Licensed Dietitians chair may terminate this relationship at any time, for any reason, with or without cause or notice. No supervisor or board member of The West Virginia Board of Licensed Dietitians, other than the appointing authority, has the authority to enter into any agreement with you for employment for any specified period or make promises or commitments contrary to the foregoing. Further, any employment agreement entered into by the appointing authority shall not be enforceable unless in writing.

Beverly is a Licensed Nutritionist from the state of New Mexico. She is not a Licensed Dietitian in New Mexico but has passed her CDR exam. She was requesting reciprocity.

The board decided to defer any decision until all of her documentation has been submitted. If there are still questions concerning reciprocity then the Attorney Generals Office will be contacted for their input.

### **Speech Pathologist engaging in MNT**

The Board felt that the Speech Pathologist should only be engaging in the instruction of the various textures of foods and not the nutritional make-up – this would be considered Medical Nutrition Therapy for which their license does not cover. A response will be given to this question.

### **Teresa Stanley**

Thru a computer entry error, Teresa was mailed a lapse letter in error. She had spent \$5.55 to send a certified letter concerning this matter. Based on the accounting system, we are unable to refund her the postage money sent but the Board decided in good faith that we would send her \$5.55 in stamps to replace her expense.

*No formal complaints were received during 2006-2007.*

*Numerous calls were received from hospitals, nursing homes, pharmacies and individuals for clarification as to the duties allowed under State law for Dietary Managers, Diet Technicians and requirements for a dietitian to operate under the "Scope of Practice" and to obtain a listing of dietitians in a particular area of the State of West Virginia.*

*Several times a week, the Board receives requests from hospital and nursing homes to verify a license for a dietitian and the completion of required CEUs. It is estimated that over 200 requests are received annually. A verification form is utilized for this purpose.*

*Several inquiries were made to Board members concerning the practice of dietetics. This prompted a telephone call to the Pharmacy Board to be on the alert and to, perhaps, include some information in their newsletter.*

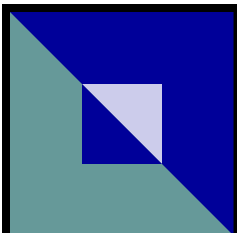
*Random calls are received from the public asking how to locate a qualified dietitian in a particular area for the purpose of Medical Nutrition Therapy. ## OVERVIEW OF PROFESSIONAL REGULATION OF DIETITIANS

Forty-four states currently have statutory provisions regarding profession regulation of dietitians and/or nutritionist. The rationale for legislatures acting to protect these titles is simple: the public deserves to know which individuals are qualified by education, experience and examination to provide nutrition care services.

State legislatures are charged with protecting the health and safety of the public. Accordingly, every state regulates occupations and professions that have an impact on the public's health and safety.

As the public has become aware of the importance of good nutrition, many entrepreneurs have taken advantage of the newly recognized market. While many of these products and services may be worthwhile when used in the context of an overall good nutrition regimen, some are simply capitalizing on the new infatuation the consuming public has with healthy eating and nutrition.

As medical nutrition therapy is used in the treatment of various diseases, individuals seeking nutritional advice that are medically compromised deserve the assurance that the individual treating them has the requisite education and experience. Licensure laws protect the public from unscrupulous and unqualified individuals who would portray themselves as nutrition experts.

The WVBOLD has received several calls, from out-of-state and in-state, this past year inquiring about the laws in WV for practicing dietetics. In conversation, it was generally obvious that these individuals were looking for a state in which they could practice dietetics without the necessary educational credentials. In addition several calls were received from WV dietitians inquiring about other professions seeking to cash-in on instructing citizens on weight reduction diets. In those cases, dietitians were given the proper tools to address the issues with those individuals, outlining the scope of practice of dietetics.
