FUNCTIONS OF THE STATE BOARD OF ARCHITECTS

The functional objectives of the State Board of Architects are to administer the provisions of the West Virginia Laws, Rules and Regulations governing the profession of Architecture in such a manner as to protect the public's health, safety and welfare.

The program of this agency can be generally classified into Administration and Enforcement. The Administrative functions include the categories of:

1. Process and qualify applications for licensees
2. Issue licenses to qualified applicants
3. Investigate formal complaints filed
4. Conduct hearings for possible suspension or revocation of License
5. Renew licenses annually

The State Board of Architects consists of five registered professional Architects and two lay members, each Board Member being appointed by the Governor of West Virginia and with the consent of the Senate of the West Virginia Legislature for terms of five years or until their successors are named.

Article 30-12-3. Fees of Article 12. Architects of the State Code states the following:

Article 30-12-3 FEES (a) Notwithstanding any other provision of the law to the contrary, the board is authorized and empowered to establish by legislative rule in accordance with the provisions of article three, chapter twenty-nine-a of this code a schedule of fees to be charged to applicants. The board shall charge for: Examination reexamination, renewal of certificates, restoration of expired certificates, reciprocal registration and for any other matters deemed appropriate by the board. (b) Until such time as the board establishes otherwise, the fees previously set by legislative rule remain in effect.

The board shall cause such schedule of fees to be published annually in the state register.

In accordance with Legislative Rule Board of Architects, Series 3, Fees for Registration of Architects the schedule of fees of the West Virginia Board of Architects from July 1, 2006 to June 30, 2007 shall be:

§2-3-3. Fees.

3.1. The applicant shall pay with his or her application for registration of reciprocal registration a non-refundable filing fee in the amount of one hundred dollars (\$100.00).

3.2. The applicant shall pay directly to NCARB or its designee all fees related to the cost of the A.R.E. or any division of the A.R.E.

3.3. The applicant for registration or reciprocal registration shall pay the Board fifty dollars (\$50.00) for a hand seal and printed certification evidencing registration as an architect.

3.4. The applicant shall pay a fee to the Board of seventy-five dollars (\$75.00) for the annual renewal of a certificate of registration. An initial certificate of registration expires on June 30th of the year following initial registration and annual renewals expire on June 30th of each year thereafter.

3.5. The nonresident applicant for reciprocal registration shall pay to the Board, in addition to the filing fee accompanying the application and the fee for the hand seal and printed certification, two hundred fifty dollars (\$250.00) for registration.

3.6. The applicant shall pay to the Board for the restoration of an expired certificate of registration one hundred fifty dollars (\$150.00), if the certificate of registration is restored within twelve months (12) from the renewal date.

3.7. The applicant shall pay to the Board for restoration of an expired certificate of registration two hundred fifty dollars (\$250.00), if the certificate of registration is restored more than twelve (12) months from the renewal date.

This fee schedule supersedes any fee schedule which may be stipulated in the Rules of the West Virginia Board of Architects.
