Sound leadership includes financial stability. During the past three years DCR has saved West Virginia counties \$67.1 million in their jail bills.

The employees of DCR are the unsung heroes of West Virginia.

Every day in West Virginia, the Division of Corrections & Rehabilitation is responsible for keeping the state's jails, prisons, and juvenile centers up and running. There are no "breaks" or "days off." As an essential public safety agency, the DCR operates twenty-four hours a day, seven days a week. On any given day, there are over 10,000 offenders and residents in our facilities. Throughout every weekday, weekend, and holiday, DCR staff members report to their duty locations, work their posts, cover the backs of their fellow correctional workers, deal with hardships and endure distresses that the outside world cannot possibly imagine, supervise offenders on parole, support those in the field, and provide appropriate rehabilitation services to offenders, all to further our mission of both protecting the safety of West Virginia's citizens and ensuring opportunities for our incarcerated population to return to their communities as productive and responsible citizens. The ongoing pandemic dictates that we continue adapting to new challenges, and we are "doing more with less" in several ways, including dealing with the serious staffing

shortages we are facing across the Division. And tragically, we have mourned the loss of our co-workers who lost their battles with COVID-19. This is the DCR's reality. We are always "on," and I especially want to recognize and thank our determined and dedicated staff who have withstood these challenges and who continue to serve and persevere.

Despite the pandemic's health and staffing challenges, we nonetheless have continued to develop and enhance our offender services. This past year we have implemented several legislative mandates.

House Bill 3304, passed during the 2021 regular session, included provisions for expanding the state's work release facilities. I'm proud to report that additional work release units have been established at Huttonsville Correctional Center and at Northern Regional Jail & Correctional Facility. We continue to explore opportunities to build upon this progress.

House Bill 3078, also passed during the 2021 regular session, provides that eligible offenders who have not been able to complete required programming while incarcerated, through no fault of their own, may complete those programs in the community as a condition of parole. To that end the DCR has established relationships with numerous community providers, and the Parole Board can now release offenders with these programming requirements as additional conditions of their supervision.

Finally, the Non-Violent Offender Parole Program, enacted into law in 2020, was implemented in July 2021. This statute allows offenders who are non-violent and who have completed their required programming to be released directly at the time of their first parole eligibility, without having to see the Parole Board. As of December 2021, over 150 inmates have been released pursuant to this new program.

While the pandemic has caused significant changes to our operations and our lives we are nonetheless continually striving to improve and expand our programs and capabilities.

As you read this annual report, and the accomplishments noted herein, please think about a friend, loved one, or someone you know who may be interested in being part of our team. We have a place for them, and their local facility would welcome the opportunity to speak with them about the career opportunities that are available in corrections. You will find contact information for all DCR locations in the back of this report.

As always, we want to thank the Governor and all those who have been supportive of our staff and our mission. We are deeply appreciative.

Corrections Academy Adopts Blended Learning Format

• Due to the Pandemic, in FY 2021, the Corrections Academy experienced 2 full training shutdowns totaling nearly a 7-month stoppage of operations, which caused the agency waiting list for Basic Training to exceed 600 employees. By implementing a "blended learning" format, wherein new employees receive the lecture portion of Basic Training virtually, followed by the hands-on skills training at their facility, the waiting list has been reduced to less than 100, which is less than the number on the waiting list when the Pandemic began in March 2020. While doing this, staff of the Bureau of Training and Staff Development have continued to work to better the content of the Training, revising, or developing 16 of the 37 courses offered in Basic Training, to bring the curriculum further in line with statutory mandates or nationally accepted best practices.

Inmate Assaults Decline

• Inmate-on-inmate assaults dropped 11% between FY2020 and FY2021, resulting in safer facilities.

PREA Accomplishments

• The Office of PREA (Prison Rape Elimination Act) Compliance was established within the Inspector General's Bureau. This office conducted nearly 300 PREA complaint reviews during FY2021 and assisted with PREA audits at eighteen facilities.


PREA Audit Teams

• During the ongoing COVID-19 pandemic, the Office has also formed audit teams to ensure adherence to DCR's response policy.


Correctional Industries Accomplishments

• Correctional Industries shops continued to operate throughout the pandemic and into FY21 to produce all items needed by the DCR, National Guard and other State agencies. Hand sanitizer was produced at the Industries shop at Pruntytown Correctional Center and Jail. The partnership with the National Guard allowed the Correctional Industries inmates to expand their contribution to West Virginia's COVID-19 response effort, with the more than 174,000 masks and 20,000 gowns they have made and distributed statewide.

Commissioner



Betsy Steinfeld Jividen was appointed as the Commissioner for the West Virginia Division of Corrections effective January of 2018 and ultimately reappointed as the Commissioner of the newly created West Virginia Division of Corrections and Rehabilitation, effective July of 2018. As such, she is responsible for overseeing the state's 35 facilities, including prisons, jails, community corrections centers, juvenile and contract facilities, along with approximately 4100 employees and more than 12,000 offenders.

She previously was the first woman to be appointed as an Assistant United States Attorney in the Northern District of West Virginia, where she spent 37 years, serving in both the Criminal and Civil Divisions of the office, as well as in senior leadership positions, including Civil Chief, Senior Litigation Counsel,

First Assistant United States Attorney, and three terms as the Acting United States Attorney.

In addition, Commissioner Jividen served as the Reentry Coordinator for the Northern District of West Virginia, working with correctional staff, probation officers, inmates and reentrants - both inside facilities and outside in our communities - assisting with projects and programs aimed at making successful reentry a priority and a reality. She has spent many hours both professionally and personally engaged in work that promotes successful reentry, and by extension, the safety and welfare of communities throughout West Virginia. Ms. Jividen was also instrumental in the development of the first federal Drug Court program for the Northern District of West Virginia. She serves as a board member for the Unity Center, HoH Share and the YWCA's residential program for Women in Transition, and as a volunteer at the House of Hagar and for the Project HOPE homeless outreach program.

Commissioner Jividen is a graduate of the University of Wisconsin and the West Virginia University College of Law. She has been recognized by the National Association of Former United States Attorneys for her exceptional service to the Department of Justice and the United States of America. In 2011, she was named as one of West Virginia's outstanding women attorneys, and in 2014, she was selected as a Fellow of the West Virginia Bar Foundation. Commissioner Jividen also spent several years as an Adjunct Professor at the West Virginia University College of Law, teaching Appellate Advocacy and Trial Advocacy.

Deputy Commissioner: Field Services



Paul Simmons began his career with the Division of Corrections at the West Virginia Penitentiary in July of 1987, as a Correctional Officer I and was promoted to the rank of Sergeant and then Lieutenant. He was part of the transition team for closing the Penitentiary and opening the Mount Olive Correctional Complex. In February of 1998, Paul transferred to Saint Marys Correctional Center and in October of that same year joined the staff at Northern Correctional Center, where he became the Associate Warden of Security in November, 2012. Paul also served as Northern Regional CERT Commander from 2001 to 2012. Paul was appointed as the Assistant Commissioner for the WV Division of Corrections on August 2, 2015 and as the Acting Deputy Commissioner on May 27, 2017. Paul is currently the Deputy Commissioner for Field Services within the WV Division of Corrections and Rehabilitation. He supervises the Assistant Commissioners of Bureau of Prisons and Jails, Bureau of Community Corrections and the Bureau of Juvenile Services.

The Departments under the supervision of the Deputy Commissioner of Field Services include: **Security Services for Prisons, Steve Caudill, Director** This department oversees the Special Operations of the WVDCR including the CERT (Corrections Emergency Response Team), CNT (Crisis Negotiators Team) and the K9 operations.

Investigations: Steve Berthiaume, Director

Investigators are currently embedded in 16 of the 24 adult facilities in the state and 1 of the 10 juvenile centers. These Investigators are tasked with conducting investigations at all the State's Correctional Centers, Jails, Juvenile Detention Centers and Youth Reporting facilities. Additionally, the Unit offices two Investigators in McDowell County at the Stevens Correctional Facility. The Unit conducted 697 investigations at these facilities and in many cases, members of the Investigations Unit worked hand in hand with members of the West Virginia State Police in preparing these cases for prosecution. The CID Unit acts as the point of contact for all Law Enforcement inmate communication requests that encompass calls, emails, video visits, visitor lists, contact lists, financial accounts and other inmate related information. During the time period covered by this report, the CID Unit fielded 4,139 such requests for information from local, state and federal law enforcement agencies.

The CID Unit maintains the WVDCR STG (Security Threat Group) Database and Complete STG Member lists. This information is disseminated to appropriate law enforcement agencies when STG members are to be paroled or released into the community. The CID Unit has an Investigator officed at the West Virginia Fusion Center who coordinates and fills the requests for information of law enforcement agencies. This Investigator coordinates efforts with any Fusion Center partner on requests relating to WVDCR information. Additionally, this Investigator is the point of contact for the Joint terrorism task force (JTTF) for WVDCR relating to Terroristic ties as it pertains to any facility's safety and security. The Unit also assists other agencies and during this period conducted 29 investigations for the Equal Employment Opportunity section.

Construction & Engineering--Phil Farley, Director

The West Virginia Division of Corrections Director of Construction and Engineering is responsible for overseeing Corrections physical improvements in the facilities throughout the state.

Correctional Healthcare--Debbie Hissom, Director

This department serves as the WVDCR's liaison with health care vendors. Medical Services participates in assessments, planning, implementation and evaluation of policy and practice throughout the system.

Chief of Staff



Brad Douglas started with the WVDOC in February 2000 as a Data Analyst. In that function he assisted with the establishment and development of the WVDOC's Office of Research & Planning. In 2002, Brad was promoted to Criminal Justice Specialist 2. Later, in December 2003 after the retirement of the Director of Research & Planning, Brad was promoted to that position and served as such until 2011. In 2011, the Commissioner merged the Information Technology and Research & Planning units into the Office of Research & Technology with Brad in the Director's position. In July 2015, Brad was selected as the Commissioner's Chief of Staff and in that role served as the WVDOC's legislative liaison. In August 2017, Brad accepted a temporary assignment for the Regional Jail Authority as Administrator of the South Central Regional Jail. After the consolidation of the State's three correctional agencies under HB 4338 in July 2018, Brad returned to the Central Office as Chief of Staff for the West Virginia Division of Corrections & Rehabilitation.

Brad was instrumental in the development of the Supreme Court Ordered "Master Plan to Address Prison Overcrowding" in 2002, served as staff on the Governor's Commission on Prison Overcrowding in 2009, and served as a primary WVDOC technical consultant during the development and adoption of the Council of State Government's "Justice Reinvestment in West Virginia" initiative. Brad was also co-project manager of the Inmate Management Information System Steering Committee and served as WVDOC and DMAPS project manager in the more recent Offender Information System project. Brad holds a Bachelor's Degree in Criminal Justice from West Virginia State University, and a Masters in Justice Leadership from Marshall University. In 2001, Brad was the recipient of the WV Association of Correctional Employee's K.D. Knapp Scholarship and the Southern States Correctional Association Scholarship.

Information Technology: Molly Mullins, Director

This office is responsible for planning, development, implementation of the agency's Offender Information System, and liaisons with the WV Office of Technology on hardware, software, network infrastructure support and maintenance. The Office is also involved with the design, maintenance, and implementation of the agency's Security Technology Infrastructure.

Records & Interstate Compact: Diann Skiles, Director

This office is responsible for inmate records and document management for the WVDCR. The office instructs, trains, and oversees records and document management at WVDCR facilities as well as ensuring proper information flow between the WVDCR and other state and federal agencies. The office also manages the Interstate Compact for the Transfer of Adult Offenders on Probation and Parole for the State of West Virginia, this task includes the procedures necessary to transfer parolees and probationers between states and the extradition of current inmates to other jurisdictions for trial or to serve detainers.

Correctional Hearings: John Drake, Director

This office oversees the inmate disciplinary hearing program and the management of hearings for Preliminary Parole Revocations, Revocations from Mandatory Supervision and Conditional Release. Correctional Hearing Officers report directly to this office in order to ensure an impartial disciplinary hearing at the facility level.

Planning and Assessment

This portion of the Commissioner's Office manages the production of specialized reports for WVDCR leadership, answers requests for information from the legislature and other parties in state government and the public, liaisons with the Office of Research and Strategic Planning for correctional research purposes, and oversees all grant related activity within the agency.

Classification for Prisons: Lesley Hill, Director

This department is responsible for offender classification and offender movement within the WVDCR.


Policy & Compliance Office: Debbi Minnix, Director

This offices primary duty includes policy development.

Recruitment: Renae Stubblefield, Recruiting Coordinator

The position is responsible for providing recruiting services & resources, administrative support to the Chief of Staff, Team Captain & Agency Recruiters and/or HR Generalists within the Division of Corrections and Rehabilitation through coordination, scheduling, information dispersal and supplying promotional items when requested; Monitors facility vacancy rates and directs resources to areas of greatest need. The Recruiting Coordiantor also assists in organizing division-wide recruiting events, as well as collecting data from all recruitment activities for statistical reporting within the Division.

Assistant Commissioner: Bureau of Prisons & Jails



Marvin Plumley graduated from The College of West Virginia in June of 2000 with a Bachelor of Science degree in Criminal Justice. He began his career with the Division of Corrections in January 2001 at Anthony Correctional Center as a Correctional Counselor II. He remained at ACC until June of 2008 and served in multiple roles including Corporal, Lieutenant and Associate Warden of Security and Programs. In June 2008, Marvin was promoted to the Deputy Warden post at Lakin Correctional Center and served in that capacity for two years before transferring to serve as the Deputy Warden at Mount Olive Correctional Complex.

In May 2012, Marvin was appointed as the Warden at Huttonsville Correctional Center and remained there until April 2017 when he accepted a promotion to Senior Director of Compliance and Audits



On July 1, 2018 consolidation of the State's three correctional agencies occurred and Commissioner Jividen appointed Marvin to serve as the Assistant Commissioner for the Bureau of Prisons and Jails for the newly formed Division of Corrections and Rehabilitation. Throughout his tenure Marvin has performed various ancillary duties to include EEO Counselor and Investigator, CERT, CNT, Investigations and several other committees/groups. Marvin currently oversees Eddie Long, Director of Correctional Industries, and Lance Yardley, Chief of Institutional Operations, and Region 1 and 2's prisons and jails.



The map below shows the number of clients supervised by Parole Services, by county at the end of FY 2021. Kanawha County had the highest case load, followed by Cabell, Wood, Berkeley and Mercer Counties. Some reasons for these high numbers are the fact that Kanawha and Cabell Counties have high populations compared to the rest of the state, while Berkeley and Mercer border other states and supervise a large number of interstate compact cases.



On June 30, 2021, there were 3663 total clients under the supervision of WVDCR Parole Services. Of those 3663 clients it should be noted that 1139 were out of state cases.

Assistant Commissioner: Bureau of Juvenile Services



William Marshall was born in Point Pleasant and graduated from Wahama High School, Marshall University and the W.V. State Police Academy. Marshall began his State Police career in Huntington, where he was awarded the 1995 National Association of Police Organizations (NAPO) West Virginia Police Officer of the Year. He later received Honorable Mention for NAPO National Police Officer of the Year. After a tour of duty in Ripley, Marshall transferred to the Interstate Drug Interdiction Team. He was then selected to work on the W.V. Worker's Compensation Fraud Task Force. He also spent time assigned to the drug task forces in Charleston and Parkersburg.

Such distinguished service led to Marshall's selection to the IRS Criminal Investigation Division's Fraud Task Force, working out of the U.S. Attorney's Office for the Southern District of West

Virginia in Charleston. While there, he received commendations for outstanding investigative work. He also received a deputation from the U.S. Marshal's Service. Marshall was promoted to Sgt. in 2006 and named Commander of the Pleasants County Detachment. He then served as Commander of the Wood County Detachment before being selected as the Deputy Director of Traffic Records at State Police Headquarters, working with the Governor's Highway Safety Program.

In 2010, Marshall returned to Wood County and resumed command there until the conclusion of his career in July 2017. He retired with more than 25 years of service with the West Virginia State Police. Following his retirement, Military Affairs and Public Safety Cabinet Secretary, Jeff Sandy, chose Marshall as the Cabinet Department's first Director of Corrections Investigations. It was while performing those duties that Governor Jim Justice appointed Marshall as Director of the former legacy agency, Division of Juvenile Services. Under the newly formed Division of Corrections and Rehabilitation, He now serves as the Assistant Commissioner of the Bureau of Juvenile Services. Asst. Commissioner Marshall oversees Denny Dodson, Chief of Juvenile Operations which in addition to the Juvenile Facilities includes the following Youth Reporting Centers:

Assistant Commissioner: Training & Staff Development Bureau



Scott Patterson began employment in West Virginia corrections in 1992 as a Correctional Officer at the West Virginia Penitentiary where he also served as a Counselor and acting Unit Manager. He began working for the Academy as an Institutional Training Officer assigned to the newly-constructed Mount Olive Correctional Complex; while at Mount Olive, he served as a Case Manager, Unit Manager and then Director of Classification.

In 1998, he was appointed as Warden of the Anthony Correctional Center, where he served until 2007; during his tenure at Anthony, he was placed on temporary duty assignment in McDowell County as the Warden of the Stevens and Welch Correctional Centers. In 2007, he left the Division of Corrections and deployed to Iraq as a contractor to the U.S. Department of Justice, helping that country rebuild its

corrections system to operate in accordance with international standards for the humane treatment of prisoners and the rule of law. He returned from Iraq in 2009 and, after a brief hiatus, accepted employment as a Child Protective Services Worker with the WV Department of Health and Human Resources in 2010, a position he held until 2011 when he was once again appointed as Warden of the Anthony Correctional Center. In 2014 he became the WV DOC Senior Director of Compliance and Audits, and held that position until 2017, when he became the Director of Training. In 2017, he was assigned as the Acting Assistant Commissioner – Operations, and he held that position until July 2018 when he was appointed the Division of Corrections and Rehabilitation's Assistant Commissioner for the Bureau of Training and Staff Development.

Leadership staff under this Bureau include: Ralph Terry, Chief of Training Operations; James Day, Academy Manager; and Matt Smith, Specialized Training Manager.



Assistant Commissioner: Intergovernmental Affairs Bureau



Mr. David Farmer began his career with the WVRJA in February 2002 as the Director of Inmate services at the South Central Regional Jail in Charleston, WV. He was appointed as the Administrator of the Southwestern Regional Jail in Logan, WV in December of 2011. He remained in that position until being appointed as Director of the Academy/ Deputy Chief of Operations in August 2014. Mr. Farmer was appointed Executive Director of the Regional Jail and Correctional Facility Authority on June 1, 2015. In July 2018, Mr. Farmer was appointed Assistant Commissioner of Intergovernmental Affairs Bureau where he now oversees Constituent and Victims Services, Inmate Grievances Coordinator, Director of Operations, Director of Safety and Loss Control, Director of Staffing Services and the Director of PREA Compliance.

The Office of Constituent Services serves as a liaison between the WV Division of Corrections and Rehabilitation and the community by providing information to address concerns regarding conditions of confinement and delivery of timely information. The role of this office is to provide an avenue for the general public to obtain and express concerns on relative issues to the division. During FY21, this office answered approximately 400 calls/emails regarding issues/concerns of offenders in WVDCR.

The Office of Constituent Services maintains Employee Grievances for the Division. The Administrative Hearing Examiner administers the Level I Grievance process for approximately 4000 employees that fall within the Division of Corrections and Rehabilitation. All Level I Grievance Hearing decisions are submitted to the Chief Hearing Examiner of the WV Division of Corrections and Rehabilitation, for review and final sanction. If the Grievant is not satisfied with the Hearing Examiner's response at Level I, the Grievant may appeal to the State Employees Grievance Board.

During the fiscal year 2020-2021, there were approximately eighty-six Level I grievances filed; eighteen terminations/ suspensions, eight written reprimands, sixteen pay/promotion related issues, twenty-four job position/classification related issues, seven related to leave/time, eight in relation to hostile work environment/EEO and two pertaining to face masks and one over an employee performance appraisal. Level I outcomes included three granted, two granted in-part, forty-five denied, fourteen withdrew, and twenty-two waived.

The Victim Services Program offers direct services to victims of crime in all 55 counties in West Virginia for the West Virginia Division of Corrections and Rehabilitation. Carla Shirey, is the VSS (Victim Services Specialist) and provides services to victims by registering them in the OIS data base and registering them with the WV Victim Notification Everyday (VINE) notification program.

During FY21, Ms. Shirey has provided direct services to 356 victims of crime. Part of the services included attending 147 parole hearings with victims of all types of crime. While targeting the underserved population of victims of homicide in West Virginia, Carla has assisted 69 families of deceased victims of homicide. In addition, the VSS has Victim Services Representatives (VSR's) staff on-site at WVDCR facilities that are also trained to offer direct services.

Staffing Services: Lori Lynch, Director

The Staffing Services section supplies the Commissioner and Deputy Commissioner with the information needed to balance the personnel resources available with the needs of the facilities and work units within the entire Division. With an everchanging inmate and resident population, staffing audits are ongoing to ensure that resources are shifted as the Commissioner deems necessary. Staffing Services assists all Bureaus of the WV Division of Corrections & Rehabilitation, with the utilization of available personnel positions to insure that the resources are in place to fulfill the mission of each Bureau.

Grievances: Lawrence Pettey: Inmate Grievance Coordinator

The Grievance Coordinator reviews 3rd level inmate grievances to insure due process and propriety of grievances filed by inmates, while protecting the interests of the Division and State.

PREA Compliance: Tim Harper, Director

This office was established to ensure compliance of the standards of the Prison Rape Elimination Act. Due to the COVID-19 Pandemic, many audits had to be rescheduled during FY20; the two facilites that did receive accreditation were the Sam Perdue Juvenile Center and Southern Regional Jail and Correctional Facility.

Safety & Loss Prevention Department: Anthony Carrico, Director

Goals of this office include the reduction of workers compensation experience modification ratings, improve return to work participation and review inspection principles, safety strategies and overall consistency and uniformity with all facilities.

Operations Department: Betty Slack, Director

The Director of Operations oversees the contract management of all inmate services contracts; manages the internal audits section; and serves as the liaison for the Division of Corrections and Rehabilitation and the Department of Administrative Services.




The table on the right and the chart below shows the total average sentenced inmate population in WVDCR institutions and the total average sentenced inmate population that have been committed to the WVDCR, but were awaiting prison space in county/regional jails during the past 20 years. During that period, the total inmate population for WVDCR has increased by a total of 2234 inmates.

Inmates that were committed to the WVDCR but were waiting in county/regional jails for bed space in WVDCR facilities increased by a total of 783 inmates since 2001.

The WVDCR also houses inmates in the McDowell County Correctional Center on a per diem contract basis; this population is represented in the "Contracted" column. This segment has increased by 211 inmates in the last 20 years.






Average Daily Population Juvenile Services Residential FY2016-FY2021


