The parties stipulated as follows: Claimant paid for a certain food item, but was transferred to another Respondent facility before he received it. A bailment situation was created between the parties, and Respondent is liable to refund Claimant for the amount paid. The Court found that Claimant should be awarded the sum of \$7.00, which is the amount Claimant paid for the food.

AMOUNT CLAIMED: \$14.00

AMOUNT AWARDED: \$7.00

CC-16-0643 MIGUEL DELGADO V. DIVISION OF CORRECTIONS

The parties stipulated as follows: Respondent's officers destroyed certain personal items including a clay pipe used during religious ceremonies for which he claims \$85.00. The Court found that Respondent is liable for the value of the property which was wrongfully destroyed and that Claimant should be awarded the sum of \$12.95 which it calculates as fair and reasonable recovery to both parties.

CC-15-2042 MIGUEL DELGADO V. DIVISION OF CORRECTIONS

Respondent argues that there is no evidence Respondent caused the damage, and that Claimant has a history of altering or damaging his own property. The Court found that a bailment situation was created between the parties, and Respondent is liable for the damaged property. Claimant should be awarded \$88.00, which accounts for depreciation of the stereo over time, plus \$20.00 for repair costs, for a total award of \$108.00.

CC-14-1086 MIGUEL DELGADO V. DIVISION OF CORRECTIONS

The parties stipulated as follows: Respondent's officers seized two legal books which Claimant lawfully possessed without giving him a receipt for the same. A bailment situation was created between the parties, and Respondent is liable for the value of the missing property. The parties disputed the value of the books. The Court found that Claimant should be awarded the sum of \$80.00, which accounts for depreciation of the books over time.

AMOUNT AWARDED: \$80.00

CC-14-1194 MARK GILLMAN V. DIVISION OF CORRECTIONS

Claimant, an inmate at Huttonsville Correctional Center, seeks to recover \$480.00 for the loss of certain personal property items he alleges were stolen from his cell while he was away. Respondent argues that inmates are responsible for ensuring their property is secure. The Court found that a bailment situation was created between the parties, and Respondent failed to adequately patrol and provide security for inmates' property. Therefore, Respondent was liable for the value of the property, which the Court found was \$480.00.

AMOUNT CLAIMED: \$480.00

AMOUNT AWARDED: \$480.00

CC-15-1826 DONALD GOOD V. DIVISION OF CORRECTIONS

Claimant seeks to recover \$25.00 for sweat pants that he sent to the laundry but were not returned to him. He also had several other items which the Court denied. The Court made an award based upon bailment in an amount determined to be fair and reasonable to the parties.

AMOUNT CLAIMED: \$50.00

AMOUNT AWARDED: \$25.00

CC-15-1590 ELLIOTT GWYNN V. DIVISION OF CORRECTIONS

The parties stipulated as follows: Respondent's officers seized Claimant's personal property when he was transferred to another Respondent facility. Upon his arrival at the new prison, some of Claimant's items were not returned to him. A bailment situation was created between the parties, and Respondent is liable for the value of the missing property. Respondent offered to pay \$71.00, the total value of two of the items, which Claimant accepted. The Court found that the settlement was fair and reasonable, and made an award in that amount.

AMOUNT AWARDED: \$71.00

CC-16-0571 SMITTY HARDING V. DIVISION OF CORRECTIONS

Claimant, formerly an inmate at Mount Olive Correctional Center, seeks to recover \$2,768.85 for the loss of certain personal property items he alleges were lost by Respondent while he was hospitalized in an outside medical facility. Respondent argued that Claimant had not exhausted his administrative remedies, although it could produce no evidence supporting its position. The Court found that a bailment situation was created between the parties, and Respondent was liable for the value of the property, which the Court found was \$918.85.

CC-13-0625 WARREN HEASTER V. DIVISION OF CORRECTIONS

Claimant seeks to recover \$64.21 for sweatshirts and sweat pants that he sent to the laundry but were not returned to him. Respondent stipulated to the loss and value of these items. The Court made an award based upon bailment in the amount agreed by the parties.

CC-14-0486 ROBERT B. JOSEPH V. DIVISION OF CORRECTIONS

Claimant, an inmate at Huttonsville Correctional Center, seeks to recover \$116.00 for the loss of certain personal property items he alleges were stolen from his cell while he was at supper. Respondent argues that inmates are responsible for ensuring their property is secure. The Court found that a bailment situation was created between the parties, and Respondent failed to adequately patrol and provide secure property boxes for inmates. Therefore, Respondent was liable for the value of the property, which the Court found was \$116.00.

AMOUNT AWARDED: \$116.00

CC-15-0138 ADRIAN F. KING, JR. V. DIVISION OF CORRECTIONS

Claimant, an inmate at Huttonsville Correctional Center, seeks to recover \$22.89 for the loss of food items he alleges were destroyed by Respondent while he was working in another part of the prison. Respondent argued that the food items were contraband, and were found in a common area of the cell. The Court found that a bailment situation was created between the parties, and Respondent was liable to the Claimant for the value of the food.

CC-16-0331 NORMENT SECURITY GROUP V. DIVISION OF CORRECTIONS

Claimant seeks to recover \$308,986.73 for renovating security electronics equipment at Mt. Olive Correctional Complex. This amount is the balance owed for a Change Order to a contract for these services. Respondent admitted the validity and amount of the claim. The Court reviewed the claim and determined that Claimant may make a recovery.

CC-0073 HARRY M. PHILLIPS V. DIVISION OF CORRECTIONS

Claimant alleged that personal property was taken from him while he was in solitary confinement and the Court determined that Claimant should be reimbursed for certain items of clothing and a pair of shoes for a total amount of \$133.28 which is fair and reasonable to the parties.

AMOUNT AWARDED: \$133.28

CC-13-0639 HARRY REYNOLDS V. DIVISION OF CORRECTIONS

Claimant and Respondent agreed to stipulate this claim for missing postage purchased for him by his sister. The parties agreed to the amount of \$146.00 which the Court determined to be fair and reasonable to resolve the claim.

AMOUNT AWARDED: \$146.00

CC-16-0306 BARRY GLEN THOMPSON V. DIVISION OF CORRECTIONS

Claimant, an inmate at St. Marys Correctional Center, seeks to recover \$1,200.00 for the loss of certain personal property items he alleges were lost by Respondent following his transfer to the facility from a regional jail. Respondent's witness testified that Claimant's property was erroneously marked with another inmate's name and mailed to the incorrect address. The Court found that a bailment situation was created between the parties, and Respondent was liable for the value of the property, which the Court found was \$800.00.

AMOUNT CLAIMED: \$1,200.00

AMOUNT AWARDED: \$800.00

CC-14-0394 MAX J. WOODSON V. DIVISION OF CORRECTIONS

The parties stipulated as follows: Claimant's X-Box video game was missing from his personal property following a contraband search in his cell. A bailment situation was created between the parties, and Respondent is liable for the value of the game. The Court found that Claimant should be awarded the sum of \$69.97, the value of the game.

CC-16-0397 EDWIN L. WRIGHT II V. DIVISION OF CORRECTIONS

Respondent was negligent in its maintenance of the road, and agreed to reimburse Claimant for her vehicle damage and towing bill. The Court found that Claimant failed to prove her damages for lost wages and is therefore not entitled to recover for the same.

Respondent was responsible for the maintenance of Route 16, which it failed to maintain properly on the date of the incident. The parties agreed to the amount of \$6,000.00 as a full resolution of the claim, and the Court granted the award.

CC-14-0508 / CC-14-1481 JERRY ADKINS AND ROSE LITA ADKINS V. DIVISION OF HIGHWAYS

Claimants brought these separate actions, which were later consolidated by this Court, following a single incident on Route 61 / Mill Creek Road in Fayette County. Claimants' vehicle struck a hole in the road, causing Claimant Jerry Adkins to lose control and swerve off the roadway. Both Claimants suffered physical injuries, and the vehicle was damaged. For purposes of settlement, Respondent acknowledged some culpability for the accident. The Court found that Respondent was negligent in its maintenance of the road, and granted an award to Claimants in total amount of \$17,500.00, which amount was agreed by the parties as a fair and reasonable settlement of the claim.

Upon consideration, the Court found that the Respondent was negligent in its maintenance of the road on the dates in question, and granted Claimant an award of \$620.53, which is 40% of the total repairs paid for each separate incident, given the age and condition of her vehicle.

CC-15-1384 MELISSA DAWSON V. DIVISION OF HIGHWAYS

Claimant seeks to recover \$685.82 in damages to her 1992 Subaru Legacy, which struck a large hole on U.S. 19 in Morgantown, Monongalia County. Upon consideration, the Court found that the Respondent was negligent in its maintenance of the road on the date in question and granted Claimant an award in the amount of her damages.

AMOUNT CLAIMED: \$685.82

AMOUNT AWARDED: \$685.82

CC-09-0102 DEREK FRIZZI V. DIVISION OF HIGHWAYS

Claimant and Respondent stipulated to this claim which resulted from injury to Claimant's person after the vehicle in which Claimant was a passenger was buried under a landslide while traveling on Route 2 near Wellsburg, Brooke County. Respondent was responsible for the maintenance of Route 2, which it failed to maintain properly on the date of the incident. The parties agreed to the amount of \$3,000.00 as a full resolution of the claim, and the Court granted the award.

AMOUNT CLAIMED: Unliquidated

AMOUNT AWARDED: \$3,000.00

CC-15-1685 MICHAEL E. FRUM V. DIVISION OF HIGHWAYS

Claimant seeks to recover \$300.92 in damages to his 2005 Ford Excursion, which was struck by a low-hanging branch on Fields Park Road in Morgantown, Monongalia County. Respondent argued that it had no notice of the tree or its potential hazard to motorists. The Court found that the Respondent was negligent in its maintenance of the road on the date of the incident and made an award in the amount of \$300.92, the amount of damages proven by the evidence.

AMOUNT AWARDED: \$300.92

CC-16-0260 EMMA L. GIFFIN V. DIVISION OF HIGHWAYS

Claimant and Respondent stipulated to this claim which resulted from damage to Claimant's 2015 Ford Focus after it struck a sharp object on Zane Street in Wheeling, Ohio County. Respondent was responsible for the maintenance of Zane Street, which it failed to maintain properly on the date of the incident. Claimant subsequently provided her insurance declarations page to establish her collision deductible of 500.00. The Court made an award of \$113.96 for her damages.

AWARDED: \$113.96

CC-14-0826 WILLIAM W. GREEN V. DIVISION OF HIGHWAYS

Claimant seeks to recover \$1,220.37 in damages to his 2001 Mercedes C-240, which struck a large hole in the travel portion of MacCorkle Avenue in South Charleston, Kanawha County. Claimant stated that one tire immediately blew upon impact with the hole, and approximately 20 months later, in August 2015, he was advised that other parts of the car were damaged, although it was not determined that these damages resulted from this incident. The Court found that the Respondent was negligent in its maintenance of the road on the date in question and made an award in the amount of \$59.50, the total replacement cost for one of Claimant's tires, as stipulated by Respondent at the hearing.

AMOUNT AWARDED: \$59.50

CC-14-1396 DAVID HASHIMOTO V. DIVISION OF HIGHWAYS

Claimant seeks to recover \$1,789.11 in damages to his 1998 Dodge Ram, which struck a piece of metal debris in a construction zone on Interstate 79 near Jane Lew, Lewis County. Following the hearing, it was determined that a third-party contractor was performing the construction work, and Claimant was advised by the contractor that he could not file a claim with the company because the accident occurred more than two years prior to his contact. Upon consideration, the Court found that the Respondent was negligent in its maintenance of the road on the date in question and made an award. The Court further found that Respondent could seek indemnification from the third-party contractor for damages.

AMOUNT CLAIMED: \$1,789.11

AMOUNT AWARDED: \$1,789.11

CC-15-2003 RANDY HENNEN V. DIVISION OF HIGHWAYS

The parties stipulated as follows: Claimant was operating his 1992 Ford tractor on his own field near the site of a newly constructed bridge when he ran over an unmarked survey stake, causing damage. Respondent was negligent in its maintenance of the area and agreed to reimburse Claimant for the cost of the replacement tire tube, but deferred to the Court's ruling on whether Claimant should be reimbursed for his own claimed labor in replacing the tube. The Court found that Claimant's claim for labor costs was proper and awarded the same.

CC-09-0103 TIFFANY JACKSON V. DIVISION OF HIGHWAYS

Claimant and Respondent stipulated to this claim which resulted from injury to Claimant's person after the vehicle in which Claimant was a passenger was buried under a landslide while traveling on Route 2 near Wellsburg, Brooke County. Respondent was responsible for the maintenance of Route 2, which it failed to maintain properly on the date of the incident. The parties agreed to the amount of \$3,000.00 as a full resolution of the claim, and the Court granted the award.

AMOUNT AWARDED: \$3,000.00

CC-13-0592 JERRY J. JUSTICE AND WANDA JUSTICE V. DIVISION OF HIGHWAYS

Claimants brought this action for property damage to their residence in Garland, McDowell County, which they allege occurred as a result of Respondent's negligent maintenance of a drainage system. Claimants stated that they had previously contacted Respondent about flooding potential near their home and had been advised that the problem would be fixed. However, no such work was performed, and in September 2013 extremely heavy rains washed out the road and caused water to flow down a nearby hill, flooding Claimants' property and residence. Respondent argued that it was not liable for damage caused by unexpectedly heavy rain, and the road had been properly maintained. The Court found that Respondent failed to maintain the drainage system in compliance with its duties, and failed to take reasonable steps to remedy the drainage issue following adequate notice of possible flooding. The Court therefore made an award to Claimants in the amount of damages proven at the hearing.

CC-15-1522 SHERRY P. KING V. DIVISION OF HIGHWAYS

Claimant seeks to recover \$744.09 in damages to her 2002 Subaru Forester, which struck a series of large holes over a period of several months on Route 7 in Cassville, Monongalia County. Upon consideration, the Court found that the Respondent was negligent in its maintenance of the road on the dates in question, and granted Claimant an award of \$250.00, which was the amount of her collision insurance deductible.

AMOUNT AWARDED: \$250.00

CC-09-0101 JAYSON M. LAROCHE V. DIVISION OF HIGHWAYS

Claimant and Respondent stipulated to this claim which resulted from damage to Claimant's vehicle and injury to his person after the vehicle was buried under a landslide while traveling on Route 2 near Wellsburg, Brooke County. Respondent was responsible for the maintenance of Route 2, which it failed to maintain properly on the date of the incident. The parties agreed to the amount of \$30,000.00 as a full resolution of the claim, and the Court granted the award.

AMOUNT CLAIMED: Unliquidated

AMOUNT AWARDED: \$30,000.00

CC-14-1225 ROBERT B. LAWRENCE and MARTHA JANE LAWRENCE V. DIVISION OF HIGHWAYS

Claimants brought this action for damages to their vehicle which occurred on Route 40 near Wheeling when it went into a hole and sustained damage. Claimant and Respondent stipulated the claim and the Court made an award in the amount agreed upon by the parties because it was less than the collision deductible of \$1,000.00.

AMOUNT CLAIMED: \$193.88

AMOUNT AWARDED: \$193.88

CC-12-0334 STEVEN MOHWISH AND DEBRA MOHWISH V. DIVISION OF HIGHWAYS

Claimants brought this action for property damage to their residence in Parkersburg, Wood County, which they allege occurred as a result of Respondent's negligent maintenance of a drainage system. Respondent argued that although there was a drainage pipe failure, it was prohibited from repairing the issue because it was located on private property. Respondent further argued that Claimants' land was contained in a natural drainage course. The Court found that Respondent failed to maintain the drainage system in compliance with its duties and is thus responsible for the flooding damages. The Court therefore made an award to Claimants in the amount of actual damages proven at the hearing.

CC-15-1788 HEATHER MOORE and BEN MOORE

This claim was stipulated by the parties wherein Claimants' vehicle sustained damages as the result of an incident which occurred on I-64 in Huntington. There was a large hole in the pavement of the roadway and Respondent failed to maintain the highway in proper condition on this date. The Court made an award in the amount agreed upon by the parties.

CC-15-0285 MARTHA MOYERS V. DIVISION OF HIGHWAYS

Claimant brought this action for property damage to her residence in Parkersburg, Wood County, which she alleges occurred as a result of Respondent's negligent maintenance of a drainage system. Respondent argued that although there was a drainage pipe failure, it was prohibited from repairing the issue because it was located on private property. Respondent further argued that Claimant's land was contained in a natural drainage course. The Court found that Respondent failed to maintain the drainage system in compliance with its duties and is thus responsible for the flooding damages. The Court therefore made an award to Claimant in the amount of actual damages proven at the hearing.

Claimants stated that the additional weight has caused the bank to slip, resulting in damage to their retaining wall, driveway and carport. Respondent argued that the damage was due to the construction of the retaining wall, which cut into the natural slope of the land. The Court found that Respondent's maintenance of the road has significantly increased the pressure and has caused the earth to move, which in turn caused Claimants' damages. The Court therefore made an award to Claimants in the amount of damages proven at the hearing, plus 20% of the estimated total due to an increase in costs.

AMOUNT AWARDED: \$8,611.34

CC-14-0315 HANK W. SNOW V. DIVISION OF HIGHWAYS

Claimant and Respondent stipulated to this claim wherein Claimant was traveling on Route 17 in Boone County when he drove off the road on his right, over steered his vehicle and lost control of the vehicle which then rolled several times causing personal injuries to Claimant and damages to his vehicle. The parties agreed to a total damage amount of \$80,000.00. The Court reviewed the stipulation and made an award to the Claimant.

AMOUNT AWARDED: \$80,000.00

CC-15-2005 SOUTHEASTERN EQUIPMENT COMPANY, INC. V. DIVISION OF HIGHWAYS

The parties stipulated as follows: Claimant, a foreign corporation, rented certain construction equipment to Respondent over a period of several months, and Respondent failed to pay Claimant for the rented equipment in accordance with the parties' agreement. The parties agree that an award in the amount of \$73,995.70 would be fair and reasonable to resolve the claim. The Court found that Respondent did breach the parties' contract, and Claimant is entitled to recover the agreed amount.

CC-16-0514 SHANNON B. STEWART AND JAMES O. STEWART V. DIVISION OF HIGHWAYS

Claimants seek to recover \$2,880.00 for the value of a 1998 Ford Ranger which was totaled after striking a large tree in the travel portion of WV Route 97 in Pineville, Wyoming County. Respondent argued that it had no notice of the tree or its potential hazard to motorists. The Court found that the Respondent was negligent in its maintenance of the road on the date of the incident and made an award in the amount of \$2,880.00, the amount of damages proven by the evidence.

AMOUNT CLAIMED: \$2,880.00

AMOUNT AWARDED: \$2,880.00

CC-14-1024 GLENN M. TAYLOR V. DIVISION OF HIGHWAYS

Claimant seeks to recover \$3,125.91 in damages to his 2006 Volkswagen Jetta, which struck rocks in the travel portion of Route 43 in Elkview, Kanawha County. Claimant stated that Respondent had previously cleaned up rock slides in the area, and no signs were present warning of the potential for falling rock. The Court found that the Respondent was negligent in its maintenance of the road on the date in question and made an award in the amount of \$3,125.91, the total of Claimant's damages.

AMOUNT AWARDED: \$3,125.91

CC-15-0915 JONATHAN VILLANUEVA V. DIVISION OF HIGHWAYS

Claimant and Respondent stipulated to this claim which resulted from damage to Claimant's 2013 Chevrolet Sonic after it was struck by a boulder falling from a hill adjacent to Route 60 in Cedar Grove, Kanawha County. Respondent was responsible for the maintenance of Route 60, which it failed to maintain properly on the date of the incident. At the hearing, the Claimant stated that although he received emergency medical treatment as a result of the incident, he waived any claim for personal injury and agreed to accept the stipulated amount of \$500.00 as a full resolution of the claim. The Court granted an award in the amount of \$500.00, the amount of Claimant's insurance collision deductible.

AMOUNT AWARDED: \$500.00

CC-15-1300 ROBERT WADE, JR., AND ALICE WADE V. DIVISION OF HIGHWAYS

Claimants seek to recover \$1,000.00 in damages to their 2004 Ford F-150 and 2007 Ford Edge, which struck a series of large holes in separate incidents on Eads Mill Road in Princeton, Mercer County. Upon consideration, the Court found that the Respondent was negligent in its maintenance of the road on the dates in question, and granted Claimants an award of \$500.00 for each of the two claimed incidents, for a total of \$1,000.00.

AMOUNT AWARDED: \$1,000.00

CC-15-0933 AMY SUE WOLFE V. DIVISION OF HIGHWAYS

Claimant seeks to recover \$786.35 in damages to her 2012 Ford Focus, which was struck from underneath by a large rock on Tallentire Road in Bruceton Mills, Preston County. Respondent argued that the nature of the gravel base road in question made incidents like Claimant's unavoidable. The Court found that the Respondent was negligent in its maintenance of the road on the date of the incident and made an award in the amount of \$786.35, which included Claimant's \$500.00 collision insurance deductible as well as a \$286.35 "betterment charge" Claimant was required to pay out of pocket.

CC-16-0355 JUSTIN D. WOODY V. DIVISION OF HIGHWAYS

Claimant and Respondent stipulated to this claim which resulted from damage to Claimant's 1999 Dodge Avenger after it struck a hole near Brockway Avenue in Morgantown, Monogalia County. Respondent was responsible for the maintenance of Brockway Avenue, which it failed to maintain properly on the date of the incident. Respondent contested the amount of damages asserted by Claimant. The Court found that Claimant was entitled to an award of \$2,089.47, the total of his proven damages.

CLAIM AGAINST DIVISION OF LABOR - WEIGHTS AND MEASURES

CC-16-0883 UNIFIRST CORPORATION V. DIVISION OF LABOR - WEIGHTS AND MEASURES

Claimant seeks to recover \$34.41 for equipment supplied to Respondent and documented by an unpaid invoice. Respondent admits the validity of the claim agrees that the same should be paid. The Court found that sufficient funds were expired in the appropriate fiscal year from which the invoice could have been paid, and Claimant is entitled to an award.

CLAIMS AGAINST DIVISION OF MOTOR VEHICLES

CC-16-0889 RHONDA ODELL V. DIVISION OF MOTOR VEHICLES

Claimant seeks to recover \$120.00 for fees paid to retrieve a vehicle from impoundment following an error made by Respondent regarding Claimant's registration. Respondent admitted the validity of the claim and the amount. The Court made an award to Claimant.

AMOUNT AWARDED: \$120.00

CC-15-1559 JEFFREY A. POE AND GINNY A. POE V. DIVISION OF MOTOR VEHICLES

Claimant seeks to recover \$919.75 for taxes paid on a vehicle that Claimant returned to the dealer shortly after purchase. Respondent admitted the validity and amount of the claim. The Court found that Claimant was entitled to an award in the amount of the taxes paid.

AMOUNT AWARDED: \$919.75

CLAIM AGAINST DIVISION OF REHABILITATION SERVICES

CC-16-0955 RUSSELL NESBITT SERVICES INC. V. DIVISION OF REHABILITATION SERVICES

Claimant seeks recovery for providing Workshop programs to Respondent for which it has not been paid. Respondent admitted the validity and the amount of the claim. The Court made an award in the amount agreed upon by the parties.

CLAIMS AGAINST REGIONAL JAIL AUTHORITY

CC-16-0319 BILLY RAY AYERS, JR. V. REGIONAL JAIL AUTHORITY

Claimant, an inmate at Southern Regional Jail, seeks to recover \$600.00 for the loss of a certain personal property item he alleges was lost by Respondent following his booking at the facility. Claimant states that when he was processed at the jail, his personal property, including a family ring, was collected and stored by Respondent; however, when he inquired of the whereabouts of the ring, he would told it was not with his other items. Claimant argues that Respondent is liable for the loss of his ring, which he valued at \$600.00. The Court found that a bailment situation was created between the parties, and Respondent was liable for the value of the property, which the Court found was \$200.00.

AMOUNT CLAIMED: \$600.00

AMOUNT AWARDED: \$200.00

CC-15-1584 LOIS BAKER, P.O.A. FOR DENVER BAKER V. REGIONAL JAIL AUTHORITY

The parties stipulated as follows: Claimant ordered five books to be delivered to Denver Baker at Western Regional Jail; however, Mr. Baker only received two of the books. A bailment situation was created between the parties, and Respondent is liable for the value of the missing books.

AMOUNT CLAIMED: \$60.07

AMOUNT AWARDED: \$60.07

CC-15-1937 JAMES TIMOTHY COBB V. REGIONAL JAIL AUTHORITY

The parties stipulated as follows: Claimant's personal property was damaged due to his cell mate's misconduct during his incarceration at North Central Regional Jail. Respondent's officers removed and destroyed the damaged property without giving him a receipt for the same. A bailment situation was created between the parties, and Respondent is liable for the value of the missing property, which the parties agreed was \$75.00.

AMOUNT CLAIMED: \$100.00

AMOUNT AWARDED: \$75.00

CC-15-1946 DAVID FARIAS V. REGIONAL JAIL AUTHORITY

The parties stipulated as follows: Claimant's personal property, including \$342.00 in cash, was taken from him and inventoried when he was processed at Eastern Regional Jail. Upon Claimant's release from the facility, all of the property except the cash was returned to him. A bailment situation was created between the parties, and Respondent is liable for the value of the missing cash.

AMOUNT CLAIMED: \$342.00

AMOUNT AWARDED: \$342.00

CC-16-0359 IRVIN J. BAKER AND KELLI M. FORDYCE V. REGIONAL JAIL AUTHORITY

The parties stipulated as follows: Approximately 40 books owned by Claimant Baker that had been purchased by Claimant Fordyce were confiscated by Respondent's officers during a search of the facility, and were never returned to the inmate, Claimant Baker. A bailment situation was created between the parties, and Respondent is liable for the value of the missing property, which the parties agreed was \$591.73.

AMOUNT CLAIMED: \$700.00

AMOUNT AWARDED: \$591.73

CC-15-2080 SUSAN GANDY V. REGIONAL JAIL AUTHORITY

The parties stipulated as follows: Claimant's personal property, including a ring, was confiscated upon her booking at South Central Regional Jail. When Claimant was released from the facility, all of her property was returned except for the ring. A bailment situation was created between the parties, and Respondent is liable for the value of the missing property, which the parties agreed was \$1,055.00.

AMOUNT AWARDED: \$1,055.00

CC-15-1819 ARRON D. HUDGINS V. REGIONAL JAIL AUTHORITY

The parties stipulated as follows: Claimant's prescription eyeglasses were taken from him by a correctional officer and were never returned, even after the officer was ordered by facility administrators to return the glasses. A bailment situation was created between the parties, and Respondent is liable for the value of the missing property, which the parties agreed was \$400.00.

CC-15-1881 ROBERT W. MOATS V. REGIONAL JAIL AUTHORITY

Claimant, formerly an inmate at North Central Regional Jail, seeks to recover \$300.00 for the loss of certain personal property items he alleges were converted by Respondent during his transfer to another facility. Claimant states that when he was transferred from the jail to St. Mary's Correctional Center, his personal property items, which had been collected by Respondent's officers for transport, were misplaced and never received. Claimant argues that Respondent is liable for the loss of his property. The Court found that a bailment situation was created between the parties, and Respondent was liable for the value of the property, which the Court found was \$200.00.

AMOUNT AWARDED: \$200.00

CC-16-0566 DREW NUTTER V. REGIONAL JAIL AUTHORITY

The parties stipulated as follows: Claimant's personal property was taken from him and inventoried when he was placed in disciplinary segregation at Northern Regional Jail, but was never returned to him upon his release to the general population. A bailment situation was created between the parties, and Respondent is liable for the value of the missing property, which the parties agreed was \$100.00.

AMOUNT CLAIMED: \$165.29

AMOUNT AWARDED: \$100.00

CC-15-1755 JOSHUA CHARLES STOREY V. REGIONAL JAIL AUTHORITY

The parties stipulated as follows: Claimant was transported from North Central Regional Jail to Tygart Valley Regional Jail. Upon his arrival at the new facility, Claimant realized that his personal property was missing. Several months later Claimant was advised that all but two items of his property were missing. A bailment situation was created between the parties, and Respondent is liable for the value of the missing property, which the parties agreed was \$50.00.

AMOUNT AWARDED: \$50.00
