In compliance with W.Va. Code \$7-18-13a, CVBs are to now report to the WVSAO, the WV Joint Committee on Government & Finance, and

The West Virginia Association CVB 90 days following the end of the CVB's fiscal year the following:

- Balance sheet annually
- Income statement annuals
- Either an audit or a financial review triennially W.Va Code § 7-18-14.

In addition, CVBs are to be accredited by an accrediting body such as the WV Association of Convention & Visitors Bureaus (WVACVB) W.VA.

code §7-18-13a(b) which confirms compliance with the following industry standards as follows:

- Annual budget
- Budget allocation within the industry standard of 40%- 40%- 20% (Marketing, Personnel, Administrative),
- Marketing plan targeting markets outside of 50 miles of their destination,
- Full time executive director
- Physical office/Visitor Center,
- Website, and
- Annual reporting to all the CVBs funding entities.

#### Notes to the Financial Statements

December 31, 2022

#### Note A - Summary of Significant Accounting Policies

<u>Nature of Operations</u> - Hatfield-McCoy Convention & Visitors Bureau, Inc. is a non-stock nonprofit corporation established to promote tourism in Logan County and its surrounding communities.

<u>Basis of Accounting</u> - The Organization's policy is to prepare its financial statements on the cash basis of accounting; consequently, revenues are recognized when received rather than when promised or earned and certain expenses and asset purchases are recorded when cash is disbursed rather than when the obligation is incurred, payroll taxes that have been withheld but not yet deposited with the taxing authority but related to compensation paid are recorded when withheld.

<u>Cash and Cash Equivalents</u> - For purposes of the statement of cash flows, cash includes only deposits in bank accounts available for operating expenses.

<u>Classification of Support</u> – The Organization reports gifts of cash and other assets as restricted support if they are received with donor or grantor stipulations that limit the use of the donated assets. When the restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, with donor restricted net assets are reclassified to without donor restricted net assets and reported on the statement of support, revenues, expenses, and changes in net assets – cash basis as net assets released from restrictions. Donor-imposed restrictions met in the same year in which the contribution is recognized are reported as changes in net assets without donor restrictions during that year.

<u>Income Taxes</u> - The Hatfield-McCoy Convention & Visitors Bureau, Inc. is a nonprofit corporation under section 501(c)(6) of the Internal Revenue Code and is exempt from income taxes from its nonprofit activities. The Internal Revenue Service has classified the organization as a non-profit that is not a private foundation.

Management has determined that the company does not have any uncertain tax positions and associated unrecognized benefits that materially impact the financial statements or related disclosures. Because tax matters are subject to some degree of uncertainty, there can be no assurance that the company's tax returns will not be challenged by the taxing authorities and that the company will not be subject to additional tax, penalties and interest as a result of such challenge.

The company has exempt organization tax filings open to Internal Revenue Service audit for years ending December 31, 2020, 2021 and 2022.

<u>Advertising Costs</u> - Hatfield-McCoy Convention & Visitors Bureau, Inc. expenses advertising costs as they are incurred.

#### Note A - Summary of Significant Accounting Policies (Continued)

<u>Estimates</u> - The preparation of financial statements in conformity with the modified cash basis requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### Note B - Subsequent Events

The organization has evaluated all subsequent events through July 3, 2023, which is the date the financial statements were available to be issued. The organization believes that there have been no significant subsequent events.

# **Elk Visitor Center**

The West Virginia Division of Natural Resources (WVDNR) has awarded a \$6.7 million contract to the March-Westin Company, Inc. of Morgantown to construct a new Tomblin Wildlife Management Area Visitor Center and Elk Viewing Platform in Logan County.

Construction on the new Elk Visitor Center, set to open in 2025, will draw thousands of visitors to witness the elk herd's majesty, boosting the local economy and supporting ongoing elk management. The elk viewing tower, with enhanced accessibility, will complement the visitor center's 2,000-square feet of displays, conference facilities, and offices. An additional 500-square feet will highlight the elk program's history. Beyond the visitor center, the facility includes 3,300-square feet tailored to managing West Virginia's growing elk herd.

Funding for the project comes from \$2.5 million in Abandoned Mine Lands grants awarded by Gov. Justice, along with \$2.1 million from the West Virginia Department of Economic Development and an additional \$2.1 million from hunting and fishing license funds.

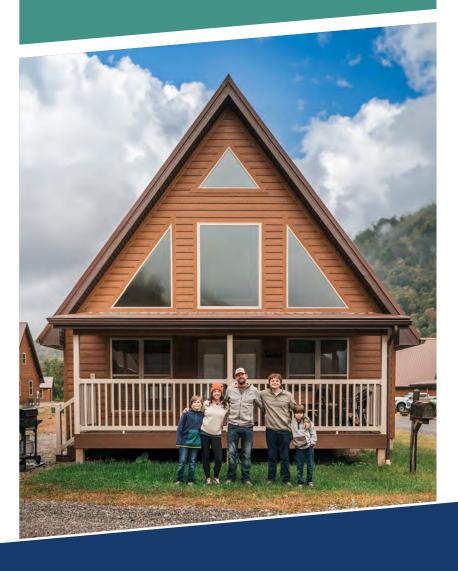

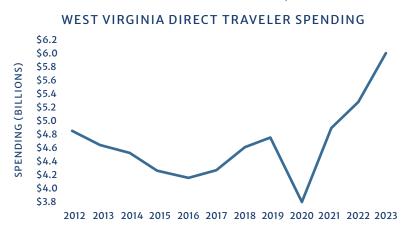
