BOARD MEETING MINUTES

West Virginia Board of Licensed Dietitians
Monday, October 6, 2014 at 5:00 PM
Minutes

Meeting was called to order at 5:10 PM with a quorum established.

Attending: Helen Lodge, MS, RD, LD, Chair, Frank O. Markun, MBA, RD, LD, Betty Forbes, MS, RD, LD (via telephone), Rick Call

Absent: Adrian Richard McGinnis, WVAND Board Liaison

Approval of previous minutes-June 23, 2014-accepted for filing

Treasurer's Report-Frank Markun gave balance of accounts and had the report filed with Secretary.

Approval new licensed dietitians since last meeting were discussed and accepted by committee, record placed with Secretary for filing.

REVIEW OF RENEWAL PROCESS

ACTION: The WV Treasurer's Office mailed postcards to licensed dietitians by May 1st apprising licensees of the online availability. A few postcards came back with undeliverable stamped on them. Have looked at the addresses and some were for lapse status people. Will asked the Treasurer's Office to check the data base and make sure we only get Active licenses next year. Those requesting a paper copy will be required to pay a \$5.00 processing fee.

AUDITING OF ALL LICENSEES FILES

ACTION: An audit is being performed to verify that the database and files are consistent as they are placed into the fireproof file cabinet. Once done a list of even year licensees will be printed and sent to Frank to have the company generate a random sampling for Betty to send out letters to.

TELECONFERENCING

ACTION: It was discussed that we need to call IT support line to find out how to hook up new telephone conference call system that was purchased recently. This new telephone will allow us to speak and hear callers clearly.

FEE INCREASE

ACTION: Discussed best way to pursuit increasing the licensing fee from %50.00 to \$100.00 through Rules and Regulations. We will have Helen find out correct procedure for doing this for next Fiscal year.

REVIEW OF POLICIES FOR BOARD

ACTION: Helen assigned to find a group of Registered and Licensed Dietitians in the area that would be willing to review all policies and procedures that have been established by this Board and give suggestions for improvements. They will meet over the winter and have a report by the Spring meeting.

OFFICE PROCEDURE

ACTION: Review and approve a new reinstatement form for use after August 31st of each year for those licensed dietitians that have gone into lapse status and want to be reinstated. This will avoid the need to have them fill out the long form again, creating more paperwork to file. It was accepted to start using the new form immediately.

ANNUAL REPORT

ACTION: Helen suggested that the Board purchase a large screen for desktop because it is very difficult to put together the annual report with the existing one. This report is due by December 31, of every year. Motion made and accepted to have her purchase a large flat screen monitor to help with the production of annual reports.

OLD BUSINESS

ACTION: None discussed

NEW BUSINESS

ACTION: Helen, Safety Committee Chair for the Board, reminded us to only exit out the front door when an emergency in the building occurs, including, but not limited to fires. When exiting the building be cautious of oncoming traffic to the left of building, since the sidewalk is very narrow.

ACTION: Since several members did not have their calendars available, it was decided that Helen would send out an e-mail to see what date in February would be good for all of members to attend.

Call to Order: The meeting was called to order by Vice Chairman Frank Markun and a quorum was established.

Special Recognition for Helen Lodge’s Years of Service: This was the first Board Meeting since the death of Helen Lodge, who had helped create the Board in 1997 and had served as its chairman since that time. Helen’s unwavering dedication and service to the Board and the practice of dietetics was recognized by Frank and all those attending the meeting. Helen had received numerous local, state and national honors for her volunteer work in health and nutrition, the arts, education and humanitarian causes.

Introduction of New Board Members: Helen Lodge and Frank Markun had been working to have some new members appointed to the Board to fill vacancies, and Governor Tomblin had made these new appointments in early June. Frank welcomed these new Board members -- Grady Bowyer, Mary Kathryn Gould, Margaret “Peg” Andrews, and Susan Arnold. He then asked them and Nancy Hill, administrative assistant, to tell a little about themselves. After everyone introduced themselves, Frank moved that new officers be elected.

Election of New Officers: Suggestions were taken for the new chairman and Frank Markun stated that he would like to keep his position as vice chairman/CFO. Members agreed it was not necessary to continue publishing a newsletter, so it was not necessary to fill this position. The following officers were then elected:

Chairman - Grady Bowyer
Vice Chairman/CFO - Frank Markun
Audit Committee Chairman: Susan Arnold
Secretary – Mary Katherine Gould

Approval of Minutes: Due to the illness and death of Helen Lodge, the minutes of the September 2014 Board meeting were not available. Frank said he would compile the minutes and share them with Board members.

Treasurer’s Report: Frank Markun presented a brief Financial Report which the members approved.

Annual Audit: Plans were discussed for the Annual Audit with the new chairman Susan Arnold, who will present the findings at the Board's next meeting.

New/Renewed and Provisional Licensees: The Board approved 10 new licenses, renewed 10 licenses, and changed 1 licensee from provisional to active status.

Updates to Website: Nancy Hill reported on the steps she has taken to help clarify the verification process on the website and the other updates that need to be made to the website to make the application process easier. Grady Bowyer stated he would plan to meet with Phil White at the Treasurer's office to go over all the changes that need to be made to the website and sign a contract for the work to be done.

Other Database Changes: Grady Bowyer and Nancy Hill discussed the need to make the renewal process easier. Grady said he would ask Phil White in the Treasurer's Office to make it possible to download the database in an Access format in addition to the Excel format, and make other changes to simplify the renewal process.

Information from Other States: Richard McGinnis said he would be happy to put Board members in touch with other states if we had questions concerning how they handle various processes. The Board members thanked him for this offer

Filing of the Annual Report: A 2014 Annual Report has not been filed and Grady Bowyer said he would do what he could to create the report.

Newsletter: During discussions earlier in the meeting about the need to fill the newsletter editor position, it had been decided not to continue publishing the newsletter because it is not a requirement that Boards publish newsletters.

Safety Training: The requirement for Board members to complete the Defensive Driving Course and the steps they need to take to complete it was discussed.

WV Auditor's Conference: This year's Auditor's Conference will take place on Dec. 1 at the Charleston Marriott. Last year, Frank Markun and Nancy Hill had attended. Grady stated he was planning on attending and encouraged other board members to register and attend.

Special Recognition to Nancy Hill: Grady Bowyer and the Board members thanked Nancy Hill for all she has done to keep the office running smoothly while Helen was ill and during these past months since her death when renewals were due. Nancy has worked for the Board since July 2013 on a temporary part-time basis and her status has now been changed to permanent part-time. Grady made a motion that Nancy's pay be increased. After a brief discussion, new Board members said they appreciated Nancy's work and they would like to increase her pay, but needed to table the motion until the next meeting when they would know more about the Board's financial status.

Other New Business: There was none reported.

Old Business: There was none reported.

Next Board Meeting Date: The next Board meeting will be Dec. 8 at 5 p.m.

Adjournment: The meeting adjourned at 7:22 p.m.

Non-Members Present: Frank Markun and Richard McGinnis, Public Member appointed by WVAND as the Consumer Protection Coordinator

Call to Order: The meeting was called to order at 5:00 PM by Chairman Grady Bowyer. A quorum was established.

Approval of Minutes: Minutes of 8/11/15 meeting were approved with a minor change in Richards McGinnis' title. Richard was appointed by the WV Academy of Nutrition and Dietetics (WVAND) as the Consumer Protection Coordinator.

Minutes of 10/6/14 meeting with an editorial change removing a percent sign and replacing it with a dollar sign under fee increase were approved.

Financial Report: A week prior to the board meeting, Frank Markun's appointment to the board was rescinded due to his time in office. Frank has agreed to volunteer and assist the new Vice Chair/CFO transition into the position. He also stated that Linda Lyter, Executive Director of Massage Therapy and Acupuncture, will continue to assist with budget forecasting. Bills for the WVBOLD include rent, parking, telephone, IT, and the Attorney General's service if necessary.

Replacement for Vice Chairman/CFO: Peg Andrews volunteered to take the position as Vice Chair/CFO and board members voted to approve her in this position.

Recommendation for New Board Member: Richard McGinnis will inform the WVAND Board of the need to fill the vacant WVBOLD position. This position is supposed to be filled within 60 days of the vacancy (12/2/15). Several names were submitted for the most recent appointments, but WVAND will need to see if they are still willing to serve. All potential

names are to be sent to Richard by 12/18 and he will submit them to Becky Neal in the Governor's office.

Audit Committee Report: Thirty audit letters and forms were mailed on 10/15/15 to randomly selected licensees who were given a one month timeframe for completion. Susan received 29 of 30. License 554 did not return the information. As this license holder is currently active, a certified letter will be sent requesting submission of the information. If the license holder reports that he/she is retired, then an audit request will be sent to the next person on the list.

Of those who returned the information, 20 had acceptable documentation. Questionable documentation included:

1. Certificates of program completion without signatures. Some of which did not indicate the number of CPEs provided – It was determined that these were likely completed online. Licensees need to be sure to provide additional information regarding the number of CPEs.
2. Copies of presentation PowerPoints – This was not deemed acceptable as presentation notes can be shared. A certificate, receipt, or confirmation letter must be included as evidence of CPE.
3. Some licensees reported speaking at conferences for CPEs – This is not appropriate as the speaker is providing the information, not gaining knowledge.
4. Certificates of completion from ServSafe – We need to ascertain whether or not ServSafe is accepted by CDR

Auditees who returned questionable documentation will be requested to send additional information.

The board determined it would be appropriate to add these issues to the FAQs on the website.

Disciplinary Matters: No issues presented since the last meeting.

New and Provisional Licenses: New licenses: 6 Provisional Licenses: 2
Motion to accept the new and provisional license passed

Database Report: Grady Bowyer met with the treasurer's office and we are now able to have our database exported to Access. With this, we have more flexibility in terms of reports and mailings. These can be customized by active status, lapse status, etc.

Renewals for 2016: The renewal period will be May 1-June 30. After July 1, Treasurer's office will assess the \$25.00 late fee. Since we now have online renewal, would like to phase out using any form of cash/check. Goal is to have all individuals using the online renewal

process, even new applicants. The possibility of printing a temporary license until one is mailed will be considered at a later date.

Application: Revisions to the form for New Applications were reviewed. A discussion ensued regarding the need to bring clarity as to which application an individual is to complete. These need to be clearly stated on the website.

Postcards: A sample postcard providing information on license renewal was reviewed.

A motion to approve the renewal period, revised application, and postcard was made and passed.

Surplus Property: Nancy Hill completed the paperwork to have surplus property removed from the board office. The items were taken 12/8/15.

Concerns: The office was recently contacted with a news media inquiry. It was determined that all media inquiries should be fielded to the Media Relations Chair of the WVAND. That individual's name and number are needed.

Old Business: At the last board meeting a recommendation was made to increase the salary of the Administrative Assistant. After looking into the finances, it was determined that doing so would not be possible because of budget constraints.

New Business: Richard McGinnis attended meetings with AND for public policy, during which he learned that if a state board is going to be experiencing sunset or is attempting to make a change in the licensing law, it is imperative to have a lobbyist. If desired, WVAND can hire a lobbyist to assist in these circumstances.

The meeting was adjourned at 7:01 PM.
