Domestic Appeals Summary FY2015



- 689 appeals were filed between July 1, 2014 and June 30, 2015 (fiscal year 2015) from Family Court final orders to the Circuit Court. In comparison to original petition filings for the same time period, appeals totaled approximately two percent.
- 162 appeals were refused during FY2015.
- 454 appeals were disposed during the fiscal year.
- 75 were remanded back to Family Court.
- Of those disposed, the average* age at disposal was 41 days.
- 138 petitioners represented themselves in their appeal.
- 1 appeal was reported as being automatically transferred to the Supreme Court.
- Of the subject matters reported for these appeals, the three most frequent were child support (22%), domestic violence (19%), and other (18%).

**Data collected from the Circuit Clerks is reported in a summarized format, monthly. Therefore, if a judge disposed of more than one case of a particular type during a single month the age at disposal was reported as an average of such cases. The average calculated for this report utilizes the data collected on such reports and, consequently, may average summarized information.*
