The meeting was called to order at 10:00 a.m by Anita Ray, Board Chairman. Moved by Mr. Harvey, seconded by Mr. Eltzroth, that the minutes of the March 5<sup>th</sup> meeting be approved. Motion carried. Now, I would ask you to approve the minutes of the May 14<sup>th</sup> meeting. Moved by Mr. Harvey, seconded by Mr. Eltzroth, that the minutes be approved. Motion carried.

Motion carried.

We will decide by the next meeting if a late fee will be paid unless it is in the Rule. If it's in the Rule, then we will have to wait until this winter to impose the late fee. Moved by Mr. Harvey, second by Mr. Eltzroth, that those sanitarians that are short of their 15 CEH's who are working for health departments, we will contact them and those working for private industries or other government agencies other than the health department in this state, we make no extra effort to contact them in getting their hours together. Motion carried.



In regards to the CEH's due for January 2012, 15 CEH's are all that is required since it is not in the Rule. Sometime this spring, the Rule will go into effect concerning the CEH's. All that will be required is 15 hours in 2011 for 2012. Moved by Mr. Harvey, seconded by Mr. Eltzroth, that the renewal registrations for CEH's due on January 2012, we will require 15 CEH's to be obtained during the 2011 year. Motion carried.

If Anita gets any comments regarding the new Rule within the comment period that seems reasonable, she may make them without calling a special Board meeting.

Moved by Mr. Eltzroth, seconded Mr. Harvey, that the Board go through State Purchasing to buy a laptop to be used for the recording of the CEH's and Board Meetings. Motion carried.

Moved by Mr. Harvey, seconded by Mr. Eltzroth, that Mike Eltzroth be nominated as Chairman and Richard Wheeler as Vice-Chair for a period of 18 months. Motion carried. The next re-election of officers will be December 2011 and thereafter on every December. Motion carried. The first one was the Declaratory Ruling and basically what I did was strike throughs and underlines, just basically cleaning up the definitions in the new laws. Changed the principal office from the old Washington Street East, Building 3 to our current address. This is all on the passage of the Rule next week. Some code changes 26CSR2, on complaint changes. Again I made all the necessary changes consistent with what the new Law is going to say. Just some code changes and some definition changes. On the 26CSR3, is the one that we spent most of the time on. Obviously, we had the definitions We had Ann to check all the authorities for Code. They will be submitted to Ann Goldberg for review to be submitted to the Legislature. We bumped the fee from \$35 in the new Law this year to \$50 in the Rule. Moved by Mr. Eltzroth, seconded by Mr. Harvey, that Anita Ray give Ann Goldberg the authority to submit the rules to

the legislature. Motion carried. After that, there will be a 30 day public committee period. Attach the comments to the Rule.

Mr. Thornton reported that they transferred the old records to WV State Archives from 1977 to 2000 and kept all other files actually on the sanitarians. We will have a demo done at the next meeting about viewing the CEH's on the web.







When the CEH's are reviewed, they will be debited 30 minutes for breaks. A lot of meetings are being held for different reasons: no agenda, no sign-in sheets, etc.

Jay Carper submitted CEH's which are for nurse credits. He will not be given CEH's for two (2) courses. Anita will send him a letter or a phone call and explain that for CEH's, it has to be sanitarian duties and not nurse duties. Rob Dillon is short 1.25 hours and also the proper

Update of Proposal Chapter 30 Change Law. The Bill is now in the Senate and in Government Organization. Some of the wording was changed. Registration will be renewed before January 1 annually. The new fee will be \$35.00 annually and based on 18 months or 6 months. Mr. Thornton recommended that the 18 months be approved and the fee will be \$52.50 for the 18 months (from July 1, 2009 to January of 2011). Fifteen (15) CEH's are still required. Moved by Mr. Harvey, seconded by Mr. Eltzroth, that the 18 months fee of \$52.50 be required if and when the bill passes. Motion passed.

Review of forms regarding the new Sanitarian Bill. New name, State Board of Sanitarians. Also a proposal for a new seal. Moved by Mr. Harvey, seconded by Mr. Eltzroth, that the Board purchase a new seal.

Two year experience required needed for sanitarian or RS status. Moved by Ms. Ray, seconded by Mr. Eltzroth, that we accept the new form regarding the experience. For part-time sanitarians, the work experience would be equivalent to 2080 hours per year x 2 for the 2 years or 4,160 hours credited. The supervisor would also need to sign off on it. Motion carried.

Sanitarians would still have to pass the Sanitarian's Training Course. We are just waiving the college degree for veterans. Moved by Mr. Eltzroth, seconded by Mr. Harvey, that the meeting be adjourned.

## Complaints in Last 3 Years To West Virginia Board of Registration for Sanitarians

1. **Case 07-001. Filed 8/13/07 Complaint that Sanitarian using his office for personal gain and acting unethically. Upon receipt the Board Chairperson requested an investigation be conducted by the Public Health Sanitation Division field personnel with a report back to the board. The investigation was conducted and a report submitted to the board. After reviewing the complaint and the report from the PHSD the Board decided the actions taken by the sanitarian were not unethical but some were unprofessional. The sanitarian was notified of these findings and stated he would correct the unprofessional behavior. The complainant was notified of this finding. Action taken 9/28/07**
2. **Case 07-002. Filed 8/21/07 Complaint that sanitarian acted in an unethical and unprofessional manner. Upon receipt the Board Chairperson requested an investigation be conducted by the Public Health Sanitation Division field personnel with a report back to the board. The investigation was conducted and a report submitted to the board. After reviewing the complaint and the report from the PHSD the Board decided the actions taken by the sanitarian were not unethical but some were unprofessional. The sanitarian was notified of these findings and stated she would correct the unprofessional behavior. The complainant was notified of this finding. Action taken 10/15/07**
3. **Case 07-003 Filed 10/1/07 Complaint that sanitarian acted in unethical and unprofessional manner. Upon receipt the Board Chairperson requested an investigation be conducted by the Public Health Sanitation Division field personnel with a report back to the board. The investigation was conducted and a report submitted to the board. After reviewing the complaint and the report from the PHSD the Board decided that their was insufficient evidence of any improper behavior and therefore was without merit. The sanitarian was notified of these findings. The complainant was notified of this finding. Action taken 12/10/07.**
4. **Case 09-001. Filed 3/23/09. Complaint that supervising sanitarian requiring them to enforce law in manner violating local ordinance and state rules. Upon receipt the Board Chair requested an investigation be conducted by the Public Health Sanitation Division field personnel with a report back to the board. The investigation was conducted and a report submitted to the Board 04/09. After reviewing the complaint and the report from the PHSD the Board decided the complainant fails to demonstrate that the respondent violates WV Code 30-1-8 or 30-17-12. The differences needed to be addressed by the County Board of Health on enforcement of policies and rules. Notified complainant of decision on 7/9/09**
5. **Case 09-002. Filed 6/24/09. Complaint that Sanitarian supervisor assigned untrained, unapproved staff to conduct sanitarian duties and filed false workmen's compensation claim. Upon receipt the Board Chair requested an investigation be conducted by the Public Health Sanitation Division field personnel with a report back to the Board. The investigation was conducted and a report submitted to the**

Board 8/6/09. After reviewing the complaint and the report from the PHSD the Board decided the Complainant fails to demonstrate that the respondent violates WV Code 30-1-8 or 30-17-12. Workman's Comp complaint was not under Board jurisdiction. Notified complainant of decision on 11/19/09.
