Moved by Ms. Ray, seconded by Mr. White, that Joseph Faller be approved for Sanitarian status. Motion carried.

Ms. Ray went to get Ms. Nassandra Wright for discussion concerning her not attending the required sections of the Sanitarian Training Class as required.

Nassandra Wright has her R.S, Master's, she used to be a food trainer, and she came from out of state. She missed the sewage class by being tied up and out of town for meetings by Dr. Gupta. She intends to take the course for sewage because she has not done a lot of work in sewage when she worked in Ohio. She intends to take the food part this year and the sewage part

next year just because she can't be away from her four children again in Morgantown for that long.

Mr. Thornton explained to her the procedures for anyone coming out of the state with a RS and working in WV, they must attend the food section and the sewage section of the Sanitarian's Training Class. You were expected to be at the next available class. So that isn't possible since the class is going on right now. The Board would have to decide if you violated the terms for us to give her the RS from WV or if we would extend it to the next available class.

Ms. Wright stated that she was required to assist the HO, Dr. Gupta, under a current federal case that is going on which prevented her from being able to attend the sewage class in Morgantown. I am not at liberty to discuss the case since this is a public meeting. So, I would urge you before you take any detrimental action against me; you may want to request the information from Dr. Gupta.

Was Dr. Gupta aware at the time of the scheduling conflict?

Because this was a Federal case and is handled by the Attorney General's Office, I'm sure the parties are aware of the priorities when it comes to that. Also, in the bylaws, there wasn't a timeframe of when you are required to take the courses so I was not aware of that. But in the bylaws, it does state that you need to audit the food and sewage but it didn't specify a timeframe to accomplish that.

Whereas it does state that the 300 hours is stated to have the RS license.

Right, and the 300 hours I had already provided to the Board. I already have the RS license.

So it's your intention to take that part of the course next year.

It is my intention to take that part of the course.

What guarantee do we have that you will do that?

Guarantee? I'm not sure what guarantee I can provide you with because I don't hold the future for tomorrow but at the same time, it is my intention to take the class next year

Obviously, there has to be a timeframe.

Right.

And if there isn't, there should be one established. Correct.

I guess that would be something that we would discuss in Executive Session.

I was under orders to assist with the Federal Case that's going on. Since this is a public meeting, I'm not at liberty to discuss that. Please feel free to contact Dr. Gupta for further details or try to provide it in writing.

In the bylaws, It was referred to as auditing the class.

It is not auditing a class. Auditing a class is just to sit in on a class. You actually would have to take the class and then take a test.

I would like to have more information regarding that. Are you the only one that could have assisted or were there others that could have assisted?

I'm sure that is something that we could provide the details with.

Also, I don't know if the bylaws have changed within the last ten years but I know an individual here that was not required to audit or take the food or sewage section and pass the exam and practice as a sanitarian. So, I would like to be treated in a similar manner unless the law has been changed since then.

Can you provide us the name of the individual that was allowed to practice without taking the food and sewage system sections and taking the tests?

Sure. Mike Waugh. He is a RS in West Virginia. He was never allowed to audit or take the course and pass the exam.

He was told to do that.

Did he do so? Is there documentation I could be provided the same option?

We would have to check the records. He was required. He was supposed to.

So, unless the law has been changed within the last ten years, I would be expected to be treated similar based on federal and state guidelines.

Linda Whaley, who is over the Sanitarian Training Class, always sends us a letter that this individual has met the requirements and attended the course.

Could you clarify what you meant by "not allowed" to take the course?

I just wanted to give you a similar scenario which under similar circumstance, I am expected to be treated similar.

But he was not allowed to take it?

Well, there was no record that he was allowed to take the course or audit the course or pass the exam. But my request is, can I be provided with written documentation that he

took the exam or was he provided an exemption? Can I be provided with documentation and if that was the case, will I be treated similar? I am asking the Board was he allowed or was he exempted?

Your earlier comment, he wasn't allowed to take the test. That is what's confusing me.

Similar circumstance for each individual should be treated in a similar manner.

Are you saying that he didn't take any part of the Sanitarian's Training Course?

What I'm saying is I would like to be provided documentation if he did or he didn't. To my knowledge, he didn't. I'm just saying what was the circumstance, what exactly took place? I'm asking for verification from the Board.

So someone told you that there was someone who didn't take it and he is still allowed to work.

Well, again since this is a public meeting, I wouldn't want to discuss anyone else's issues.

I understand that but you're asking us to make a decision but all the information that I have is personally.

I'm asking the Board because you have records. So, I'm asking the Board, was he allowed or was he exempt? So, that is the question that I have for the Board.

No sanitarian has been exempted. If that did take place, that was a serious oversight.

But that goes back to the issue the reason why I had to miss taking the course was because of the orders that I was under.

Any other questions? Just have a seat outside and we will go into Executive Session.

You can just go back to your office.

The Board came out of Executive Session. Nassandra, it is the decision of the Board and Dr. Gupta has given us his assurance that you will be in attendance next year when the sewage section of the Training Class is offered Do you have any questions or comments?

I would like an explanation of the decision that the Board used in terms or reciprocity on the 20 CSR 04. I'm just trying to figure out the criteria that is met in order for your license to be issued and if you take action after the license is issued, provide the

license to have no conditions on it OK, these are the criterias that need to be met to get your RS license, but I was issued my RS license back in last year. I had no conditions on the license that I needed to fulfill, any further criteria.

Well, it says waste water and food training and any additional training as determined by the Board. With the county's agreement and your agreement, we allowed you to work before taking the food and sewage portions and receiving your RS. You were approved for RS with those conditions. When you were hired by the county, that was all done verbally. We are going to change our procedures actually and put that in writing A man that came out of state from Maryland, he's taking the course right now and it was put in an email to him and where we didn't have an email to you so we don't have anything in writing.

OK.

But it is in the Board's minutes and we could give you a copy of the Board's minutes.

That would be great.

I'm just trying to understand this part of the Regulation.

You took the two sections and this was on the Board's minutes and we are going to put that in writing. We could give you a copy of the minutes that stated that. We had the agreement before you received the RS. The agreement is that you will take the sewage when it is offered next year and the food this year.

Would you find out about Mike Waugh?

In a statement from Dr. Gupta, he said that you will be taking the sewage portion next year and the food portion this year. How soon can you do that?

It is my intention in taking the sewage course next year.

Anita, as your supervisor, gave us the agreement that you would be taking the sewage and food portions when it was available. Are you clear on this, otherwise no one could hire you in WV. The agreement is that you get hired and then you take those.

So, the agreement is as Bill is saying, that if I take the sewage portion next year. Is that correct?

Yes, that is correct.

OK, I just want to make sure that we're all on the same page.

Yes, and Dr. Gupta assured us that this would happen.

Correct.

We will get a letter out to you that we're allowing you to next year to take the sewage portion. We will expect you to take the food this year. It is in writing in the Board Minutes but not necessarily to you but we're going to change that.

Will you be checking on the position of Mike Waugh?

That is a separate issue and we will be investigating and if it turns out that he did not take the food and sewage portions, If he did not take the two sections, then he would be required to do so. He and anyone else across the State. We have to treat all people equal. That will be an ongoing separate investigation. We certainly could not ask you to do something that someone else had not done.

I certainly appreciate that.

We appreciate you bringing that to our attention.

I just wanted to make sure that it was clear for the entire situation. Could you tell me if this was a complaint that was brought to the Board's attention or how was it brought about?

It wasn't a complaint. We were just notified by the Training Officer that you were not in class. She was expecting you in class, which she knew that this was a requirement for you to keep your RS. It wasn't a complaint, she knew what the rules were and was just notifying us.

Do you have any further questions for me?

No.

May I be excused?

Sure.

Is it possible for you to send me the minutes from last year?

Yes.
