AN ACT to amend and reenact section eighteen, article six, chapter twelve of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to continuing the West Virginia board of investments until the first day of July, one thousand nine hundred ninety-seven.

*Be it enacted by the Legislature of West Virginia:*

That section eighteen, article six, chapter twelve of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

**ARTICLE 6. WEST VIRGINIA STATE BOARD OF INVESTMENTS.**

**§12-6-18. West Virginia board of investments continued.**

1 After having conducted a performance and review  
2 through its joint committee on government operations,  
3 pursuant to article ten, chapter four of this code, the  
4 Legislature hereby finds and declares that the West  
5 Virginia board of investments should be continued and  
6 reestablished. Accordingly, notwithstanding the provi-  
7 sions of article ten, chapter four of this code, the West

8 Virginia board of investments shall continue to exist  
9 until the first day of July, one thousand nine hundred  
10 ninety-seven, to allow for monitoring of compliance with  
11 recommendations contained in the preliminary perfor-  
12 mance review and to allow for further review by the joint  
13 committee on government operations.
