AN ACT making a supplementary appropriation of federal funds out of the treasury from the balance of federal moneys remaining unappropriated for the fiscal year ending the thirtieth day of June, one thousand nine hundred ninetyseven, to the bureau of environment, solid waste management board, account no. fund 8820, fiscal year 1997, organization 0312, supplementing and amending the appropriation for the fiscal year ending the thirtieth day of June, one thousand nine hundred ninety-seven.

WHEREAS, The governor has established the availability of federal funds for continuing programs now available for expenditure in the fiscal year ending the thirtieth day of June, one thousand nine hundred ninety-seven, which are hereby appropriated by the terms of this supplementary appropriation bill; therefore
