Senate Bill No. 1014

(BY SENATOR HELMICK)

[Passed March 21, 2004; in effect from passage.]

AN ACT making a supplementary appropriation of public moneys out of the treasury from the balance of moneys remaining as an unappropriated balance in the state fund, general revenue, to higher education policy commission - higher education policy commission - system - control account, fund 0586, fiscal year 2005, organization 0442, all supplementing and amending the appropriations for the fiscal year ending the thirtieth day of June, two thousand five.

WHEREAS, The governor submitted to the Legislature a statement of the state fund, general revenue, dated the fourteenth day of January, two thousand four, setting forth therein the cash balance as of the first day of July, two thousand three; and further included the estimate of revenues for the fiscal year 2004, less net appropriation balances forwarded and regular appropriations for fiscal year 2004; and further included the estimate of revenue for the fiscal year 2005, less regular appropriations for fiscal year 2005; and

WHEREAS, The governor, by executive message dated the twenty-first day of March, two thousand four, has revised the revenue estimates for the fiscal year ending the thirtieth day of June, two thousand five; and

WHEREAS, It appears from the governor's statement of the state fund - general revenue and executive message there now remains an unappropriated balance in the state treasury which is available for appropriation during the fiscal year ending the thirtieth day of June, two thousand five; therefore

Be it enacted by the Legislature of West Virginia:

That the total appropriation for the fiscal year ending the thirtieth day of June, two thousand five, to fund 0586, fiscal year 2005, organization 0442, be supplemented and increased in the existing line item as follows:
