

## Senate Bill No. 3005

(By Senators Tomblin, Mr. President, and Sprouse, By Request of the Executive)

[Passed May 17, 2005; in effect from passage.]

AN ACT supplementing, amending, reducing and increasing items of the existing appropriations from the State Fund, General Revenue, to the Department of Administration - Office of the Secretary, fund 0186, fiscal year 2006, organization 0201, and to the Department of Revenue - State Budget Office, fund 0595, fiscal year 2006, organization 0703, by supplementing and amending the appropriation for the fiscal year ending the thirtieth day of June, two thousand six.

Be it enacted by the Legislature of West Virginia:
