That the Code of West Virginia, 1931, as amended, be amended by adding thereto a new section, designated §18A-2-14, to read as follows:

§18A-2-14. Mileage reimbursement for school personnel.

- 1 A county board shall reimburse any school personnel
- 2 for each mile traveled when the employee is required to .
- 3 use a personal motor vehicle in the course of
- 4 employment. The county board shall reimburse at the
- 5 same rate for all employees in that county. The rate of
- 6 reimbursement shall be at least the lesser of, and not
- 7 more than the greater of, the federal standard mileage
- 8 rate and the rate authorized by the travel management
- 9 rule of the Department of Administration.
