11	adding thereto a new section, designated $$15-9-5$, relating to
12	the authorization of the promulgation of rules by the
13	Governor's Committee on Crime, Delinquency and Correction;
14	meetings; and the composition of advisory committee members.
15	Be it enacted by the Legislature of West Virginia:
16	That the Code of West Virginia, 1931, as amended, be amended
17	by adding thereto a new section, designated $$15-9-5$, to read as
18	follows:
19	ARTICLE 9. GOVERNOR'S COMMITTEE ON CRIME, DELINQUENCY AND
20	CORRECTION.
21	§15-9-5. Authorization for the promulgation of legislative rules.
22	(a) The Governor's Committee on Crime, Delinquency and
23	Correction shall develop and promulgate rules for state, county and
24	municipal law-enforcement officers, law-enforcement agencies and

- 1 communications and emergency operations centers which dispatch law-
- 2 enforcement officers with regard to child abuse and neglect:
- 3 Provided, That such rules and procedures must be consistent with
- 4 the priority criteria prescribed by generally applicable department
- 5 procedures.
- 6 (b) The rules and the revisions thereof as provided in this
- 7 section shall be proposed as legislative rules for legislative
- 8 approval in accordance with article three chapter twenty-nine-a of
- 9 this code.
- 10 (c) Prior to the publication of proposed rules, the Governor's
- 11 Committee on Crime, Delinquency and Correction shall convene a
- 12 meeting or meetings of an advisory committee to assist in the
- 13 development of the rules.
- 14 (d) The advisory committee shall meet at least on a biennial
- 15 basis to review the rules and to propose revisions as a result of

- (e) The advisory committee shall be composed of:

- 9 (6) A health care provider with pediatric experience and child

- 12 Administrative Office of the Courts or his or her designee, as a
- 13 nonvoting member;
- 14 (8) The Director of the West Virginia Child Advocacy Network
- 15 or his or her designee;
- 16 (9) The Director of the West Virginia Developmental
- 17 <u>Disabilities Council or his or her designee;</u>
- 18 (10) An individual representing communications and emergency
- 19 operations centers that dispatch law-enforcement officers; and
- 20 (11) Other persons or organizations who, in the discretion of
- 21 the Executive Director of the Governor's Committee on Crime,
- 22 Delinquency and Corrections have an interest in the rules:
- 23 Provided, That the total number of the advisory committee shall not
- 24 exceed sixteen.

NOTE: The purpose of this bill relates to the authorization of the promulgation of rules by the Governor's Committee on Crime, Delinquency and Correction to establish procedures for the investigation of child abuse and neglect investigations.
