10	A BILL to amend and reenact $$18-5-22$ of the Code of West Virginia,
11	1931, as amended, relating to requiring every county board of
12	education to employ a nurse in each public school in the
13	county.
14	Be it enacted by the Legislature of West Virginia:
15	That $\$18-5-22$ of the Code of West Virginia, 1931, as amended,
16	be amended and reenacted to read as follows:
17	ARTICLE 5. COUNTY BOARD OF EDUCATION.
18	§18-5-22. Medical and dental inspection; school nurses;
19	specialized health procedures; establishment of
20	council of school nurses.
21	(a) County boards shall provide proper medical and dental
22	inspections for all pupils attending the schools of their county
23	and have the authority to may take any other action necessary to
24	protect the pupils from infectious diseases, including the
25	authority to require from all school personnel employed in their
26	county, certificates of good health and of physical fitness.
27	(b) Each county board shall employ full-time at least one
20	
28	school nurse for every one thousand five hundred kindergarten

- 1 thereof: Provided, That each county shall employ full time at
- 2 least one school nurse: each public school in the county,
- 3 beginning with the school year 2011-2012: Provided, however That
- 4 a county board may contract with a public health department for
- 5 services considered equivalent to those required by this section in
- 6 accordance with a plan to be approved by the state board:
- 7 Provided, further however, That the state board shall promulgate
- 8 rules requiring the employment of school nurses in excess of the
- 9 number required by this section to ensure adequate provision of
- 10 services to severely handicapped pupils. An appropriation may be
- 11 made to the state department to be distributed to county boards to
- 12 support school health service needs that exceed the capacity of
- 13 staff as mandated in this section. Each county board shall apply
- 14 to the state superintendent for receipt of this funding in a manner
- 15 set forth by the state superintendent that assesses and takes into
- 16 account varying acuity levels of students with specialized health
- 17 care needs.
- 18 (c) Any person employed as a school nurse must be a registered
- 19 professional nurse properly licensed by the West Virginia Board of
- 20 Examiners for Registered Professional Nurses in accordance with
- 21 article seven, chapter thirty of this code.
- 22 (d) Specialized health procedures that require the skill,
- 23 knowledge and judgment of a licensed health professional may be
- 24 performed only by school nurses, other licensed school health care
- 25 providers as provided in this section, or school employees who have
- 26 been trained and retrained every two years who are subject to the
- 27 supervision and approval by school nurses. After assessing the

1 health status of the individual student, a school nurse, in 2 collaboration with the student's physician, parents and, in some 3 instances, an individualized education program team, may delegate 4 certain health care procedures to a school employee who shall be 5 trained pursuant to this section, considered competent, have 6 consultation with, and be monitored or supervised by the school 7 nurse: Provided, That nothing in this section prohibits any school 8 employee from providing specialized health procedures or any other 9 prudent action to aid any person who is in acute physical distress 10 or requires emergency assistance. For the purposes of this section 11 "specialized health procedures" means, but is not limited to, 12 catheterization, suctioning of tracheostomy, naso-gastric tube "School employee" means 13 feeding or gastrostomy tube feeding. 14 "teachers" as defined in section one, article one of this chapter 15 and "aides" as defined in section eight, article four, chapter 16 eighteen-a of this code. Commencing with the school year beginning 17 on July 1, 2002, "school employee" also means "secretary I", 18 "secretary II" and "secretary III" as defined in section eight, 19 article four, chapter eighteen-a of this code: Provided, however, 20 That a "secretary I", "secretary II" and "secretary III" shall be 21 is limited to the dispensing of medications.

(e) Any school service employee who elects, or is required by this section, to undergo training or retraining to provide, in the manner specified in this section, the specialized health care procedures for those students for which the selection has been approved by both the principal and the county board shall receive additional pay of at least one pay grade higher than the highest

1 pay grade for which the employee is paid: Provided, That any 2 training required in this section may be considered in lieu of 3 required in-service training of the school employee and a school 4 employee may not be required to elect to undergo the training or 5 retraining: Provided, however, That commencing with July 1, 1989, 6 any newly employed school employee in the field of special 7 education is required to undergo the training and retraining as 8 provided in this section: Provided further, That if an employee 9 who holds a class title of an aide is employed in a school and the 10 aide has received the training, pursuant to this section, then an 11 employee in the field of special education is not required to 12 perform the specialized health care procedures.

- (f) Each county school nurse, as designated and defined by this section, shall perform a needs assessment. These nurses shall meet on the basis of the area served by their regional educational service agency, prepare recommendations and elect a representative to serve on the council of school nurses established under this section.
- (g) There shall be a Council of School Nurses which shall be convened by the State Board of Education. This council shall prepare a procedural manual and shall provide recommendations regarding a training course to the Commissioner of the Bureau for Public Health who shall consult with the State Department of Education. The state board then has the authority to promulgate a rule in accordance with the provisions of article three-b, chapter twenty-nine-a of this code to implement the training and to create standards used by those school nurses and school employees

- 1 performing specialized health procedures. The council shall meet
- 2 every two years to review the certification and training program
- 3 regarding school employees.
- 4 (h) The State Board of Education shall work in conjunction
- 5 with county boards to provide training and retraining every two
- 6 years as recommended by the Council of School Nurses and
- 7 implemented by the rule promulgated by the state board.

NOTE: The purpose of this bill is to require every county board of education to employ a nurse in each public school in the county.
