  6 at least one member of the council must be a veteran of the Korean
  7 Conflict, at least two members of the council must be veterans of
  8 the Vietnam era, at least one member must be a veteran of the first
  9 Gulf War and at least one member must be a veteran of the
  10 Afghanistan or Iraqi Conflicts. The members of the veterans'
  11 council must be selected with special reference to their ability
  12 and fitness to effectuate the purposes of this article.
- A director secretary and such veterans' affairs officers,

  15 advisable, shall administer the West Virginia division of veterans'

  20 secretary; honoring academic achievement at military

- 22 (a) It is the duty and function of the Veterans' Council to 23 advise the director secretary on the general administrative

- 1 policies of the division department, to select, at their first 2 meeting in each fiscal year commencing on July 1, a chairman 3 chairperson to serve one year, to advise the director secretary on 4 rules as may be necessary, to advise the Governor and the 5 Legislature with respect to legislation affecting the interests of 6 veterans, their widows, dependents and orphans and to make annual 7 reports to the Governor respecting the service of the division 8 department. The director secretary has the same eligibility and 9 qualifications prescribed for members of the Veterans' Council. 10 <del>The Governor shall appoint a director for a term of six years, by</del> 11 and with the advice and consent of the Senate. Before making the 12 appointment appointing the secretary the Governor shall request the 13 council of the West Virginia division of veterans' affairs to 14 furnish a full and complete report concerning the qualifications 15 and suitability of the proposed appointee. The director may only 16 be removed by the Governor for cause, but shall have upon his or 17 her own request an open hearing before the Governor on the 18 complaints or charges lodged against him or her. The action of the 19 Governor shall be final. The director secretary ex officio shall 20 be is the executive secretary of the Veterans' Council, shall keep 21 the minutes of each meeting and be in charge of all records of the 22 division department.
- 23 (b) The Veterans' Council may annually honor each West

- 1 Virginian graduating from the U.S. Military Academy, the U.S. Naval
- 2 Academy, the U.S. Air Force Academy and the U.S. Coast Guard
- 3 Academy with the highest grade point average by bestowing upon him
- 4 or her the "West Augusta Award." The award shall be in a design
- 5 and form established by the council and include the famous
- 6 Revolutionary War phrase from which the award's name is derived:
- 7 "Once again our brethren from West Augusta have answered the call
- 8 to duty." The council shall coordinate the manner of recognition
- 9 of the recipient at graduation ceremonies with each academy.

NOTE: The purpose of this bill is to redesignate the Division of Veterans' Affairs to the Department of Veteran's Assistance and to provide that the department be supervised by a secretary level administrator.
