- 19 (d) The secretary may delegate his or her powers and duties to
- 20 assistants and employees, but the secretary is responsible for all
- 21 official acts of the department.

## 22 §9A-1-1c. Reports by secretary.

- The secretary shall report annually to the Governor concerning
- 24 the conduct of the department and make other reports as the

- 1 Governor may require.
- 2 §9A-1-1d. Right of appeal from interference with functioning of
- 3 agency.
- 4 Any governmental entity may appeal to the Governor for review
- 5 upon a showing that application of the secretary's authority may
- 6 interfere with the successful functioning of that entity. The
- 7 Governor's decision controls on appeal.
- 8 §9A-1-2. Veterans' Council; administration of department.
- 9 There is continued the "Veterans' Council" consisting of nine
- 10 members who must be citizens and residents of this state and who
- 11 have served in and been honorably discharged or separated under
- 12 honorable conditions from the Armed Forces of the United States and
- 13 whose service was within a time of war as defined by the laws of
- 14 the United States, either Public Law No. 2 -- 73rd Congress, or
- 15 Public Law No. 346 -- 78th Congress, and amendments thereto.
- 16 Where feasible, two members of the council shall be veterans of
- 17 either World War II or the Korean Conflict, at least two members of
- 18 the council shall be veterans of the Vietnam era, at least one
- 19 member shall be a veteran of the first Gulf War and at least one
- 20 member shall be a veteran of the Afghanistan or Iraqi Conflicts.
- 21 The members of the veterans' council shall be selected with special
- 22 reference to their ability and fitness to effectuate the purposes
- 23 of this article. If an eligible veteran is not available or cannot
- 24 be selected, a veteran who is a citizen and resident of this state,

- 1 who served in and was honorably discharged or separated under
- 2 honorable conditions from the Armed Forces of the United States and
- 3 who served during any time of war or peace may be selected.
- A secretary and such veterans' affairs officers, assistants
- 5 and employees as the secretary considers advisable, shall
- 6 administer the West Virginia Department of Veterans' Assistance.
- 7 §9A-1-4. Duties and functions of Veterans' Council; appointment of
- 8 secretary; honoring academic achievement at military
- 9 academies.
- 10 (a) It is the duty and function of the Veterans' Council to
- 11 advise the secretary on the general administrative policies of the
- 12 department, to select, at their first meeting in each fiscal year
- 13 commencing on July 1, a chairperson to serve one year, to advise
- 14 the secretary on rules as may be necessary, to advise the Governor
- 15 and the Legislature with respect to legislation affecting the
- 16 interests of veterans, their widows, dependents and orphans and to
- 17 make annual reports to the Governor respecting the service of the
- 18 department. The secretary has the same eligibility and
- 19 qualifications prescribed for members of the Veterans' Council.
- 20 The secretary ex officio shall maintain all records of the
- 21 Veterans' Council.
- 22 (b) The Veterans' Council may annually honor each West
- 23 Virginian graduating from the U.S. Military Academy, the U.S.
- 24 Naval Academy, the U.S. Air Force Academy and the U.S. Coast

- 1 Guard Academy with the highest grade point average by bestowing
- 2 upon him or her the "West Augusta Award." The award shall be in a
- 3 design and form established by the council and include the famous
- 4 Revolutionary War phrase from which the award's name is derived:
- 5 "Once again our brethren from West Augusta have answered the call
- 6 to duty." The council shall coordinate the manner of recognition of
- 7 the recipient at graduation ceremonies with each academy.
