9 AN ACT making a supplementary appropriation of public moneys out of  
10 the Treasury from the balance of moneys remaining as an  
11 unappropriated surplus balance in the State Fund, General  
12 Revenue, to the Governor's Office - Civil Contingent Fund,  
13 fund 0105, fiscal year 2011, organization 0100, by  
14 supplementing and amending the appropriations for the fiscal  
15 year ending June 30, 2011.

16 WHEREAS, The Governor submitted to the Legislature the  
17 Executive Budget document, dated January 12, 2011, which included  
18 a statement of the State Fund, General Revenue, setting forth  
19 therein the cash balance as of July 1, 2010; and further included  
20 the estimate of revenues for the fiscal year 2011, less net  
21 appropriation balances forwarded and regular appropriations for  
22 fiscal year 2011; and

23 WHEREAS, It appears from the Governor's Executive Budget  
24 document, statement of the State Fund, General Revenue, there now

1 remains an unappropriated surplus balance in the State Treasury  
2 which is available for appropriation during the fiscal year ending  
3 June 30, 2011; therefore

4 *Be it enacted by the Legislature of West Virginia:*

5 That the total appropriation for the fiscal year ending June  
6 30, 2011, to fund 0105, fiscal year 2011, organization 0100, be  
7 supplemented and amended by adding a new item of appropriation as  
8 follows:
