10	A BILL to amend and reenact $\$$ 50-1-3, $\$$ 50-1-8, $\$$ 50-1-9 and $\$$ 50-1-
11	9a, of the Code of West Virginia, 1931, as amended, all
12	relating to equally compensating all state magistrates,
13	magistrate assistants, magistrate court clerks and magistrate
14	court deputy clerks.
15	Be it enacted by the Legislature of West Virginia:
16	That $$50-1-3$, $$50-1-8$, $$50-1-9$ and $$50-1-9a$, of the Code of
17	West Virginia, 1931, as amended, be amended and reenacted, all to
18	read as follows:
19	ARTICLE 1. COURTS AND OFFICERS.
20	§50-1-3. Salaries of magistrates.
21	(a) The Legislature finds and declares that:
22	(1) The West Virginia Supreme Court of Appeals has held that
23	a salary system for magistrates which is based upon the population
24	that each magistrate serves does not violate the equal protection
25	clause of the Constitution of the United States;

- 1 (2) The West Virginia Supreme Court of Appeals has held that
- 2 a salary system for magistrates which is based upon the population
- 3 that each magistrate serves does not violate section thirty-nine,
- 4 article VI of the Constitution of West Virginia;

23 §50-1-8. Magistrate court clerks; salaries; duties; duties of

1 circuit clerk.

- 2 (a) In each county having three or more magistrates the judge
 3 of the circuit court or the chief judge of the circuit court, if
 4 there is more than one judge of the circuit court, shall appoint a
 5 magistrate court clerk. In all other counties the judge may
 6 appoint a magistrate court clerk or may by rule require the duties
 7 of the magistrate court clerk to be performed by the clerk of the
 8 circuit court, in which event the circuit court clerk is entitled
 9 to additional compensation in the amount of \$2,500 per year. The
 10 magistrate court clerk serves at the will and pleasure of the
 11 circuit judge.
- (b) Magistrate court clerks shall be paid a monthly salary by
 the state. Magistrate court clerks serving magistrates who serve
 less than eight thousand four hundred in population shall be paid
 up to \$26,436 per year and magistrate court clerks serving

 19 appointment of magistrate court deputy clerks, not to exceed
 20 seventy-two in number. The magistrate court deputy clerks shall be
 21 appointed by the judge of the circuit court, or the chief judge if
 22 there is more than one judge of the circuit court, to serve at his
 23 or her will and pleasure under the immediate supervision of the

- 2 (b) Magistrate court deputy clerks shall have the duties,
- 3 clerical or otherwise, as may be assigned by the magistrate court
- 4 clerk and as may be prescribed by the rules of the Supreme Court of

NOTE: This bill is requested by the Supreme Court of Appeals Administrative Office. The purpose of this bill is to provide that all magistrates, magistrate assistants, magistrate court clerks and deputy clerks be paid equally. This bill will eliminate the two-tier system. The 2010 Census notes a decrease in population for Lewis, McDowell, Wetzel and Wyoming Counties. If the Legislature fails to pass legislation equalizing the magistrate court system in regard to pay, the magistrate court personnel's salary in those four counties will be drastically reduced January 1, 2013, as directed by the West Virginia Code.
