10 AN ACT expiring funds to the unappropriated surplus balance in the  
11 State Fund, General Revenue, for the fiscal year ending June  
12 30, 2012, in the amount of \$212,859.85 from the Department of  
13 Military Affairs and Public Safety - Office of the Secretary,  
14 fund 0430, fiscal year 2006, organization 0601, activity 511,  
15 and making a supplementary appropriation of public moneys out  
16 of the Treasury from the balance of moneys remaining as an  
17 unappropriated surplus balance in the State Fund, General  
18 Revenue, to the Department of Military Affairs and Public  
19 Safety - Division of Corrections - Correctional Units, fund  
20 0450, fiscal year 2012, organization 0608, by supplementing  
21 and amending the appropriations for the fiscal year ending  
22 June 30, 2012.

23 WHEREAS, The Legislature finds that the account balance in the  
24 Department of Military Affairs and Public Safety - Office of the  
25 Secretary, fund 0430, fiscal year 2006, organization 0601, activity

1 511, exceeds that which is necessary for the purposes for which the  
2 account was established; and

3 WHEREAS, The Governor submitted to the Legislature the  
4 Executive Budget document, dated January 11, 2012, which included  
5 a statement of the State Fund, General Revenue, setting forth  
6 therein the cash balance as of July 1, 2011; and further included  
7 the estimate of revenues for the fiscal year 2012, less net  
8 appropriation balances forwarded and regular appropriations for  
9 fiscal year 2012; and

10 WHEREAS, It appears from the Governor's Executive Budget  
11 document, statement of the State Fund, General Revenue, and this  
12 legislation there now remains an unappropriated surplus balance in  
13 the State Treasury which is available for appropriation during the  
14 fiscal year ending June 30, 2012; therefore

15 *Be it enacted by the Legislature of West Virginia:*

16 That the balance of the funds available for expenditure in the  
17 fiscal year ending June 30, 2012, to the Department of Military  
18 Affairs and Public Safety - Office of the Secretary, fund 0430,  
19 fiscal year 2006, organization 0601, activity 511, be decreased by  
20 expiring the amount of \$212,859.85 to the unappropriated surplus  
21 balance of the State Fund, General Revenue, to be available for  
22 appropriation during the fiscal year 2012.

23 And, That the total appropriation for the fiscal year ending  
24 June 30, 2012, to fund 0450, fiscal year 2012, organization 0608,  
25 be supplemented and amended by increasing an existing item of

1 appropriation as follows:
