11	adding thereto a new section, designated §4-2-4a; and to amend
12	said code by adding thereto a new section, designated §30-1A-
13	2a, all relating to the Legislative Auditor; authorizing the
14	Legislative Auditor to establish and charge fees for the
15	sunrise application review process; reporting requirements;
16	and terminating these fees on July 1, 2015.
17	Be it enacted by the Legislature of West Virginia:
18	That the Code of West Virginia, 1931, as amended, be amended
19	by adding thereto two new section designated $$4-2-4a$$ and $$30-1A-2a$,
20	all to read as follows:
21	CHAPTER 4. THE LEGISLATURE.
22	ARTICLE 2. LEGISLATIVE AUDITOR; POWERS; FUNCTIONS; DUTIES;
23	COMPENSATION.
24	§4-2-4a. Authorizing Auditor to establish and charge fees for the
25	sunrise application review process.
26	(a) The Legislative Auditor may establish a graduated fee
27	schedule related to the actual cost for the review of a sunrise

- 1 application, under the provisions of article one-a, chapter thirty 2 of this code.
- 3 (b) The Legislative Auditor may collect, and the professional 4 or occupational group or organization, an individual or board shall 5 pay, the fee established by the Legislative Auditor for the review 6 of a sunrise application.
- 7 (c) The Legislative Auditor shall render to the professional 8 or occupational group or organization, individual or board liable 9 for the fee a statement of the fee as soon as practicable after the 10 costs were incurred. It is the duty of the professional or 11 occupational group or organization, an individual or board to 12 promptly pay in the manner that other claims and accounts are paid.
- 13 (d) The money received by the Legislative Auditor from this
 14 source shall be expended only for the purpose of covering the costs
 15 associated with the review of a sunrise application, unless
 16 otherwise directed by the Legislature.
- 17 (e) The Legislative Auditor shall report annually by January 18 1 to the Joint Committee on Government Organization the following:
- 19 (1) The fees charged for the review of sunrise applications;
- 20 (2) The professional or occupational group or organization,
- 21 individual or board liable for the fee;
- 22 (3) Whether the fees were paid promptly; and
- 23 (4) Any other information required by the Joint Committee on 24 Government Organization.
- 25 (f) The provisions of this section terminate on July 1, 2015.

- 2 (a) The Legislative Auditor may collect, and the professional 3 or occupational group or organization, an individual or board shall

- 5 of a sunrise application, established under the provisions of
- 6 section four-a, article two, chapter four of this code.
- 7 (b) The provisions of this section terminate on July 1, 2015.
