- 20 §36B-1-103. Definitions.
- 21 In the declaration and bylaws (section one hundred six,
- 22 article three of this chapter), unless specifically provided
- 23 otherwise or the context otherwise requires, and in this chapter:

1 In this chapter:

(1) "Affiliate of a declarant" means any person who controls, 3 is controlled by, or is under common control with a declarant. For 4 purposes of this definition: A person "controls" a declarant if (i) Is a general partner, officer, director or 5 the person: 6 employer of the declarant; (ii) directly or indirectly or acting in 7 concert with one or more other persons, or through one or more 8 subsidiaries, owns, controls, holds with power to vote, or holds 9 proxies representing, more than twenty percent of the voting 10 interest in the declarant; (iii) controls in any manner the 11 election of a majority of the directors of the declarant; or (iv) 12 has contributed more than twenty percent of the capital of the 13 declarant. A person "is controlled by" a declarant if the 14 declarant: (i) Is a general partner, officer, director or employer 15 of the person; (ii) directly or indirectly or acting in concert 16 with one or more other persons, or through one or more 17 subsidiaries, owns, controls, holds with power to vote, or holds 18 proxies representing, more than twenty percent of the voting 19 interest in the person; (iii) controls in any manner the election 20 of a majority of the directors of the person; or (iv) has 21 contributed more than twenty percent of the capital of the person. 22 Control does not exist if the powers described in this paragraph 23 are held solely as security for an obligation and are not

- 1 exercised.
- 2 (2) "Allocated interests" means the following interests
- 3 allocated to each unit: (i) In a condominium, the undivided
- 4 interest in the common elements, the common expense liability, and
- 5 votes in the association; (ii) in a cooperative, the common expense
- 6 liability and the ownership interest and votes in the association;
- 7 and (iii) in a planned community, the common expense liability and
- 8 votes in the association.
- 9 (3) "Assessment" means the sum attribute to each unit and due
- 10 to the association pursuant to section one hundred-fifteen, article
- 11 three of this chapter.
- 12 (3) (4) "Association" or "unit owners' association" means the
- 13 unit owners' association organized under section one hundred one,
- 14 article three of this chapter.
- 15 (5) "Bylaws" means instruments, however denominated, that
- 16 contain the procedures for conduct of the affairs of the
- 17 association regardless of the form in which the association is
- 18 organized, including any amendments to the instruments.
- 19 $\frac{(4)}{(6)}$ "Common elements" means: (i) In a condominium or
- 20 cooperative, all portions of the common interest community other
- 21 than the units; and (ii) in a planned community, any real estate
- 22 within a planned community owned or leased by the association,
- 23 other than a unit; and (iii) in all common interest communities,

- $\boldsymbol{1}$ any other interests in real estate for the benefit of unit owners
- 2 which are subject to te declaration.
- $\frac{(5)}{(7)}$ "Common expenses" means expenditures made by, or
- 4 financial liabilities of, the association, together with any
- 5 allocations to reserves.
- 6 (8) "Common expense liability" means the liability for
- 7 common expenses allocated to each unit pursuant to section one
- 8 hundred seven, article two of this chapter.
- 9 (7) (9) "Common interest community" means real estate
- 10 described to the declaration with respect to which a person, by
- 11 virtue of his or her ownership of a unit, is obligated to pay for
- 12 a share of real estate taxes, insurance premiums, maintenance, or
- 13 improvement of, or service or other expenses related to, common
- 14 <u>elements</u>, other units, or other real estate described in a the
- 15 declaration: Provided, That any resort owner which, prior to the
- 16 effective date of this article, began the development of a resort
- 17 and imposed fees or assessments upon owners of real estate in the
- 18 resort for maintenance and care of the roads, streets, alleys,
- 19 sidewalks, parks, common areas and common facilities in and around
- 20 the resort, for fire and police protection and for such other
- 21 services as may be made available to owners of real estate, may
- 22 also impose the same fees and assessments to be used for the same
- 23 or similar purposes upon persons purchasing real estate in the

- 1 resort after the effective date of this article without creating a
- 2 common interest community.
- 3 The term does not include an arrangement described in sections
- 4 two hundred-nine and two hundred-ten of this article. For purposes
- 5 of this paragraph, "Ownership of a unit" does not include holding
- 6 a leasehold interest of less than twenty years in a unit, including
- 7 renewal options.
- 8 (10) "Condominium" means a common interest community in
- 9 which portions of the real estate are designated for separate
- 10 ownership and the remainder of the real estate is designated for
- 11 common ownership solely by the owners of those portions. A common
- 12 interest community is not a condominium unless the undivided
- 13 interest in the common elements are vested in the unit owners.
- 14 $\frac{(9)}{(11)}$ "Conversion building" means a building that at any
- 15 time before creation of the common interest community was occupied
- 16 wholly or partially by persons other than purchasers and persons
- 17 who occupy with the consent of purchasers.
- 18 (10) (12) "Cooperative" means a common interest community in
- 19 which the real estate is owned by an association, each of whose
- 20 members is entitled by virtue of his or her ownership interest in
- 21 the association to exclusive possession of a unit.
- (11) (13) "Dealer" means a person in the business of selling
- 23 units for his or her own account.

- 1 (12) (14) "Declarant" means any person or group of persons
- 2 acting in concert who: (i) As part of a common promotional plan,
- 3 offers to dispose of his or the interest of the person or group of
- 4 persons in a unit not previously disposed of; or (ii) reserves or
- 5 succeeds to any special declarant right.
- 6 (13) (15) "Declaration" means any the instruments, however
- 7 denominated, that create a common interest community, including any
- 8 amendments to those the instruments.
- 9 (14) (16) "Development rights" means any right or combination
- 10 of rights reserved by a declarant in the declaration to: (i) Add
- 11 real estate to a common interest community; (ii) create units,
- 12 common elements or limited common elements within a common interest
- 13 community; (iii) subdivide units or convert units into common
- 14 elements; or (iv) withdraw real estate from a common interest
- 15 community.
- 16 (17) "Dispose" or "disposition" means a voluntary
- 17 transfer to a purchaser of any legal or equitable interest in a
- 18 unit, but the term does not include the transfer or release of a
- 19 security interest.
- 20 (18) "Executive board" means the body, regardless of name,
- 21 designated in the declaration or bylaws to act on behalf of the
- 22 association.
- (17) (19) "Identifying number" means a symbol or address that

- 1 identifies only one unit in a common interest community.
- 2 (18) (20) "Leasehold common interest community" means a common
- 3 interest community in which all or a portion of the real estate is
- 4 subject to a lease, the expiration or termination of which will
- 5 terminate the common interest community or reduce its size.
- 6 $\frac{(19)}{(21)}$ "Limited common element" means a portion of the
- 7 common elements allocated by the declaration or by operation of
- 8 subdivision (2) or (4), section one hundred two, article two of
- 9 this chapter for the exclusive use of one or more but fewer than
- 10 all of the units.
- 11 (20) (22) "Master association" means an organization described
- 12 in section one hundred twenty, article two of this chapter, whether
- 13 or not it is also an association described in section one hundred
- 14 one, article three of this chapter.
- 15 (21) (23) "Offering" means any advertisement, inducement,
- 16 solicitation or attempt to encourage any person to acquire any
- 17 interest in a unit, other than as security for an obligation. An
- 18 advertisement in a newspaper or other periodical of general
- 19 circulation, or in any broadcast medium to the general public, of
- 20 a common interest community not located in this state, is not an
- 21 offering if the advertisement states that an offering may be made
- 22 only in compliance with the law of the jurisdiction in which the
- 23 common interest community is located.

- 1 (22) (24) "Person" means an individual, corporation, business
- 2 trust, estate, trust, partnership, <u>limited liability company</u>,
- 3 association, joint venture, public corporation, government,
- 4 governmental subdivision, or agency, or instrumentality, or any
- 5 other legal or commercial entity. In the case of a land trust, the
- 6 corpus of which is real estate, however, "person" the term means
- 7 the beneficiary of the trust rather than the trust or the trustee.
- 8 (23) (25) "Planned community" means a common interest
- 9 community that is not a condominium or a cooperative. A
- 10 condominium or cooperative may be part of a planned community.
- 11 (24) (26) "Proprietary lease" means an agreement with the
- 12 association pursuant to which a member is entitled to exclusive
- 13 possession of a unit in a cooperative.
- $\frac{(25)}{(27)}$ "Purchaser" means a person, other than a declarant
- 15 or a dealer, who that by means of a voluntary transfer acquires a
- 16 legal or equitable interest in a unit other than: (i) A leasehold
- 17 interest (including renewal options) of less than twenty years; or
- 18 (ii) as security for an obligation.
- 19 (26) (28) "Real estate" means any leasehold or other estate or
- 20 interest in, over, or under land, including structures, fixtures
- 21 and other improvements and interest that by custom, usage or law
- 22 pass with a conveyance of land though not described in the contract
- 23 of sale or instrument of conveyance. "Real estate" The term

- 1 includes parcels with or without upper or lower boundaries, and
- 2 spaces that may be filled with air or water.
- 3 (29) "Record" means information that is inscribed on a
- 4 tangible medium or that is stored in an electronic or other medium
- 5 and is retrievable in perceivable form.
- 6 (27) (30) "Residential purposes" means use for dwelling or
- 7 recreational purposes, or both.
- 8 (31) "Rule" means a policy, guideline, restriction, procedure,
- 9 or regulation of an association, however dominated, which is not
- 10 set forth in the declaration or bylaws and which governs the
- 11 conduct of persons or the use or appearance of property.
- 12 (32) "Resort" means a destination location which consists
- 13 of: (i) One or more persons offering recreational facilities and
- 14 services such as skiing, golf, tennis or boating to the general
- 15 public and commercial facilities such as retail stores, restaurants
- 16 and hotels or other lodging accommodations; and (ii) at least one
- 17 hundred residential units, a majority of which are used as vacation
- 18 or second homes rather than primary residences.
- (29) (33) "Resort owner" means any person owning or operating
- 20 substantially all of the recreational facilities located within a
- 21 resort, or the predecessor in title of any such person.
- 22 (30) (34) "Security interest" means an interest in real estate
- 23 or personal property, created by contract or conveyance, which

1 secures payment or performance of an obligation. The term includes
2 a lien created by a mortgage, deed of trust, trust deed, security
3 deed, contract for deed, land sales contract, lease intended as
4 security, assignment of lease or rents intended as security, pledge
5 of an ownership interest in an association, and any other
6 consensual lien or title retention contract intended as security
7 for an obligation.

(31) (35) "Special declarant rights" means rights reserved for 9 the benefit of a declarant to: (i) Complete improvements indicated 10 on plans and plans filed with the declaration (section one hundred 11 nine, article two of this chapter) or, in a cooperative, to 12 complete improvements described in the public offering statement 13 pursuant to subdivision (2), subsection (a), section one hundred 14 three, article four of this chapter; (ii) exercise any development 15 right (section one hundred ten, article two of this chapter); (iii) 16 maintain sales offices, management offices, signs advertising the 17 common interest community, and models (section one hundred fifteen, 18 article two of this chapter); (iv) use easements through the common 19 elements for the purpose of making improvements within the common 20 interest community or within real estate which may be added to the 21 common interest community (section one hundred sixteen, article two 22 of this chapter); (v) make the common interest community subject to 23 a master association (section one hundred twenty, article two of

1 this chapter); (vi) merge or consolidate a common interest 2 community with another common interest community of the same form 3 of ownership (section one hundred twenty-one, article two of this 4 chapter); or (vii) appoint or remove any officer of the association 5 or any master association or any executive board member during any 6 period of declarant control (subsection (d), section one hundred 7 three, article three of this chapter); (viii) control any 8 construction, design review, or aesthetic standards committee or 9 process; (ix) attend meetings of the unit owners and, except during 10 an executive session, the executive board; or (x) have access to 11 the records of the association to the same extent as a unit owner. (36) "Time share" means a right to occupy a unit or any 12 13 of several units during five or more separated time periods over a 14 period of at least five years, including renewal options, whether 15 or not coupled with an estate or interest in a common interest 16 community or a specified portion thereof. 17 (33) (37) "Unit" means a physical portion of the common 18 interest community designated for separate ownership or occupancy,

20 subsection (a), section one hundred five, article two of this 21 chapter. If a unit in a cooperative is owned by a unit owner or is 22 sold, conveyed, voluntarily or involuntarily encumbered or 23 otherwise transferred by a unit owner, the interest in that unit

19 the boundaries of which are described pursuant to subdivision (5),

- 1 which is owned, sold, conveyed, encumbered, or otherwise
- 2 transferred is the right to possession of that unit under a
- 3 proprietary lease, coupled with the allocated interests of that
- 4 unit, and the association's interest in that unit is not thereby
- 5 affected.
- 6 $\frac{(34)}{(38)}$ "Unit owner" means a declarant or other person who
- 7 that owns a unit, or a lessee of a unit in a leasehold common

- 10 from the common interest community, but does not include a person
- 11 having an interest in a unit solely as security for an obligation.

- 22 If any provision of this chapter or the application thereof to

- 1 any person or circumstances is held invalid, the invalidity does
- 2 not affect other provisions or applications of this chapter which
- 3 can be given effect without the invalid provisions or applications,
- 4 and to this end the provisions of this chapter are severable.
- 5 §36B-1-201. Applicability to new common interest communities.
- 6 Except as otherwise provided in sections 1-202 and 1-203, this
- 7 chapter applies to all common interest communities created within
- 8 this state after the effective date of this chapter. The provisions
- 9 of chapter fifty-three, acts of the Legislature, 1963, chapter one
- 10 hundred twenty-nine, acts of the Legislature, 1980, and chapter
- 11 thirty-eight, acts of the Legislature, 1984, do not apply to common

- 1 common expense liability of all units restricted to residential
- 2 purposes, exclusive of optional user fees and any insurance
- 3 premiums paid by the association, may not exceed \$300 as adjusted

- 23 (a) Except as provided in section 1-205, Same; exception for

1 small preexisting cooperatives and planned communities, sections 2 1-105 (separate titles and taxation), 1-106 (Applicability of local 3 ordinances, regulations and building codes), 1-107 (Eminent 4 domain), 2-103 (Construction and validity of declaration and 5 bylaws), 2-104 (Description of units), 2-121 (Merger or 6 consolidation of common interest communities), 3-102(a)(1) through 7 (6) and (11) through (16) (Powers of unit owners' association), 8 3-111 (Tort and contract liability), 3-116 (Lien for assessments), 9 3-118 (Association records), 4-109 (Resales of units), and 4-117 10 (Effect of violation on rights of action; attorney's fees), and 11 section 1-103 (Definitions) to the extent necessary in construing 12 any of those sections, apply to all common interest communities 13 created in this state before the effective date of this chapter; 14 but those sections apply only with respect to events and 15 circumstances occurring after the effective date of this chapter 16 and do not invalidate existing provisions of the declaration, 17 bylaws or plats or plans of those common interest communities. 18 Except for a cooperative or planned community described in section 19 1-205 (Same-Exception for small preexisting cooperatives and 20 planned communities), or a nonresidential common interest community 21 described in section 1-207, (Same; Exception for Small Preexisting 22 Cooperatives and Planned Communities), the following apply to a 23 common interest community created in this state before the

- 9 (b) (c) The provisions of chapter one hundred fifty-three,
 10 Acts of the Legislature, 1063, chapter one hundred twenty-nine,
 11 Acts of the Legislature, 1980, or of chapter thirty-eight, Acts of
- 12 the Legislature, 1984, do not apply to condominiums or other common
- 13 interest communities created after the effective date of this

- 15 rules, bylaws, plats and plans and code of regulations of any
- 16 condominium or common interest community created before the

- 19 the procedures and requirements specified by those instruments and
- 20 by chapter one hundred fifty-three, Acts of the Legislature, 1963.
- 21 If the amendment grants to any person any rights, powers or
- 22 privileges permitted by this chapter, all correlative obligations,
- 23 liabilities and restrictions in this chapter also apply to that

- 1 person.
- 2 (c) (d) This chapter does not apply to condominiums or units
- 3 located outside this state, but the public offering statement
- 4 provisions, (sections 4-102 through 4-109) apply to all contracts
- 5 for the disposition thereof signed in this state by any party
- 6 unless exempt under section 4-101(b).
- 7 (d) (e) The provisions of this chapter shall apply to all
- 8 condominiums or common interest communities to the extent such
- 9 provisions conflict or are inconsistent with the provisions of
- 10 chapter one hundred fifty-three, Acts of the Legislature, 1963:
- 11 Provided, That the provisions of this chapter shall not modify,
- 12 limit or nullify any rights, duties or obligations created or
- 13 existing under any declaration, bylaws or plats or plans of
- 14 condominiums created in this state before the effective date of
- 15 this chapter.

16 §36B-1-208. Other Exemption Real Estates Arrangements.

- 17 (a) An arrangement between the associations for two or more
- 18 common interest communities to share the costs of real estate
- 19 taxes, insurance premiums, services, maintenance or improvements of
- 20 real estate, or other activities specified in their arrangement or
- 21 declarations does not create a separate common interest community.
- 22 (b) An arrangement between an association and the owner of
- 23 real estate that is not part of a common interest community to

- 1 share the costs of real estate taxes, insurance premiums, services,
- 2 maintenance or improvements of real estate, or other activities
- 3 specified in their arrangement or declarations does not create a
- 4 separate common interest community. However, assessments against
- 5 the units in the common interest community required by the
- 6 arrangement must be included in the periodic budget for the common
- 7 interest community and the arrangement must be disclosed in all
- 8 public offering statements and resale certificates required by this
- 9 chapter.
- 10 ARTICLE 2. CREATION, ALTERATION AND TERMINATION OF COMMON
- 11 INTEREST COMMUNITIES.
- 12 **§36B-2-109**. Plats and plans.
- 13 (a) Plats and plans are a part of the declaration and are
- 14 required for all common interest communities except cooperatives.
- 15 Separate plats and plans are not required by this chapter if all
- 16 the information required by this section is contained in either a
- 17 plat or plan. Each plat and plan must be clear and legible and
- 18 contain a certification that the plat or plan contains all
- 19 information required by this section.
- 20 (b) Each plat must show:
- 21 (1) The name and a survey or general schematic map of the
- 22 entire common interest community;
- 23 (2) The location and dimensions of all real estate not subject

- 1 to development rights or subject only to the development right to
- 2 withdraw and the location and dimensions of all existing
- 3 improvements within that real estate;
- 4 (3) A legally sufficient description of any real estate
- 5 subject to development rights, labeled to identify the rights
- 6 applicable to each parcel;
- 7 (4) The extent of any encroachments by or upon any portion of
- 8 the common interest community;
- 9 (5) To the extent feasible, a legally sufficient description
- 10 of all easements serving or burdening any portion of the common
- 11 interest community;
- 12 (6) The location and dimensions of any vertical unit
- 13 boundaries not shown or projected on plans recorded pursuant to
- 14 subsection (d) and that unit's identifying number;
- 15 (7) The location with reference to an established datum of any
- 16 horizontal unit boundaries not shown or projected on plans recorded
- 17 pursuant to subsection (d) and that unit's identifying number;
- 18 (8) A legally sufficient description of any real estate in
- 19 which the unit owners will own only an estate for years, labeled as
- 20 "leasehold real estate";
- 21 (9) The distance between noncontiquous parcels of real estate
- 22 comprising the common interest community;
- 23 (10) The location and dimensions of limited common elements,

- 1 including porches, balconies and patios, other than parking spaces
- 2 and the other limited common elements described in sections
- 3 2-102(2) and (4); and
- 4 (11) In the case of real estate not subject to development
- 5 rights, all other matters customarily shown on land surveys.
- 6 (c) A plat may also show the intended location and dimensions
- 7 of any contemplated improvement to be constructed anywhere within
- 8 the common interest community. Any contemplated improvement shown
- 9 must be labeled either "MUST BE BUILT" or "NEED NOT BE BUILT."
- 10 (d) To the extent not shown or projected on the plats, plans
- 11 of the units must show or project:
- 12 (1) The location and dimensions of the vertical boundaries of
- 13 each unit and that unit's identifying number;
- 14 (2) Any horizontal unit boundaries, with reference to an
- 15 established datum and that unit's identifying number; and
- 16 (3) Any units in which the declarant has reserved the right to
- 17 create additional units or common elements (section 2- 110(c)),
- 18 identified appropriately.
- 19 (e) Unless the declaration provides otherwise, the horizontal
- 20 boundaries of part of a unit located outside a building have the
- 21 same elevation as the horizontal boundaries of the inside part and
- 22 need not be depicted on the plats and plans.
- 23 (f) Upon exercising any development right, the declarant shall

- 1 record either new plats and plans necessary to conform to the
- 2 requirements of subsections (a), (b) and (d) or new certifications
- 3 of plats and plans previously recorded if those plats and plans
- 4 otherwise conform to the requirements of those subsections.
- 5 (g) Any certification of a plat or plan required by this
- 6 section or section 2-101(b) must be made by an independent
- 7 (registered) surveyor, architect or engineer.
- 8 (h) Plats and plans need not show the location and dimensions
- 9 of the units' boundaries or their limited common elements if:
- 10 (1) The plat shows the location and dimensions of all
- 11 buildings containing or comprising the units; and
- 12 (2) The declaration includes other information that shows or
- 13 contains a narrative description of the general layout of the units
- 14 in those buildings and the limited common elements allocated to
- 15 those units.
- 16 §36B-2-112. Relocation of boundaries between adjoining units.
- 17 (a) Subject to the provisions of the declaration and other
- 18 provisions of law, the boundaries between adjoining units may be
- 19 relocated by an amendment to the declaration upon application to
- 20 the association by the owners of those units. If the owners of the
- 21 adjoining units have specified a reallocation between their units
- 22 of their allocated interests, the application must state the
- 23 proposed reallocations. Unless the executive board determines,

1 within thirty days, that the reallocations are unreasonable, the 2 association shall prepare an amendment that identifies the units 3 involved and states the reallocations. The amendment must be 4 executed by those unit owners, contain words of conveyance between 5 them, and, on recordation, be indexed in the name of the grantor 6 and the grantee, and in the grantee's index in the name of the 7 association.

8 (b) Subject to the provisions of the declaration and other 9 provisions of law, boundaries between units and common elements may 10 be relocated to incorporate common elements within a unit by an 11 amendment to the declaration upon application to the association by 12 the owner of the unit who proposes to relocate a boundary. Unless 13 the declaration provides otherwise, the amendment may be approved 14 only if persons entitled to cast at least sixty-seven percent of 15 the votes in the association, including sixty-seven percent of the 16 votes allocated to units not owned by the declarant, agree to the 17 action. The amendment may describe any fees or charges payable by 18 the owner of the affected unit in connection with the boundary 19 relocation and the fees and charges are assets of the association. 20 The amendment must be executed by the unit owner of the unit whose 21 boundary is being relocated and by the association, contain words 22 of conveyance between them, and on recordation be indexed in the 23 name of the unit owner and the association as grantor or grantee,

1 <u>as appropriate.</u>

(b) (c) The association (i) in a condominium or planned community shall prepare and record plats or plans necessary to show the altered boundaries between adjoining units and their dimensions and identifying numbers, and (ii) in a cooperative shall prepare and record amendments to the declaration, including any plans, necessary to show or describe the altered boundaries between

8 adjoining units and their dimensions and identifying numbers.

- 9 §36B-2-116. Easement rights.
- 10 (a) Subject to the provisions of the declaration, a declarant
 11 has an easement through the common elements as may be reasonably
 12 necessary for the purpose of discharging the declarant's
 13 obligations or exercising special declarant rights, whether arising
 14 under this chapter or reserved in the declaration.
- (b) In a planned community, subject Subject to the provisions

 of sections 3-102(a)(6) and 3-112, the unit owners have an easement

 in the common elements for purposes of access to their units.

 (ii) to use the common elements and all real estate that must

 become common elements (section 2-105(a)(6)) for all other

 purposes.
- 21 <u>(c) Subject to the declaration and rules, the unit owners have</u>
 22 <u>a right to use the common elements that are not limited common</u>
 23 elements and all real estate that must become common elements for

- 1 the purposes for which they were intended.
- 2 §36B-2-117. Amendment of declaration.
- (a) Except in cases of amendments that may be executed by a declarant under section 2-109(f) or 2-110, or by the association under section 1-107, 2-106(d), 2-108(c), 2-112(a), or 2-113, or by 6 certain unit owners under section 2-108(b), 2-112(a), 2-113(b), or 7 2-118(b), and except as limited by subsection subsections (d),(f), 8 (q) and (h), the declaration, including any plats and plans, may be 9 amended only by vote or agreement of unit owners of units to which 10 at least sixty-seven percent of the votes in the association are 11 allocated, or any larger majority unless the declaration specifies 12 a different percentage for all amendments or for specific subjects 13 of amendment. If the declaration requires the approval of another 14 person as a condition of effectiveness, the amendment is not valid 15 without that approval. The declaration may specify a smaller 16 number only if all of the units are restricted exclusively to 17 nonresidential use.
- 18 (b) No action to challenge the validity of an amendment 19 adopted by the association pursuant to this section may be brought 20 more than one year after the amendment is recorded.
- (c) Every amendment to the declaration must be recorded in 22 every county in which any portion of the common interest community 23 is located and is effective only upon recordation. An amendment,

- 1 except an amendment pursuant to section 2- 112(a), must be indexed
- 2 in the grantee's index in the name of the common interest community
- 3 and the association and in the grantor's index in the name of the
- 4 parties executing the amendment.
- 5 (d) Except to the extent expressly permitted or required by
- 6 other provisions of this chapter, no amendment may create or
- 7 increase special declarant rights, increase the number of units,
- 8 change the boundaries of any unit, the allocated interests of a
- 9 unit, or the uses to which any unit is restricted, in the absence
- 10 of unanimous consent of the unit owners.
- 11 (e) Amendments to the declaration required by this chapter to
- 12 be recorded by the association must be prepared, executed,
- 13 recorded, and certified on behalf of the association by any officer
- 14 of the association designated for that purpose or, in the absence
- 15 of designation, by the president of the association.
- 16 (f) An amendment to the declaration may prohibit or materially
- 17 restrict the permitted uses of or behavior in a unit or the number
- 18 or other qualifications of persons who may occupy units only by
- 19 vote or agreement of unit owners of units to which at least eighty
- 20 percent of the votes in the association are allocated, unless the
- 21 declaration specifies that a larger percentage of unit owners must
- 22 vote or agree to that amendment or that such an amendment may be
- 23 approved by unit owners of units having at least eighty percent of

- 1 the votes of a specified group of units that would be affected by
- 2 the amendment. An amendment approved under this subsection must
- 3 provide reasonable protection for a use or occupancy permitted at
- 4 the time the amendment was adopted.
- 5 (g) The time limits specified in the declaration pursuant to
- 6 section 2-105(a)(8) (Contents of the Declaration) within which
- 7 reserved development rights must be exercised may be extended, and
- 8 additional development rights may be created, if persons entitled
- 9 to cast at least eighty percent of the votes in the association,
- 10 including eighty percent of the votes allocated to units not owned
- 11 by the declarant, agree to that action. The agreement is effective
- 12 thirty days after an amendment to the declaration reflecting the
- 13 terms of the agreement is recorded unless all the persons holding
- 14 the affected special declarant rights, or security interests in
- 15 those rights, record a written objection within the thirty-day
- 16 period, in which case the amendment is void, or consent in writing
- 17 at the time the amendment is recorded, in which case, the amendment
- 18 is effective when recorded.
- 19 (h) A provision in the declaration creating special declarant
- 20 rights that have not expired may not be amended without the consent
- 21 of the declarant.
- 22 (i) If any provision of this chapter, law, or of the
- 23 declaration requires the consent of a holder of a security interest

1 in a unit as a condition to the effectiveness of an amendment to 2 the declaration, that consent is deemed granted if a refusal to 3 consent in a record is not received by the association within sixty 4 days after the association delivers notice of the proposed 5 amendment to the holder at an address for notice provided by the 6 holder or mails the notice to the holder by certified mail, return 7 receipt requested, at that address. If the holder has not provided 8 to the association an address for notice, the association shall 9 provide notice to the address in the security interest of record. 10 Notwithstanding this section, an amendment to the declaration that 11 affects the priority of a holder's security interest or the ability 12 of that holder to foreclose its security interest may not be 13 adopted without that holder's consent in a record if the 14 declaration requires that consent as a condition to the 15 effectiveness of the amendment: Provided, That this subsection 16 (i) shall not apply to amendments which: (A) Permit a unit 17 previously restricted to residential occupancy to be utilized for 18 nonresidential purposes; (B) increases the share of common expenses 19 <u>allocated to the unit in a manner disproportionate to the formula</u> 20 stated in the declaration pursuant to section one hundred eighteen 21 of this article; (C) terminates the common interest community 22 pursuant to section one hundred eighteen of this article; (D) 23 transfers from the association to the unit, the duty to maintain

- 1 and common element or limited common element previously performed
- 2 by the association; or (E) the unit owner is contractually
- 3 precluded from consenting to by the terms of a planned unit
- 4 development rider in a recorded security instrument.
- 5 (j) If the declaration contains a provision requiring that
- 6 amendments to the declaration may be adopted only by vote or
- 7 agreement of unit owners of units to which more than eighty percent
- 8 of the votes in the association are allocated, the amendment is
- 9 approved:
- 10 (1) If:
- 11 (A) Unit owners of units to which at least eighty percent of
- 12 the votes in the association are allocated vote for or agree to the
- 13 proposed amendment;
- 14 (B) No unit owner votes against the proposed amendment; and
- 15 (C) Notice of the proposed amendment is delivered to the unit
- 16 owners holding the votes in the association which have not voted or
- 17 agreed to the proposed amendment and no written objection to the
- 18 proposed amendment is received by the association within sixty days
- 19 after the association delivers notice; or
- 20 (2) Unit owners of units to which at least eighty percent of
- 21 the votes in the association are allocated vote for or agree to the
- 22 proposed amendment but at least one unit owner objects to the
- 23 proposed amendment and, pursuant to an action brought by the

- 1 association in a the circuit court of the county in which the
- 2 common interest community is situate against all objecting unit
- 3 owners, the court finds that the objecting unit owners do not have
- 4 an interest, different in kind from the interests of the other unit
- 5 owners, that the voting requirement of the declaration was intended
- 6 to protect.
- 7 §36B-2-119. Rights of secured lenders.
- 8 (a) The declaration may require that all or a specified number
- 9 or percentage of the lenders who hold security interests
- 10 encumbering the units or who have extended credit to the
- 11 association approve specified actions of the unit owners or the
- 12 association as a condition to the effectiveness of those actions,
- 13 but no requirement for approval may operate to: (i) Deny or
- 14 delegate control over the general administrative affairs of the
- 15 association by the unit owners or the executive board, or (ii)
- 16 prevent the association or the executive board from commencing,
- 17 intervening in, or settling any litigation or proceeding, or (iii)
- 18 prevent any insurance trustee or the association from receiving and
- 19 distributing any insurance proceeds except pursuant to section
- 20 3-113.
- 21 (b) A lender who has extended credit to an association secured
- 22 by an assignment of income (section 3-102(14)) or an encumbrance on
- 23 the common elements (section 3-112) may enforce its security

- 1 agreement in accordance with its terms, subject to the requirements
- 2 of this chapter and other law. Requirements that the association
- 3 must deposit its periodic common charges before default with the
- 4 lender to which the association's income has been assigned, or
- 5 increase its common charges at the lender's direction by amounts
- 6 reasonably necessary to amortize the loan in accordance with its
- 7 terms, do not violate the prohibitions on lender approval contained
- 8 in subsection (a).
- 9 §36B-2-123. Master planned communities.
- 10 (a) The declaration for a common interest community may state
- 11 that it is a master planned community if the declarant has reserved
- 12 the development right to create at least five-hundred units that
- 13 may be used for residential purposes, and at the time of the
- 14 reservation that declarant owns or controls more than five-hundred
- 15 acres on which the units may be built.
- 16 (b) If the requirements of subsection (a) are satisfied, the
- 17 declaration for the master planned community need not state a
- 18 maximum number of units and need not contain any of the information
- 19 required by section 2-105(a)(3) through (14) until the declaration
- 20 is amended under subsection (c).
- 21 (c) When each unit in a master planned community is conveyed
- 22 to a purchaser, the declaration must contain:
- 23 (i) A sufficient legal description of the unit and all

- 1 portions of the master planned community in which any other units
- 2 have been conveyed to a purchaser; and
- 3 (ii) All the information required by section 2-105(a)(3)
- 4 through (14) with respect to that real estate.
- 5 (d) The only real estate in a master planned community subject
- 6 to this chapter are units that have been declared or which are
- 7 being offered for sale and any other real estate described pursuant
- 8 to subsection (c). Other real estate that is or may become part of
- 9 the master planned community is only subject to other law and to
- 10 any other restrictions and limitations that appear of record.
- 11 (e) If the public offering statement conspicuously identifies
- 12 the fact that the community is a master planned community, the
- 13 disclosure requirements contained in article four apply only with
- 14 respect to units that have been declared or are being offered for
- 15 sale in connection with the public offering statement and to the
- 16 real estate described pursuant to subsection (c).
- 17 (f) Limitations in this chapter on the addition of unspecified
- 18 real estate-(section 2-122) do not apply to a master planned
- 19 community.
- 20 (g) The period of declarant control of the association for a
- 21 master planned community terminates in accordance with any
- 22 conditions specified in the declaration or otherwise at the time
- 23 the declarant, in a recorded instrument and after giving notice in

- 1 a record to all the unit owners, voluntarily surrenders all rights
- 2 to control the activities of the association.
- 3 §36B-2-124. Termination following catastrophe.
- 4 If substantially all the units in a common interest community
- 5 have been destroyed or are uninhabitable and the available methods
- 6 for giving notice under section 3-121 of a meeting of unit owners
- 7 to consider termination under section 2-118 will not likely result
- 8 in receipt of the notice, the executive board or any other
- 9 interested person may commence an action in the circuit court of
- 10 the county in which the common interest community is situate
- 11 seeking to terminate the common interest community. During the
- 12 pendency of the action, the court may issue whatever orders it
- 13 considers appropriate, including appointment of a receiver. After
- 14 a hearing, the court may terminate the common interest community or
- 15 reduce its size and may issue any other order the court considers
- 16 to be in the best interest of the unit owners and persons holding
- 17 an interest in the common interest community.

- 23 (1) Adopt and amend bylaws and rules and regulations;

- 1 (2) Adopt and amend budgets for revenues, expenditures, and
- 2 reserves and collect assessments for common expenses from unit

- 4 (3) Hire and discharge managing agents and other employees,
- 5 agents, and independent contractors;
- 6 (4) Institute, defend, or intervene in litigation or
- 7 administrative proceedings in its own name on behalf of itself or
- 8 two or more unit owners on matters affecting the common interest
- 9 community;
- 10 (5) Make contracts and incur liabilities;
- 11 (6) Regulate the use, maintenance, repair, replacement, and
- 12 modification of common elements;
- 13 (7) Cause additional improvements to be made as a part of the
- 14 common elements;
- 15 (8) Acquire, hold, encumber, and convey in its own name any
- 16 right, title, or interest to real estate or personal property, but:
- 17 (i) Common elements in a condominium or planned community may be
- 18 conveyed or subjected to a security interest only pursuant to
- 19 section one hundred twelve of this article; and (ii) part of a
- 20 cooperative may be conveyed, or all or part of a cooperative may be
- 21 subjected to a security interest, only pursuant to section one
- 22 hundred twelve of this article;
- 23 (9) Grant easements, leases, licenses, and concessions through

- 1 or over the common elements;
- 2 (10) Impose and receive any payments, fees, or charges for the
- 3 use, rental, or operation of the common elements, other than
- 4 limited common elements described in subsections (1) and (4),
- 5 section one hundred two, article two of this chapter, and for
- 6 services provided to unit owners;
- 7 (11) Impose charges for late payment of assessments and, after
- 8 notice and an opportunity to be heard, levy reasonable fines for
- 9 violations of the declaration, bylaws, rules, and regulations of
- 10 the association;
- 11 (12) Impose reasonable charges for the preparation and
- 12 recordation of amendments to the declaration, resale certificates
- 13 required by section one hundred nine, article four of this chapter,
- 14 or statements of unpaid assessments;
- 15 (13) Provide for the indemnification of its officers and
- 16 executive board and maintain directors' and officers' liability
- 17 insurance;
- 18 (14) Assign its right to future income, including the right to
- 19 receive common expense assessments, but only to the extent the
- 20 declaration expressly so provides;
- 21 (15) Exercise any other powers conferred by the declaration or
- 22 bylaws;
- 23 (16) Exercise all other powers that may be exercised in this

- 1 state by legal entities of the same type as the association;
- 2 (17) Institute litigation or administrative proceedings in its
- 3 own name against a unit owner for the collection of dues or
- 4 assessments that are overdue or in arrears; and
- 5 (18) Exercise any other powers necessary and proper for the
- 6 governance and operation of the association;
- 7 (19) May require that disputes between the association and
- 8 unit owners or between two or more unit owners regarding the common
- 9 interest community be submitted to nonbinding alternative dispute
- 10 resolution as a prerequisite to commencement of a judicial
- 11 proceeding;
- 12 (20) May suspend any right or privilege of a unit owner that
- 13 fails to pay an assessment, but may not:
- (A) Deny a unit owner or other occupant access to the owner's
- 15 unit; or
- 16 (B) Withhold services provided to a unit or a unit owner by
- 17 the association if the effect of withholding the service would be
- 18 to endanger the health, safety, or property of any person; and
- 19 (21) The association may, after notice, suspend a unit owner's
- 20 right to vote and/or right to seek election as a director or
- 21 officer of the association for failure of the unit owner to pay
- 22 assessments. The suspend rights to vote or seek election shall be
- 23 immediately restored to the unit owner upon payment of all past due

- 1 or delinquent assessment even if paid during a meeting or election.
- 2 (b) The declaration may not impose limitations on limit the
- 3 power of the association beyond the limitions authorized in
- 4 subsection (a) (18) to:
- 5 (1) Deal with the declarant which are if the limit is more
- 6 restrictive than the limitations <u>limit</u> imposed on the power of the
- 7 association to deal with other persons; or
- 8 (2) Institute litigation or an arbitration, mediation or
- 9 administrative proceeding against any person, subject to the
- 10 following:
- 11 (A) The association shall comply with section 124 of this
- 12 article, if applicable, before instituting any proceeding described
- 13 in subsection (a) of said section in connection with construction
- 14 defects; and
- 15 (B) The executive board promptly shall provide notice to the
- 16 unit owners of any legal proceeding in which the association is a
- 17 party other than proceedings involving enforcement of rules or to
- 18 recover unpaid assessments or other sums due the association.
- 19 (c) If a tenant of a unit owner violates the declaration,
- 20 bylaws, or rules of the association, in addition to exercising any
- 21 of its powers against the unit owner, the association may:
- 22 (1) Exercise directly against the tenant the powers described
- 23 in subsection (a) (11);

- 1 (2) After giving notice to the tenant and the unit owner and
- 2 an opportunity to be heard, levy reasonable fines against the
- 3 tenant for the violation; and
- 4 (3) Enforce any other rights against the tenant for the
- 5 violation which the unit owner as landlord could lawfully have
- 6 exercised under the lease or which the association could lawfully
- 7 have exercised directly against the unit owner, or both.
- 8 (d) The rights referred to in subsection (c)(3) may be
- 9 exercised only if the tenant or unit owner fails to cure the
- 10 violation within ten days after the association notifies the tenant
- 11 and unit owner of that violation.
- 12 (e) Unless a lease otherwise provides, this section does not:
- 13 (1) Affect rights that the unit owner has to enforce the lease

- 16 not a party in the absence of a violation of the declaration,
- 17 bylaws, or rules.
- 18 (f) The executive board may determine whether to take
- 19 enforcement action by exercising the association's power to impose
- 20 sanctions or commencing an action for a violation of the
- 21 declaration, bylaws, and rules, including whether to compromise any
- 22 <u>claim for unpaid assessments or other claim made</u> by or against it.
- 23 The executive board does not have a duty to take enforcement action

- 1 if it determines that, under the facts and circumstances presented:
- 2 (1) The association's legal position does not justify taking
- 3 any or further enforcement action;
- 4 (2) The covenant, restriction, or rule being enforced is, or
- 5 is likely to be construed as, inconsistent with law;
- 6 (3) Although a violation may exist or may have occurred, it is
- 7 not so material as to be objectionable to a reasonable person or to
- 8 justify expending the association's resources; or
- 9 (4) It is not in the association's best financial or other
- 10 interests to pursue an enforcement action.
- 11 (g) The executive board's decision under subsection (f) not to
- 12 pursue enforcement under one set of circumstances does not prevent
- 13 the executive board from taking enforcement action under another
- 14 set of circumstances, but the executive board may not be arbitrary
- 15 or capricious in taking enforcement action.
- 16 (h) The executive board shall establish a reasonable method
- 17 for unit owners to communicate among themselves and with the
- 18 executive board on matters concerning the association.
- 19 §36B-3-103. Executive board members and officers.
- 20 (a) Except as otherwise provided in the declaration, the
- 21 bylaws, subsection (b), or other provisions of this chapter, the
- 22 executive board may act in all instances acts on behalf of the
- 23 association. In the performance of their duties, the officers and

- 1 members of the executive board are required to exercise (i) if
- 2 appointed by the declarant the care required of fiduciaries of the
- 3 unit owners shall exercise the degree of care and loyalty to the

- 20 (4) or to Elect members of the executive board but may fill

- 22 or, if earlier, until the next regularly scheduled election of
- 23 executive board members; or

1 <u>(5)</u> Determine the qualifications, powers, and duties, or terms
2 of office of executive board members (section 3-103(f).), but the
3 executive board may fill vacancies in its membership for the

4 unexpired portion of any term.

- (c) The executive board shall adopt budgets as provided in section 3-123. Within thirty days after adoption of any proposed budget for the common interest community, the executive board shall provide a summary of the budget to all the unit owners, and shall set a date for a meeting of the unit owners to consider ratification of the budget not less than fourteen nor more than thirty days after mailing of the summary. Unless at that meeting a majority of all unit owners or any larger vote specified in the declaration reject the budget, the budget is ratified, whether or not a quorum is present. - 19 (a) The bylaws of the association must provide:
- 20 (1) The number of members of the executive board and the
- 21 titles of the officers of the association;
- 22 (2) Election by the executive board of president, treasurer,
- 23 secretary, and any other officers of the association the bylaws

- 1 specify;
- 2 (3) The qualifications, powers and duties, terms of office,
- 3 and manner of electing and removing executive board members and
- 4 officers and filling vacancies;
- 5 (4) Which, if any, of its powers the executive board or
- 6 officers may delegate to other persons or to a managing agent;
- 7 (5) Which of its officers may prepare, execute, certify, and

- 21 (a) In a condominium or planned community, portions of the
- 22 common elements may be conveyed or subjected to a security interest
- 23 by the association if persons entitled to cast at least eighty

1 percent of the votes in the association, including eighty percent
2 of the votes allocated to units not owned by a declarant, or any
3 larger percentage the declaration specifies, agree to that action;
4 but all owners of units to which any limited common element is
5 allocated must agree in order to convey that limited common element
6 or subject it to a security interest. The declaration may specify
7 a smaller percentage only if all of the units are restricted
8 exclusively to nonresidential uses. Proceeds of the sale are an
9 asset of the association.

(b) Part of a cooperative may be conveyed and all or part of a cooperative may be subjected to a security interest by the association if persons entitled to cast at least eighty percent of the votes in the association, including eighty percent of the votes allocated to units not owned by a declarant, or any larger percentage the declaration specified, agree to that action; but, if fewer than all of the units or limited common elements are to be conveyed or subjected to a security interest, then all unit owners of those units, or the units to which those limited common elements are allocated, must agree in order to convey those units or limited common elements or subject them to a security interest. The declaration may specify a smaller percentage only if all of the units are restricted exclusively to nonresidential uses. Proceeds

- 1 conveyance or other voluntary transfer of an entire cooperative, 2 unless made pursuant to section 2-118, is void.
- (c) An agreement to convey common elements in a condominium or planned community, or to subject them to a security interest, or in a cooperative, an agreement to convey any part of a cooperative or subject it to a security interest, must be evidenced by the execution of an agreement, or ratifications thereof, in the same manner as a deed, by the requisite number of unit owners. The agreement must specify a date after which the agreement will be void unless recorded before that date. The agreement and all ratifications thereof must be recorded in every county in which a portion of the common interest community is situated, and is effective only upon recordation.
- (d) The association, on behalf of the unit owners, may contract to convey an interest in a common interest community pursuant to subsection (a), but the contract is not enforceable against the association until approved pursuant to subsections (a), (b), and (c). Thereafter, the association has all powers necessary and appropriate to effect the conveyance or encumbrance, including the power to execute deeds or other instruments.
- 21 (e) Unless made pursuant to this section, any purported 22 conveyance, encumbrance, judicial sale, or other voluntary transfer 23 of common elements or of any other part of a cooperative is void.

- 1 (f) A conveyance or encumbrance of common elements or of a 2 cooperative pursuant to this section does not deprive any unit of
- 3 its rights of access and support.
- 4 (g) Unless the declaration otherwise provides, a conveyance or
- 5 encumbrance of common elements pursuant to this section does not
- 6 affect the priority or validity of preexisting encumbrances if the
- 7 holders of first security interests on eighty percent of the units
- 8 that are subject to security interests on the day the unit owners'
- 9 agreement under subsection (c) is recorded consent in writing:
- 10 (1) A conveyance of common elements pursuant to this section
- 11 terminates both the undivided interests in those common elements
- 12 allocated to the units and the security interests in those
- 13 undivided interests held by all persons holding security interests
- 14 in the units; and
- 15 (2) An encumbrance of common elements pursuant to this section
- 16 has priority over all preexisting encumbrances on the undivided
- 17 interests in those common elements held by all persons holding
- 18 security interests in the units.
- 19 (h) The consents by holders of first security interests on
- 20 units described in subsection (g), or a certificate of the
- 21 secretary affirming that those consents have been received by the
- 22 association, may be recorded at any time before the date on which
- 23 the agreement under subsection (c) becomes void. Consents or

- 1 certificates so recorded are valid from the date they are recorded
- 2 for purposes of calculating the percentage of consenting first
- 3 security interest holders, regardless of later sales or
- 4 encumbrances on those units. Even if the required percentage of
- 5 first security interest holders so consent, a conveyance or
- 6 encumbrance of common elements does not affect interests having

This subsection 15 does not affect the priority of mechanics' or materialmen's liens, 16 or the priority of liens for other assessments made by the 17 association. 3 unit owner's inspection.

- 13 (a) Before adopting, amending or repealing any rule, the 14 executive board shall give all unit owners notice of:

- 17 (2) A date on which the executive board will act on the 18 proposed rule or amendment after considering comments from unit 19 owners.
- 20 (b) Following adoption, amendment, or repeal of a rule, the 21 association shall notify the unit owners of its action and provide 22 a copy of any new or revised rule.
- 23 (c) An association may adopt rules to establish and enforce 24 construction and design criteria and aesthetic standards if the

The notice may be delivered by any method of service and may be addressed to any person if the method of service used:
- 23 (A) Provides actual notice to the person named in the claim; 24 or

- 1 (B) Would be sufficient to give notice to the person in 2 connection with commencement of an action by the association 3 against the person.
- 4 (2) Subject to subsection (e), the association may not 5 institute a proceeding against a person until forty-five days after 6 the association sends notice of its claim to that person.
- 7 (3) During the period described in subdivision (2), the 8 declarant and any other person to which the association gave notice 9 may present to the association a plan to repair or otherwise remedy 10 the construction defects described in the notice. If the 11 association does not receive a timely remediation plan from a 12 person to which it gave notice, or if the association does not 13 accept the terms of any plan submitted, the association may 14 institute a proceeding against the person.
- 15 (4) If the association receives one or more timely remediation 16 plans, the executive board shall consider promptly those plans and 17 notify the persons to which it directed notice whether the plan is 18 acceptable as presented, acceptable with stated conditions, or not 19 accepted.
- (5) If the association accepts a remediation plan from a 21 person the association seeks to hold liable for the claimed defect, 22 or if a person agrees to stated conditions to an otherwise 23 acceptable plan, the parties shall agree on a period for 24 implementation of the plan. The association may not institute a

- 1 proceeding against the person during the time the plan is being 2 diligently implemented.
- (6) Except as otherwise provided in subdivision 4-116(d) for 4 warranty claims, any statute of limitation affecting the 5 association's right of action against a declarant or other person 6 is tolled during the period described in subdivision (2) and during 7 any extension of that time because a person to which notice was 8 directed has commenced and is diligently pursuing the remediation
- 10 (b) After the time described in subsection (a)(2) expires,
 11 whether or not the association agrees to any remediation plan, a
 12 proceeding may be instituted by:

- (1) The association against a person to which notice was
 14 directed which fails to submit a timely remediation plan, the plan

- (i) A statement of the amount or a statement that there is no 15 amount, included in the budget as a reserve for repairs and 16 replacement;
- 17 (ii) A statement of any other reserves;

- 24 (b) The public offering statement must contain any current

- 21 (5) A statement of the amount of any reserves for capital 22 expenditures and of any portions of those reserves designated by 23 the association for any specified projects;
- 24 (6) The most recent regularly prepared balance sheet and

- 1 income and expense statement, if any, of the association;
- 2 (7) The current operating budget of the association;
- 3 (8) A statement of any unsatisfied judgments against the
- 4 association and the status of any pending suits in which the
- 5 association is a defendant;
- 6 (9) A statement describing any insurance coverage provided for
- 7 the benefit of unit owners;
- 8 (10) A statement as to whether the executive board has
- 9 knowledge that any alterations or improvements to the unit or to
- 10 the limited common elements assigned thereto violate any provision
- 11 of the declaration;
- 12 (11) A statement as to whether the executive board has
- 13 knowledge of any violations of the health or building codes with
- 14 respect to the unit, the limited common elements assigned thereto,
- 15 or any other portion of the common interest community;
- 16 (12) A statement of the remaining term of any leasehold estate
- 17 affecting the common interest community and the provisions
- 18 governing any extension or renewal thereof;
- 19 (13) A statement of any restrictions in the declaration
- 20 affecting the amount that may be received by a unit owner upon
- 21 sale, condemnation, casualty loss to the unit or the common
- 22 interest community, or termination of the common interest
- 23 community; and
- 24 (14) In a cooperative, an accountant's statement, if any was

- 1 prepared, as to the deductibility for federal income tax purposes
- 2 by the unit owner of real estate taxes and interest paid by the
- 3 association;
- 4 (15) A statement describing any pending sale or encumbrance of
- 5 common elements; and
- 6 (16) A statement disclosing the effect on the unit to be
- 7 conveyed of any restrictions on the owner's right to use or occupy
- 8 the unit or to lease the unit to another person.
- 9 (b) The association, within ten days after a request by a unit
- 10 owner, shall furnish a certificate containing the information
- 11 necessary to enable the unit owner to comply with this section. A
- 12 unit owner providing a certificate pursuant to subsection (a) is
- 13 not liable to the purchaser for any erroneous information provided
- 14 by the association and included in the certificate.
- 15 (c) A purchaser is not liable for any unpaid assessment or fee
- 16 greater than the amount set forth in the certificate prepared by
- 17 the association. A unit owner is not liable to a purchaser for the
- 18 failure or delay of the association to provide the certificate in
- 19 a timely manner, but the purchase contract is voidable by the
- 20 purchaser until the certificate has been provided and for five days
- 21 thereafter or until conveyance, whichever first occurs.
- 22 §36B-4-112. Conversion buildings.
- 23 (a) A declarant of a common interest community containing
- 24 conversion buildings, and any dealer who intends to offer units in

1 such a common interest community, shall give each of 2 residential tenants and any residential subtenant in possession of 3 a portion of a conversion building notice of the conversion and 4 provide those persons with the public offering statement no later 5 than one hundred twenty days before the tenants and any subtenant 6 in possession are required to vacate. The notice must set forth 7 generally the rights of tenants and subtenants under this section 8 and must be hand delivered to the unit or mailed by prepaid United 9 States mail to the tenant and subtenant at the address of the unit 10 or any other mailing address provided by a tenant. No tenant or 11 subtenant may be required to vacate upon less than one hundred 12 twenty days' notice, except by reason of nonpayment of rent, waste, 13 or conduct that disturbs other tenants' peaceful enjoyment of the 14 premises, and the terms of the tenancy may not be altered during 15 that period. Failure to give notice as required by this section is 16 a defense to an action for possession.

(b) For sixty days after delivery or mailing of the notice described in subsection (a), the person required to give the notice shall offer to convey each unit or proposed unit occupied for residential use to the tenant who leases that unit. If a tenant fails to purchase the unit during that sixty day period, the offeror may not offer to dispose of an interest in that unit during the following one hundred eighty days at a price or on terms more favorable to the offeree than the price or terms offered to the

- 1 tenant. This subsection does not apply to any unit in a conversion
- 2 building if that unit will be restricted exclusively to
- 3 nonresidential use or the boundaries of the converted unit do not
- 4 substantially conform to the dimensions of the residential unit
- 5 before conversion.
- 6 (c) If a seller, in violation of subsection (b), conveys a
- 7 unit to a purchaser for value who has no knowledge of the
- 8 violation, the recordation of the deed conveying the unit or, in a
- 9 cooperative, the conveyance of the unit, extinguishes any right a
- 10 tenant may have under subsection (b) to purchase that unit if the
- 11 deed states that the seller has complied with subsection (b), but
- 12 the conveyances does not affect the right of a tenant to recover
- 13 damages from the seller for a violation of subsection (b).
- 14 (d) If a notice of conversion specifies a date by which a unit
- 15 or proposed unit must be vacated and otherwise complies with the
- 16 provisions of applicable law, the notice also constitutes a notice
- 17 to vacate specified by that statute.
- (d) (e) Nothing in this section permits termination of a lease
- 19 by a declarant in violation of its terms.
- 20 \$36B-4-116. Statute of limitations for warranties.
- 21 (a) A judicial proceeding for breach of any obligation arising
- 22 under section 4-113 or 4-114 must be commenced within six years
- 23 after the cause of action accrues, but the parties may agree to
- 24 reduce the period of limitation to not less than two years. With

- 1 respect to a unit that may be occupied for residential use, an
- 2 agreement to reduce the period of limitation must be evidenced by
- 3 a separate instrument executed by the purchaser.
- 4 (b) Subject to subsection (c), a cause of action for breach of
- 5 warranty of quality, regardless of the purchaser's lack of
- 6 knowledge of the breach, accrues:
- 7 (1) As to a unit, at the time the purchaser to whom the
- 8 warranty is first made enters into possession if a possessory
- 9 interest was conveyed or at the time of acceptance of the
- 10 instrument of conveyance if a nonpossessory interest was conveyed;
- 11 and
- 12 (2) As to each common element, at the time the common element
- 13 is completed or, if later, as to (i) a common element that may be
- 14 added to the common interest community or portion thereof, at the
- 15 time the first unit therein is conveyed to a bona fide purchaser,
- 16 or (ii) a common element within any other portion of the common
- 17 interest community, at the time the first unit is conveyed to a
- 18 bona fide purchaser.
- 19 (c) If a warranty of quality explicitly extends to future
- 20 performance or duration of any improvement or component of the
- 21 common interest community, the cause of action accrues at the time
- 22 the breach is discovered or at the end of the period for which the
- 23 warranty explicitly extends, whichever is earlier.
- 24 (d) During the period of declarant control, the association

1 may authorize an independent committee of the executive board to 2 evaluate and enforce any warranty claims involving the common 3 elements, and to compromise those claims. Only members of the 4 executive board elected by unit owners other than the declarant and 5 other persons appointed by those independent members may serve on 6 the committee, and the committee's decision must be free of any 7 control by the declarant or any member of the executive board or 8 officer appointed by the declarant. All costs reasonably incurred 9 by the committee, including attorney's fees, are common expenses, 10 and must be added to the budget annually adopted by the association 11 under section 3-115. If the committee is so created, the period of 12 limitation for a warranty claim considered by the committee begins 13 to run from the date of the first meeting of the committee. 14 §36B-4-117. Effect of violations on rights of action; attorney's 15 fees. 16 (a) If a declarant or any other person subject to this chapter fails to comply with any of its provisions or any provision of the declaration or bylaws, any person or class of persons adversely affected by the failure to comply has a claim for appropriate 20 relief. A declarant, association, unit owner, or any other person 21 subject to this chapter may bring an action to enforce a right 22 granted or obligation imposed by this chapter, the declaration, or 23 the bylaws. Punitive damages may be awarded for a willful failure 24 to comply with this chapter. The court in an appropriate case, may

- 1 award reasonable attorney's fees and costs.
- 2 (b) Parties to a dispute arising under this chapter, the
- 3 declaration, or the bylaws may agree to resolve the dispute by any
- 4 form of binding or nonbinding alternative dispute resolution, but:
- 5 (1) A declarant may agree with the association to do so only
- 6 after the period of declarant control has expired unless the
- 7 agreement is made with an independent committee of the executive
- 8 board elected pursuant to subdivision 4-116(d); and
- 9 (2) An agreement to submit to any form of binding alternative
- 10 dispute resolution must be in a record authenticated by the
- 11 parties.

NOTE: The purpose of this bill is to update the Uniform Common Interest Ownership Act.

\$36B-1-115, \$36B-1-116, \$36B-1-208, \$36B-2-123, \$36B-2-124, \$36B-3-120, \$36B-3-121, \$36B-3-122, \$36B-3-123 and \$36B-3-124 are new; therefore, strike-throughs and underscoring have been omitted.

§36B-3-118 has been completely rewritten; therefore, underscoring and strike-throughs have been omitted.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.

This bill is recommended for passage in the 2013 Regular Session by the Commission on Interstate Cooperation.
