LO	A BILL to amend and reenact §29-22-18d of the Code of West
L1	Virginia, 1931, as amended; to amend said code by adding
L2	thereto three new sections, designated \$29-22A-10d,
L3	\$29-22A-10e and $$29-22A-10f$; to amend said code by adding
L 4	thereto a new section, designated §29-22C-27a; and to amend
L 5	said code by adding thereto a new section, designated
L 6	§29-25-22b, all relating to the transfer of certain revenues
L 7	derived from lottery activities generally; reducing the
L 8	distribution to the West Virginia Infrastructure Fund to \$20
L 9	million for fiscal year 2015; transferring certain revenues
20	derived from racetrack video lottery, lottery racetrack table
21	games and lottery historic hotel gaming facility activities to
22	the state excess lottery revenue fund and distributing
23	revenues from the state excess lottery revenue fund to certain
24	distributees, all for fiscal year 2015.
25	Be it enacted by the Legislature of West Virginia:
26	That §29-22-18d of the Code of West Virginia, 1931, as
27	amended, be amended and reenacted; that said code be amended by
28	adding thereto three new sections, designated \$29-22A-10d,

- 1 §29-22A-10e and §29-22A-10f; that said code be amended by adding
- 2 thereto a new section, designated \$29-22C-27a; and that said code
- 3 be amended by adding thereto a new section, designated \$29-25-22b,
- 4 all to read as follows:
- 5 ARTICLE 22. STATE LOTTERY ACT.
- 6 §29-22-18d. Increase in allocation to West Virginia
- 7 Infrastructure Fund from State Excess Lottery
- 8 Revenue Fund.
- 9 Notwithstanding any provision of subsection (d), section 10 eighteen-a of this article to the contrary, the deposit of \$40 11 million into the West Virginia Infrastructure Fund set forth above 12 is for the fiscal year beginning July 1, 2010, only. For the fiscal 13 year beginning July 1, 2011, and each fiscal year thereafter, in 14 lieu of the deposits required under subdivision (5), subsection 15 (d), section eighteen-a of this article, the commission shall, 16 first, deposit \$6 million into the West Virginia Infrastructure 17 Lottery Revenue Debt Service Fund created in subsection (h), 18 section nine, article fifteen-a, chapter thirty-one of this code, 19 to be spent in accordance with the provisions of that subsection, 20 and, second deposit \$40 million into the West Virginia 21 Infrastructure Fund created in subsection (a), section nine, 22 article fifteen-a, chapter thirty-one of this code, to be spent in 23 accordance with the provisions of that article: Provided, That for 24 the fiscal year beginning July 1, 2014, the deposit to the West 25 Virginia Infrastructure Fund shall be \$20 million; Provided, 26 however, That notwithstanding any provision of subsection (a), 27 section ten, article fifteen-a, chapter thirty-one of this code to 28 the contrary, for the fiscal year beginning July 1, 2014, any

- 1 moneys disbursed from the West Virginia Infrastructure Fund in the
- 2 form of grants shall not exceed fifty percent of the total funds
- 3 available for the funding of projects.
- 4 ARTICLE 22A. RACETRACK VIDEO LOTTERY ACT.
- 5 §29-22A-10d. Changes in distribution of net terminal income;
- 6 distributions from excess lottery fund.
- 7 (a) Notwithstanding any provision of subsection (b), section
- 8 ten of this article to the contrary, for the fiscal year beginning
- 9 July 1, 2014, the distributions for transfer to the Licensed
- 10 Racetrack Modernization Fund pursuant to subsection (b), section
