10 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article, designated \$16-4F-1, \$16-4F-2, 11 12 \$16-4F-3, \$16-4F-4 and \$16-4F-5; to amend and reenact \$30-3-1413 and §30-3-16 of said code; to amend and reenact §30-5-3 of 14 said code; to amend and reenact §30-7-15a of said code; to 15 amend and reenact §30-14-11 of said code; and to amend and reenact §30-14A-1 of said code, all relating to treatment for 16 a sexually transmitted disease; defining terms; permitting 17 prescribing of antibiotics to sexual partners of a patient 18 19 without a prior examination of the partner; requiring patient 20 counseling; establishing counseling criteria; requiring 21 information materials be prepared by the Department of Health 22 and Human Resources; providing limited liability for providing 23 expedited partnership therapy; requiring legislative rules 24 regarding what is considered a sexually transmitted disease; 25 physicians, physician providing that assistants, and pharmacists and advanced nurse practitioners are not subject 26

- 2 sexually transmitted diseases for sexual partners of a
- 3 patient.
- 4 Be it enacted by the Legislature of West Virginia:
- 5 That the Code of West Virginia, 1931, as amended, be amended
- 6 by adding thereto a new article, designated \$16-4F-1, \$16-4F-2,
- 7 \$16-4F-3, \$16-4F-4 and \$16-4F-5; that \$30-3-14 and \$30-3-16 of said
- 8 code be amended and reenacted; that \$30-5-3 of said code be amended
- 9 and reenacted; that \$30-7-15a of said code be amended and
- 10 reenacted; that §30-14-11 of said code be amended and reenacted;
- 11 and that §30-14A-1 of said code be amended and reenacted, all to
- 12 read as follows:
- 13 CHAPTER 16. PUBLIC HEALTH.
- 14 ARTICLE 4F. EXPEDITED PARTNER THERAPY.
- 15 §16-4F-1. Definitions.
- 16 As used in this article, unless the context otherwise
- 17 indicates, the following terms have the following meanings:
- 18 (1) "Department" means the West Virginia Department of Health
- 19 and Human Resources.
- 20 (2) "Expedited partner therapy" means prescribing, dispensing,
- 21 furnishing or otherwise providing prescription antibiotic drugs to
- 22 the sexual partner or partners of a person clinically diagnosed as
- 23 infected with a sexually transmitted disease without physical
- 24 examination of the partner or partners.
- 25 (3) "Health care professional" means:

- 1 (A) An allopathic physician licensed pursuant to the 2 provisions of article three, chapter thirty of this code;
- 3 (B) An osteopathic physician licensed pursuant to article 4 fourteen, chapter thirty of this code;
- 5 (C) A physician assistant licensed pursuant to the provisions 6 of section sixteen, article three, chapter thirty of this code or 7 article fourteen-a, chapter thirty of this code;
- 8 (D) An advanced practice registered nurse authorized with 9 prescriptive authority pursuant to the provisions of section 10 fifteen-a, article seven, chapter thirty of this code; or
- 11 (E) A pharmacist licensed pursuant to the provisions of 12 article five, chapter thirty of this code.
- 13 (4) "Sexually transmitted disease" means a disease that may be
  14 treated by expedited partner therapy as determined by rule of the
  15 department.

### 16 §16-4F-2. Expedited partner therapy.

(a) Notwithstanding any other provision of law to the contrary, a health care professional who makes a clinical diagnosis of a sexually transmitted disease may provide expedited partner therapy for the treatment of the sexually transmitted disease if in the judgment of the health care professional the sexual partner is unlikely or unable to present for comprehensive health care, including evaluation, testing and treatment for sexually transmitted diseases. Expedited partner therapy is limited to a sexual partner who may have been exposed to a sexually transmitted disease within the previous sixty days and who is able to be

- 1 contacted by the patient.
- 2 (b) Any health care professional who provides expedited
- 3 partner therapy shall comply with all necessary provisions of
- 4 article four of this chapter.
- 5 (c) A health care professional who provides expedited partner
- 6 therapy shall provide counseling for the patient, including advice
- 7 that all women and symptomatic persons, and in particular women
- 8 with symptoms suggestive of pelvic inflammatory disease, are
- 9 encouraged to seek medical attention. The health care professional
- 10 shall also provide in written or electronic format materials
- 11 provided by the department to be given by the patient to his or her
- 12 sexual partner.

#### 13 §16-4F-3. Informational materials.

- 14 (a) The department shall provide information and technical
- 15 assistance as appropriate to health care professionals who provide
- 16 expedited partner therapy. The department shall develop and
- 17 disseminate in electronic and other formats the following written
- 18 materials:
- 19 (1) Informational materials for sexual partners, as described
- 20 in subsection (c) of section two of this article;
- 21 (2) Informational materials for persons who are repeatedly
- 22 diagnosed with sexually transmitted diseases; and
- 23 (3) Guidance for health care professionals on the safe and
- 24 effective provision of expedited partner therapy.
- 25 (b) The department may offer educational programs about
- 26 expedited partner therapy for health care professionals.

# 1 §16-4F-4. Limitation of liability.

- (a) A health care professional who provides expedited partner therapy in good faith without fee or compensation under this article and provides counseling and written materials as required in subsection (c), section two of this article is not subject to civil or professional liability in connection with the provision of the therapy, counseling and materials, except in the case of gross negligence or willful and wanton misconduct. A health care professional is not subject to civil or professional liability for choosing not to provide expedited partner therapy.
- 11 (b) A pharmacist or pharmacy is not subject to civil or 12 professional liability for choosing not to fill a prescription that 13 would cause that pharmacist or pharmacy to violate any provision of 14 the provisions of article five, chapter thirty of this code.

### 15 **§16-4F-5**. Rulemaking.

The Secretary of the Department of Health and Human Resources shall propose rules for legislative approval in accordance with the provisions of article three, chapter twenty-nine-a of this code to designate certain diseases as sexually transmitted diseases which may be treated by expedited partner therapy. The department shall consider the recommendations and classifications of the federal Department of Health and Human Services, Centers for Disease Control and Prevention and other nationally recognized medical authorities in making these designations.

#### CHAPTER 30. PROFESSIONS AND OCCUPATIONS.

## 1 ARTICLE 3. WEST VIRGINIA MEDICAL PRACTICE ACT.

- 2 §30-3-14. Professional discipline of physicians and podiatrists; reporting of information to board pertaining to 3 medical professional liability and professional 4 5 incompetence required; penalties; grounds 6 license denial and discipline of physicians and 7 podiatrists; investigations; physical and mental 8 examinations; hearings; sanctions; 9 sanctions; reporting by the board; reapplication; civil and criminal immunity; voluntary limitation of 10 11 license; probable cause determinations.
- 12 (a) The board may independently initiate disciplinary
  13 proceedings as well as initiate disciplinary proceedings based on
  14 information received from medical peer review committees,
  15 physicians, podiatrists, hospital administrators, professional
  16 societies and others.
- The board may initiate investigations as to professional incompetence or other reasons for which a licensed physician or podiatrist may be adjudged unqualified based upon criminal convictions; complaints by citizens, pharmacists, physicians, podiatrists, peer review committees, hospital administrators, professional societies or others; or unfavorable outcomes arising out of medical professional liability. The board shall initiate an investigation if it receives notice that three or more judgments, or any combination of judgments and settlements resulting in five

- 1 or more unfavorable outcomes arising from medical professional 2 liability have been rendered or made against the physician or 3 podiatrist within a five-year period. The board may not consider
- 4 any judgments or settlements as conclusive evidence of professional
- 5 incompetence or conclusive lack of qualification to practice.
- (b) Upon request of the board, any medical peer review committee in this state shall report any information that may relate to the practice or performance of any physician or podiatrist known to that medical peer review committee. Copies of the requests for information from a medical peer review committee may be provided to the subject physician or podiatrist if, in the discretion of the board, the provision of such copies will not jeopardize the board's investigation. In the event that copies are provided, the subject physician or podiatrist is allowed fifteen days to comment on the requested information and such comments must be considered by the board.
- The chief executive officer of every hospital shall, within sixty days after the completion of the hospital's formal disciplinary procedure and also within sixty days after the commencement of and again after the conclusion of any resulting legal action, report in writing to the board the name of any member of the medical staff or any other physician or podiatrist practicing in the hospital whose hospital privileges have been revoked, restricted, reduced or terminated for any cause, including resignation, together with all pertinent information relating to such action. The chief executive officer shall also report any

other formal disciplinary action taken against any physician or podiatrist by the hospital upon the recommendation of its medical staff relating to professional ethics, medical incompetence, medical professional liability, moral turpitude or drug or alcohol abuse. Temporary suspension for failure to maintain records on a timely basis or failure to attend staff or section meetings need not be reported. Voluntary cessation of hospital privileges for reasons unrelated to professional competence or ethics need not be reported.

Any managed care organization operating in this state which 11 provides a formal peer review process shall report in writing to 12 the board, within sixty days after the completion of any formal 13 peer review process and also within sixty days after the 14 commencement of and again after the conclusion of any resulting 15 legal action, the name of any physician or podiatrist whose 16 credentialing has been revoked or not renewed by the managed care 17 organization. The managed care organization shall also report in 18 writing to the board any other disciplinary action taken against a 19 physician or podiatrist relating to professional ethics, 20 professional liability, moral turpitude or drug or alcohol abuse 21 within sixty days after completion of a formal peer review process 22 which results in the action taken by the managed care organization. 23 For purposes of this subsection, "managed care organization" means 24 a plan that establishes, operates or maintains a network of health 25 care providers who have entered into agreements with and been 26 credentialed by the plan to provide health care services to

- 1 enrollees or insureds to whom the plan has the ultimate obligation
- 2 to arrange for the provision of or payment for health care services
- 3 through organizational arrangements for ongoing quality assurance,
- 4 utilization review programs or dispute resolutions.
- 5 Any professional society in this state comprised primarily of
- 6 physicians or podiatrists which takes formal disciplinary action
- 7 against a member relating to professional ethics, professional
- 8 incompetence, medical professional liability, moral turpitude or
- 9 drug or alcohol abuse shall report in writing to the board within
- 10 sixty days of a final decision the name of the member, together
- 11 with all pertinent information relating to the action.
- Every person, partnership, corporation, association, insurance company, professional society or other organization providing professional liability insurance to a physician or podiatrist in this state, including the State Board of Risk and Insurance Management, shall submit to the board the following information within thirty days from any judgment or settlement of a civil or medical professional liability action excepting product liability actions: The name of the insured; the date of any judgment or settlement; whether any appeal has been taken on the judgment and, if so, by which party; the amount of any settlement or judgment
- 23 Within thirty days from the entry of an order by a court in a 24 medical professional liability action or other civil action in 25 which a physician or podiatrist licensed by the board is determined 26 to have rendered health care services below the applicable standard

22 against the insured; and other information required by the board.

1 of care, the clerk of the court in which the order was entered 2 shall forward a certified copy of the order to the board.

Within thirty days after a person known to be a physician or 4 podiatrist licensed or otherwise lawfully practicing medicine and 5 surgery or podiatry in this state or applying to be licensed is 6 convicted of a felony under the laws of this state or of any crime 7 under the laws of this state involving alcohol or drugs in any way, 8 including any controlled substance under state or federal law, the 9 clerk of the court of record in which the conviction was entered 10 shall forward to the board a certified true and correct abstract of 11 record of the convicting court. The abstract shall include the 12 name and address of the physician or podiatrist or applicant, the 13 nature of the offense committed and the final judgment and sentence 14 of the court.

Upon a determination of the board that there is probable cause to believe that any person, partnership, corporation, association, insurance company, professional society or other organization has failed or refused to make a report required by this subsection, the board shall provide written notice to the alleged violator stating the nature of the alleged violation and the time and place at which the alleged violator shall appear to show good cause why a civil penalty should not be imposed. The hearing shall be conducted in accordance with the provisions of article five, chapter twenty-inne-a of this code. After reviewing the record of the hearing, if the board determines that a violation of this subsection has coccurred, the board shall assess a civil penalty of not less than

- 1 \$1,000 nor more than \$10,000 against the violator. The board shall 2 notify any person so assessed of the assessment in writing and the 3 notice shall specify the reasons for the assessment. 4 violator fails to pay the amount of the assessment to the board 5 within thirty days, the Attorney General may institute a civil 6 action in the circuit court of Kanawha County to recover the amount 7 of the assessment. In any civil action, the court's review of the 8 board's action shall be conducted in accordance with the provisions 9 of section four, article five, chapter twenty-nine-a of this code. 10 Notwithstanding any other provision of this article to the 11 contrary, when there are conflicting views by recognized experts as 12 to whether any alleged conduct breaches an applicable standard of 13 care, the evidence must be clear and convincing before the board 14 may find that the physician or podiatrist has demonstrated a lack 15 of professional competence to practice with a reasonable degree of 16 skill and safety for patients.
- Any person may report to the board relevant facts about the conduct of any physician or podiatrist in this state which in the opinion of that person amounts to medical professional liability or professional incompetence.
- 21 The board shall provide forms for filing reports pursuant to 22 this section. Reports submitted in other forms shall be accepted 23 by the board.
- The filing of a report with the board pursuant to any provision of this article, any investigation by the board or any disposition of a case by the board does not preclude any action by

- 1 a hospital, other health care facility or professional society
- 2 comprised primarily of physicians or podiatrists to suspend,
- 3 restrict or revoke the privileges or membership of the physician or
- 4 podiatrist.
- 5 (c) The board may deny an application for license or other
- 6 authorization to practice medicine and surgery or podiatry in this
- 7 state and may discipline a physician or podiatrist licensed or
- 8 otherwise lawfully practicing in this state who, after a hearing,
- 9 has been adjudged by the board as unqualified due to any of the
- 10 following reasons:
- 11 (1) Attempting to obtain, obtaining, renewing or attempting to
- 12 renew a license to practice medicine and surgery or podiatry by
- 13 bribery, fraudulent misrepresentation or through known error of the
- 14 board:
- 15 (2) Being found guilty of a crime in any jurisdiction, which
- 16 offense is a felony, involves moral turpitude or directly relates
- 17 to the practice of medicine. Any plea of nolo contendere is a
- 18 conviction for the purposes of this subdivision;
- 19 (3) False or deceptive advertising;
- 20 (4) Aiding, assisting, procuring or advising any unauthorized
- 21 person to practice medicine and surgery or podiatry contrary to
- 22 law:
- 23 (5) Making or filing a report that the person knows to be
- 24 false; intentionally or negligently failing to file a report or
- 25 record required by state or federal law; willfully impeding or
- 26 obstructing the filing of a report or record required by state or

- 1 federal law; or inducing another person to do any of the foregoing.
- 2 The reports and records covered in this subdivision mean only those
- 3 that are signed in the capacity as a licensed physician or
- 4 podiatrist;
- 5 (6) Requesting, receiving or paying directly or indirectly a
- 6 payment, rebate, refund, commission, credit or other form of profit
- 7 or valuable consideration for the referral of patients to any
- 8 person or entity in connection with providing medical or other
- 9 health care services or clinical laboratory services, supplies of
- 10 any kind, drugs, medication or any other medical goods, services or
- 11 devices used in connection with medical or other health care
- 12 services;
- 13 (7) Unprofessional conduct by any physician or podiatrist in
- 14 referring a patient to any clinical laboratory or pharmacy in which
- 15 the physician or podiatrist has a proprietary interest unless the
- 16 physician or podiatrist discloses in writing such interest to the
- 17 patient. The written disclosure shall indicate that the patient
- 18 may choose any clinical laboratory for purposes of having any
- 19 laboratory work or assignment performed or any pharmacy for
- 20 purposes of purchasing any prescribed drug or any other medical
- 21 goods or devices used in connection with medical or other health
- 22 care services:
- 23 As used in this subdivision, "proprietary interest" does not
- 24 include an ownership interest in a building in which space is
- 25 leased to a clinical laboratory or pharmacy at the prevailing rate
- 26 under a lease arrangement that is not conditional upon the income

- 1 or gross receipts of the clinical laboratory or pharmacy;
- 2 (8) Exercising influence within a patient-physician
- 3 relationship for the purpose of engaging a patient in sexual
- 4 activity;
- 5 (9) Making a deceptive, untrue or fraudulent representation in
- 6 the practice of medicine and surgery or podiatry;
- 7 (10) Soliciting patients, either personally or by an agent,
- 8 through the use of fraud, intimidation or undue influence;
- 9 (11) Failing to keep written records justifying the course of
- 10 treatment of a patient, including, but not limited to, patient
- 11 histories, examination and test results and treatment rendered, if
- 12 any;
- 13 (12) Exercising influence on a patient in such a way as to
- 14 exploit the patient for financial gain of the physician or
- 15 podiatrist or of a third party. Any influence includes, but is not
- 16 limited to, the promotion or sale of services, goods, appliances or
- 17 drugs;
- 18 (13) Prescribing, dispensing, administering, mixing or
- 19 otherwise preparing a prescription drug, including any controlled
- 20 substance under state or federal law, other than in good faith and
- 21 in a therapeutic manner in accordance with accepted medical
- 22 standards and in the course of the physician's or podiatrist's
- 23 professional practice. *Provided*, That A physician who discharges
- 24 his or her professional obligation to relieve the pain and
- 25 suffering and promote the dignity and autonomy of dying patients in
- 26 his or her care and, in so doing, exceeds the average dosage of a

- 1 pain relieving controlled substance, as defined in Schedules II and
- 2 III of the Uniform Controlled Substance Act, does not violate this
- 3 article. A physician licensed under this chapter may not be
- 4 disciplined for providing expedited partner therapy in accordance
- 5 with the provisions of article four-f, chapter sixteen of this
- 6 code;
- 7 (14) Performing any procedure or prescribing any therapy that,
- 8 by the accepted standards of medical practice in the community,
- 9 would constitute experimentation on human subjects without first
- 10 obtaining full, informed and written consent;
- 11 (15) Practicing or offering to practice beyond the scope
- 12 permitted by law or accepting and performing professional
- 13 responsibilities that the person knows or has reason to know he or
- 14 she is not competent to perform;
- 15 (16) Delegating professional responsibilities to a person when
- 16 the physician or podiatrist delegating the responsibilities knows
- 17 or has reason to know that the person is not qualified by training,
- 18 experience or licensure to perform them;
- 19 (17) Violating any provision of this article or a rule or
- 20 order of the board or failing to comply with a subpoena or subpoena
- 21 duces tecum issued by the board;
- 22 (18) Conspiring with any other person to commit an act or
- 23 committing an act that would tend to coerce, intimidate or preclude
- 24 another physician or podiatrist from lawfully advertising his or
- 25 her services;
- 26 (19) Gross negligence in the use and control of prescription

- 1 forms;
- 2 (20) Professional incompetence; or
- quality with reasonable skill and safety due to physical or mental impairment, including deterioration through the aging process, loss of motor skill or abuse of drugs or alcohol. A physician or podiatrist adversely affected under this subdivision shall be afforded an opportunity at reasonable intervals to demonstrate that he or she may resume the competent practice of medicine and surgery or podiatry with reasonable skill and safety to patients. In any proceeding under this subdivision, neither the record of proceedings nor any orders entered by the board shall be used against the physician or podiatrist in any other proceeding.
- (d) The board shall deny any application for a license or other authorization to practice medicine and surgery or podiatry in this state to any applicant who, and shall revoke the license of any physician or podiatrist licensed or otherwise lawfully practicing within this state who, is found guilty by any court of competent jurisdiction of any felony involving prescribing, selling, administering, dispensing, mixing or otherwise preparing any prescription drug, including any controlled substance under state or federal law, for other than generally accepted therapeutic purposes. Presentation to the board of a certified copy of the guilty verdict or plea rendered in the court is sufficient proof thereof for the purposes of this article. A plea of nolo contendere has the same effect as a verdict or plea of guilt. Upon

1 application of a physician that has had his or her license revoked 2 because of a drug-related felony conviction, upon completion of any 3 sentence of confinement, parole, probation or other court-ordered 4 supervision and full satisfaction of any fines, judgments or other 5 fees imposed by the sentencing court, the board may issue the 6 applicant a new license upon a finding that the physician is, 7 except for the underlying conviction, otherwise qualified to 8 practice medicine: *Provided*, That the board may place whatever 9 terms, conditions or limitations it deems appropriate upon a 10 physician licensed pursuant to this subsection.

(e) The board may refer any cases coming to its attention to 11 12 an appropriate committee of an appropriate professional 13 organization for investigation and report. Except for complaints 14 related to obtaining initial licensure to practice medicine and 15 surgery or podiatry in this state by bribery or fraudulent 16 misrepresentation, any complaint filed more than two years after 17 the complainant knew, or in the exercise of reasonable diligence 18 should have known, of the existence of grounds for the complaint 19 shall be dismissed: Provided, That in cases of conduct alleged to 20 be part of a pattern of similar misconduct or professional 21 incapacity that, if continued, would pose risks of a serious or 22 substantial nature to the physician's or podiatrist's current investigating body may 23 patients, the conduct 24 investigation related to the physician's or podiatrist's current 25 capacity and qualification to practice and may recommend 26 conditions, restrictions or limitations on the physician's or 1 podiatrist's license to practice that it considers necessary for 2 the protection of the public. Any report shall contain 3 recommendations for any necessary disciplinary measures and shall 4 be filed with the board within ninety days of any referral. The 5 recommendations shall be considered by the board and the case may 6 be further investigated by the board. The board after full 7 investigation shall take whatever action it considers appropriate, 8 as provided in this section.

(f) The investigating body, as provided in subsection (e) of 9 10 this section, may request and the board under any circumstances may 11 require a physician or podiatrist or person applying for licensure 12 or other authorization to practice medicine and surgery or podiatry 13 in this state to submit to a physical or mental examination by a 14 physician or physicians approved by the board. A physician or 15 podiatrist submitting to an examination has the right, at his or 16 her expense, to designate another physician to be present at the 17 examination and make an independent report to the investigating 18 body or the board. The expense of the examination shall be paid by 19 the board. Any individual who applies for or accepts the privilege 20 of practicing medicine and surgery or podiatry in this state is 21 considered to have given his or her consent to submit to all 22 examinations when requested to do so in writing by the board and to 23 have waived all objections to the admissibility of the testimony or 24 examination report of any examining physician on the ground that 25 the testimony or report is privileged communication. If a person 26 fails or refuses to submit to an examination under circumstances

- 1 which the board finds are not beyond his or her control, failure or
- 2 refusal is prima facie evidence of his or her inability to practice
- 3 medicine and surgery or podiatry competently and in compliance with
- 4 the standards of acceptable and prevailing medical practice.
- 5 (g) In addition to any other investigators it employs, the
- 6 board may appoint one or more licensed physicians to act for it in
- 7 investigating the conduct or competence of a physician.
- 8 (h) In every disciplinary or licensure denial action, the
- 9 board shall furnish the physician or podiatrist or applicant with
- 10 written notice setting out with particularity the reasons for its
- 11 action. Disciplinary and licensure denial hearings shall be
- 12 conducted in accordance with the provisions of article five,
- 13 chapter twenty-nine-a of this code. However, hearings shall be
- 14 heard upon sworn testimony and the rules of evidence for trial
- 15 courts of record in this state shall apply to all hearings. A
- 16 transcript of all hearings under this section shall be made, and
- 17 the respondent may obtain a copy of the transcript at his or her
- 18 expense. The physician or podiatrist has the right to defend
- 19 against any charge by the introduction of evidence, the right to be
- 20 represented by counsel, the right to present and cross examine
- 21 witnesses and the right to have subpoenas and subpoenas duces tecum
- 22 issued on his or her behalf for the attendance of witnesses and the
- 23 production of documents. The board shall make all its final
- 24 actions public. The order shall contain the terms of all action
- 25 taken by the board.
- 26 (i) In disciplinary actions in which probable cause has been

- (m) Any person against whom disciplinary action has been taken 21 under the provisions of this article shall, at reasonable 22 intervals, be afforded an opportunity to demonstrate that he or she 23 can resume the practice of medicine and surgery or podiatry on a 24 general or limited basis. At the conclusion of a suspension, 25 limitation or restriction period the physician or podiatrist may 26 resume practice if the board has so ordered.

If probable cause is found to exist, all proceedings on the charges shall be open to the public who are entitled to all reports, records and nondeliberative materials introduced at the hearing, including the record of the final action taken: Provided, That any medical records, which were introduced at the hearing and which pertain to a person who has not expressly waived his or her right to the confidentiality of the records, may not be open to the public nor is the public entitled to the records.

- 13 (b) It is unlawful for the proprietor of any store or 14 pharmacy, any "ambulatory health care facility", as that term is 15 defined in section one, article five-b, chapter sixteen of this 16 code, that offers pharmaceutical care, or a facility operated to 17 provide health care or mental health care services free of charge 18 or at a reduced rate and that operates a charitable clinic pharmacy 19 to permit any person not a pharmacist to compound or dispense 20 prescriptions or prescription refills or to retail or dispense the 21 poisons and narcotic drugs named in sections two, three and six, 22 article eight, chapter sixteen of this code: Provided, That a 23 licensed intern may compound and dispense prescriptions or 24 prescription refills under the direct supervision of a pharmacist: 25 Provided, however, That registered pharmacy technicians may assist

- 1 in the preparation and dispensing of prescriptions or prescription 2 refills, including, but not limited to, reconstitution of liquid 3 medications, typing and affixing labels under the direct

- (g) No pharmacist may compound or dispense any prescription order when he or she has knowledge that the prescription was issued by a practitioner without establishing a valid practitioner-patient relationship. An online or telephonic evaluation by questionnaire, or an online or telephonic consultation, is inadequate to establish a valid practitioner-patient relationship: *Provided*, That this prohibition does not apply:

- 21 §30-7-15a. Prescriptive authority for prescription drugs;

- 23 (a) The board may, in its discretion, authorize an advanced 24 practice registered nurse to prescribe prescription drugs in a
- 25 collaborative relationship with a physician licensed to practice in

- 1 West Virginia and in accordance with applicable state and federal
- 2 laws. An authorized advanced practice registered nurse may write
- 3 or sign prescriptions or transmit prescriptions verbally or by
- 4 other means of communication.

Drugs listed under Schedule III shall be limited to 6 a 72-hour supply without refill. - 1 (a) As used in this section:
- 2 (1) "Approved program" means an educational program for
- 3 osteopathic physician assistants approved and accredited by the
- 4 Committee on Allied Health Education and Accreditation or its
- 5 successor.
- 6 (2) "Board" means the Board of Osteopathy established under
- 7 the provisions of article fourteen, chapter thirty of this code.
- 8 (3) "Direct supervision" means the presence of the supervising
- 9 physician at the site where the osteopathic physician assistant
- 10 performs medical duties.
- 11 (4) "Health care facility" means any licensed hospital,
- 12 nursing home, extended care facility, state health or mental
- 13 institution, clinic or physician's office.
- 14 (5) "License" means a certificate issued to an osteopathic
- 15 physician assistant who has passed the examination for a primary
- 16 care or surgery physician assistant administered by the National
- 17 Board of Medical Examiners on behalf of the National Commission on
- 18 Certification of Physician Assistants. All osteopathic physician
- 19 assistants holding valid certificates issued by the board prior to

various disciplines to prescribe without disciplinary actions from
