14	to improving state emergency preparedness; creating an
15	emergency generator tax credit for gas or propane fueled
16	machines; requiring the Office of Emergency Services to

19	the location of emergency shelters; and providing a protection
20	from civil or criminal liability to persons donating food
21	during times of emergencies.
22	Be it enacted by the Legislature of West Virginia:
23	That the Code of West Virginia, 1931, as amended, be amended
24	by adding thereto a new article, designated \$11-13DD-1, \$11-13DD-2

- 1 and \$11-13DD-3; that \$15-5-21 of said code be amended and

- 4 CHAPTER 11. TAXATION.
- 5 ARTICLE 13DD. EMERGENCY GENERATOR TAX CREDIT.
- 6 §11-13DD-1. Amount of credit.
- 7 A taxpayer who installs or causes to be installed an emergency
- 8 generator powered by natural gas or propane on property located in
- 9 this state and used as a place of business or residence by the
- 10 taxpayer after July 1, 2014, is allowed a credit against the taxes
- 11 imposed in articles twenty-one, twenty-three and twenty-four of
- 12 this chapter in an amount equal to thirty percent of the cost to
- 13 purchase and install the system up to a maximum amount of \$3,000.
- 14 §11-13DD-2. Restrictions.
- 15 In order to receive the credit for an emergency generator, the
- 16 generator shall use natural gas or propane fueled machines for its
- 17 operation. The generator shall be permanently installed and wired
- 18 to the electrical panel in the residence or building with
- 19 insulating back-flow and shut off protection.
- 20 §11-13DD-3. Carryover credit allowed; Tax Commissioner to propose
- 21 <u>rules.</u>
- 22 If the amount of the credit exceeds the taxpayer's liability
- 23 for the taxable year, the amount which exceeds the tax liability

- 1 may be carried over and applied as a credit against the tax
- 2 liability of the taxpayer pursuant to the provisions of articles
- 3 twenty-one, twenty-three and twenty-four of this chapter to each of
- 4 the next taxable years unless sooner used.
- 5 The State Tax Commissioner shall propose rules for legislative

- 17 <u>(a)</u> The Office of Emergency Services shall ascertain what 18 means exist for rapid and efficient communication in times of
- 19 disaster. The office shall consider the desirability of
- 20 supplementing such communication resources or of integrating them
- 21 into a comprehensive state or federal-state telecommunications or
- 22 other communications system or network. In studying the character

- 13 ARTICLE 7D. GOOD SAMARITAN FOOD DONATION ACT.
- 14 §55-7D-1. Legislative findings.
- The Legislature finds that wholesale and retail food
- 16 distributors, shipping terminals and other establishments across
- 17 the state are disposing of food that could be made available to
- 18 those in need. However, many potential food donors are discouraged
- 19 from donating this food because of potential liability. The United
- 20 States Congress has recognized the need to encourage food
- 21 distributors to make otherwise disposed-of food products available
- 22 to those in need and has adopted Title 42 United States Code §1791
- 23 entitled the "Bill Emerson Good Samaritan Food Donation Act." This

- 1 federal law encourages state and local governments to enact good
- 2 samaritan or donor liability limitation laws to encourage private
- 3 cooperative efforts to provide food for hungry people within their
- 4 respective jurisdictions. The Legislature finds that this is a
- 5 worthy goal, and therefore it is appropriate for the state to
- 6 encourage participation in food donation programs by providing a
- 7 statutory framework to protect food donators from liability for
- 8 their good faith efforts, including food donators during declared
- 9 states of emergency to local emergency centers.

NOTE: The purpose of this bill is to improve state emergency preparedness. It requires the Office of Emergency Services to coordinate with local radio and television stations to broadcast public service announcements with information as to the location of emergency shelters. The bill provides tax credits for use of natural gas or propane fueled emergency generators. The bill also provides a protection from civil or criminal liability to persons who donate food during times of emergencies.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.

Chapter 11, Article 13DD is new; therefore, it has been completely underscored.
