- 11 (f) (e) "NAIC" means the National Association of Insurance Commissioners.
- 12 (g) (f) "Life and/or health insurer" means any insurance company licensed under article three

- 4 every domestic insurer shall file its RBC report:

- 17 (3) The interest rate risk with respect to the insurer's business; and
- 18 (4) All other business risks and any other relevant risks set forth in the RBC instructions
- 19 determined in each case by applying the factors in the manner set forth in the RBC instructions.
- 20 (c) A property and casualty insurer's RBC and an HMO's RBC shall be determined in
- 21 accordance with the applicable formula set forth in the RBC instructions. The formula shall take into
- 22 account (and may adjust for the covariance between), determined in each case by applying the factors

1 in the manner set forth in the RBC instructions:

- 2 (1) Asset risk;
- 3 (2) Credit risk;
- 4 (3) Underwriting risk; and
- 5 (4) All other business risks and any other relevant risks as are set forth in the RBC 6 instructions.
- (d) An excess of capital over the amount produced by the risk-based capital requirements contained in this article and the formulas, schedules and instructions referenced in this article is desirable in the business of insurance. Accordingly, insurers and HMOs should seek to maintain capital above the RBC levels required by this article. Additional capital is used and useful in the insurance business and helps to secure insurers and HMOs against various risks inherent in, or affecting, the business of insurance and not accounted for or only partially measured by the risk-based capital requirements contained in this article.
- (e) If a domestic insurer files an RBC report which, in the judgment of the commissioner is inaccurate, then the commissioner shall adjust the RBC report to correct the inaccuracy and shall notify the insurer of the adjustment. The notice shall contain a statement of the reason for the adjustment. An RBC report that is adjusted is referred to as an "Adjusted RBC Report".

- 19 (a) "Company action level event" means any of the following events:
- 20 (1) The filing of an RBC report by an insurer which indicates that:
- 21 (A) The insurer's total adjusted capital is greater than or equal to its regulatory action level

- 13 (d) Within sixty days after the submission by an insurer of an RBC plan to the commissioner,

- 3 (e) In the event of If there is a notification by the commissioner to an insurer that the insurer's

- 5 discretion, subject to the insurer's right to a hearing under section seven of this article, specify in the
- 6 notification that the notification constitutes a regulatory action level event.
- 7 (f) Every domestic insurer that files an RBC plan or revised RBC plan with the commissioner
- 8 shall file a copy of the RBC plan or revised RBC plan with the Insurance Commissioner in any state
- 9 in which the insurer is authorized to do business if:
- 10 (1) The state has an RBC provision substantially similar to subsection (a), section eight of

- 12 (2) The Insurance Commissioner of that state has notified the insurer of its request for the

- 15 proceedings. Notwithstanding any of the provisions of this subdivision, the commissioner may
- 16 forego action for up to ninety days after the mandatory control level event if the commissioner finds
- 17 there is a reasonable expectation that the mandatory control level event may be eliminated within

- 19 (2) With respect to a property and casualty insurer, the commissioner shall take any actions

Notwithstanding any of the provisions of this subdivision, the commissioner may forego action for up to ninety days after the mandatory control level event if the commissioner finds there is a reasonable expectation that the mandatory control level event may be eliminated within the ninety-day period.

- 13 the hearing, which shall be no less than fifteen nor more than forty-five days after the date of the
- 14 insurer's request.
- 15 (f) To the extent that the provisions of this section conflict with any other provisions
- 16 applicable to HMOs, the provisions of this section apply.
- 17 ARTICLE 40A. RISKED-BASED CAPITAL FOR HEALTH ORGANIZATIONS.

- 8 hospital, medical and dental indemnity or service corporation licensed under article twenty-four of
- 9 this chapter or other managed care organization licensed under article twenty-five of this chapter.
- 10 This definition does not include an organization that is licensed under article three of this chapter
- 11 as either a life or health insurer or a property and casualty insurer and that is otherwise subject to
- 12 either the life and health or property and casualty RBC requirements.
- 13 (f) "NAIC" means the National Association of Insurance Commissioners.
- 14 (g) "Negative trend" means a negative trend over a period of time, as determined in
- 15 accordance with the trend test calculation included in the RBC instructions.
- 16 (h) "RBC instructions" means the RBC report including risk-based capital instructions
- 17 adopted by the NAIC, as these RBC instructions may be amended by the NAIC from time to time
- 18 in accordance with the procedures adopted by the NAIC.
- (i) "RBC level" means a health organization's company action level RBC, regulatory action
- 20 level RBC, authorized control level RBC, or mandatory control level RBC where:
- 21 (1) "Company action level RBC" means, with respect to any health organization, the product
- 22 of 2.0 and its authorized control level RBC;

1	(2) "Regulatory action level RBC" means the product of 1.5 and its authorized control level
2	RBC;
3	(3) "Authorized Control Level RBC" means the number determined under the risk-based
4	capital formula in accordance with the RBC instructions;
5	(4) "Mandatory Control Level RBC" means the product of .70 and the authorized control
6	level RBC.
7	(j) "RBC plan" means a comprehensive financial plan containing the elements specified in
8	subsection (b), section three of this article. If the commissioner rejects the RBC plan, and it is
9	revised by the health organization, with or without the commissioner's recommendation, the plan
10	shall be called the "revised RBC plan."
11	(k) "RBC report" means the report required in section two of this article.
12	(l) "Total adjusted capital" means the sum of:
13	(1) A health organization's statutory capital and surplus (i.e. net worth) as determined in
14	accordance with the statutory accounting application to the annual financial statements required to
15	be filed under:
16	(A) Section four, article twenty-four of this chapter;
17	(B) Section nine, article twenty-five of this chapter;
18	(C) Section nine, article twenty-five-a of this chapter; or
19	(D) Section twelve, article twenty-five-d of this chapter; and
20	(2) Such other items, if any, as the RBC instructions may provide.

(a) A domestic health organization, on or prior to each March 1, (the "filing date"), shall

- 1 prepare and submit to the commissioner a report of its RBC levels as of the end of the calendar year

- 11 necessary to place the health organization under regulatory control under article ten of this chapter.
- 12 In that event, the mandatory control level event is sufficient grounds for the commissioner to take
- 13 action under article ten of this chapter, and the commissioner has the rights, powers and duties with
- 14 respect to the health organization as are set forth in article ten of this chapter. If the commissioner
- 15 takes actions pursuant to an adjusted RBC report, the health organization is entitled to the protections
- 16 of section four-b, article ten of this chapter pertaining to summary proceedings. Notwithstanding any
- 17 of the foregoing, the commissioner may forego action for up to ninety days after the mandatory
- 18 control level event if the commissioner finds there is a reasonable expectation that the mandatory
- 19 control level event may be eliminated within the ninety-day period.

20 **§33-40A-7.** Hearings.

- Upon the occurrence of any of the following events the health organization has the right to
- 22 a confidential departmental hearing, on a record, at which the health organization may challenge any

- 1 determination or action by the commissioner. The health organization shall notify the commissioner
- 2 of its request for a hearing within five days after the notification by the commissioner under
- 3 subsections (a), (b), (c) or (d) of this section. Upon receipt of the health organization's request for
- 4 a hearing, the commissioner shall set a date for the hearing, which shall be no less than ten nor more
- 5 than thirty days after the date of the health organization's request. The events include:
- 6 (a) Notification to a health organization by the commissioner of an adjusted RBC report;
- 7 (b) Notification to a health organization by the commissioner that:
- 8 (1) The health organization's RBC plan or revised RBC plan is unsatisfactory; and
- 9 (2) Notification constitutes a regulatory action level event with respect to the health
- 10 <u>organization;</u>
- 11 (c) Notification to a health organization by the commissioner that the health organization has
- 12 failed to adhere to its RBC plan or revised RBC plan and that the failure has a substantial adverse
- 13 effect on the ability of the health organization to eliminate the company action level event with
- 14 respect to the health organization in accordance with its RBC plan or revised RBC plan; or
- (d) Notification to a health organization by the commissioner of a corrective order with
- 16 respect to the health organization.
- 17 §33-40A-8. Confidentiality; prohibition on announcements; prohibition on use in rate making.
- 18 (a) All RBC reports (to the extent the information is not required to be set forth in a publicly
- 19 available annual statement schedule) and RBC plans (including the results or report of any
- 20 examination or analysis of a health organization performed pursuant to this statute and any corrective
- 21 order issued by the commissioner pursuant to examination or analysis) with respect to a domestic
- 22 health organization or foreign health organization that are in the possession or control of the

- 1 commissioner shall be confidential by law and privileged, are not subject to the provisions of chapter
- 2 twenty-nine-b of this code, are not subject to subpoena, and are not subject to discovery or
- 3 admissible in evidence in any private civil action. However, the commissioner may use the
- 4 documents, materials or other information in the furtherance of any regulatory or legal action brought
- 5 as a part of the commissioner's official duties.
- 6 (b) Neither the commissioner nor any person who received documents, materials or other
- 7 information while acting under the authority of the commissioner are permitted or required to testify
- 8 in any private civil action concerning any confidential documents, materials or information subject
- 9 to subsection (a) of this section.
- (c) In order to assist in the performance of the commissioner's duties, the commissioner:
- 11 (1) May share documents, materials or other information, including the confidential and
- 2 privileged documents, materials or information subject to subsection (a) of this section, with other
- 13 state, federal and international regulatory agencies, with the NAIC and its affiliates and subsidiaries,
- 14 and with state, federal and international law-enforcement authorities the recipient agrees to maintain
- 15 the confidentiality and privileged status of the document, material or other information;
- 16 (2) May receive documents, materials or information, including otherwise confidential and
 - 7 privileged documents, materials or information, from the NAIC and its affiliates and subsidiaries,
- 18 and from regulatory and law-enforcement officials of other foreign or domestic jurisdictions, and
- 19 shall maintain as confidential or privileged any document, material or information received with
- 20 notice or the understanding that it is confidential or privileged under the laws of the jurisdiction that
- 21 is the source of the document, material or information; and
- 22 (3) May enter into agreements governing sharing and use of information consistent with this

1 subsection.

- 2 (d) No waiver of any applicable privilege or claim of confidentiality in the documents,
- 3 materials or information may occur as a result of disclosure to the commissioner under this section
- 4 or as a result of sharing as authorized in subdivision (3), subsection (c) of this section.
- 5 (e) It is the finding of the Legislature that the comparison of a health organization's total adjusted capital to any of its RBC levels is a regulatory tool which may indicate the need for corrective action with respect to the health organization, and is not intended as a means to rank health organizations generally. Therefore, except as otherwise required under the provisions of this article, the making, publishing, disseminating, circulating or placing before the public, or causing, directly or indirectly to be made, published, disseminated, circulated or placed before the public, in a newspaper, magazine or other publication, or in the form of a notice, circular, pamphlet, letter or 11 12 poster, or over a radio or television station, or in any other way, an advertisement, announcement or statement containing an assertion, representation or statement with regard to the RBC levels of any health organization, or of any component derived in the calculation by any health organization, agent, 14 15 broker or other person engaged in any manner in the insurance business would be misleading and is therefore prohibited: Provided, That if any materially false statement with respect to the comparison regarding a health organization's total adjusted capital to its RBC levels (or any of them) or an inappropriate comparison of any other amount to the health organization's RBC levels is 18 19 published in any written publication and the health organization is able to demonstrate to the commissioner with substantial proof the falsity of the statement, or the inappropriateness, as the case may be, then the health organization may publish an announcement in a written publication if the 22 sole purpose of the announcement is to rebut the materially false statement.

1	(f) It is the further finding of the Legislature that the RBC instructions, RBC reports, adjusted
2	RBC reports, RBC plans and revised RBC plans are intended solely for use by the commissioner in
3	monitoring the solvency of health organizations and the need for possible corrective action with
4	respect to health organizations and shall not be used by the commissioner for rate making not
5	considered or introduced as evidence in any rate proceeding nor used by the commissioner to
6	calculate or derive any elements of an appropriate premium level or rate of return for any line or
7	insurance that a health organization or any affiliate is authorized to write.
8	§33-40A-9. Supplemental provisions; rules; exemption.
9	(a) The provisions of this article are supplemental to any other provisions of the laws of this
10	state, and do not preclude or limit any other powers or duties of the commissioner under such laws
11	including, but not limited to, article ten and article thirty-four of this chapter.
12	(b) The commissioner may propose reasonable rules for legislative approval in accordance
13	with chapter twenty-nine-a of this code, as are necessary or proper to effectuate the purposes of this
14	article and to prevent circumvention and evasion thereof.
15	(c) The commissioner may exempt from the application of this article a domestic health
16	organization that:
17	(1) Writes direct business only in this state;
18	(2) Assumes no reinsurance in excess of five percent of direct premiums written; and
19	(3) Writes direct annual premiums for comprehensive medical business of \$2 million or less
20	<u>or</u>
21	(4) Is a limited health service organization that covers less than two thousand lives.

22 §33-40A-10. Foreign health organizations.

- 1 (a) (1) A foreign health organization, upon the written request of the commissioner, shall
- 2 submit to the commissioner an RBC report, as of the end of the calendar year just ended, not later
- 3 than the later of:
- 4 (A) The date an RBC report would be required to be filed by a domestic health organization
- 5 under this article; or
- 6 (B) Fifteen days after the request is received by the foreign health organization.
- 7 (2) A foreign health organization, at the written request of the commissioner, shall promptly
- 8 submit to the commissioner a copy of any RBC plan that is filed with the insurance commissioner
- 9 of any other state.
- 10 (b) If there is a company action level event, regulatory action level event or authorized
- 11 control level event with respect to a foreign health organization as determined under the RBC statute
- 12 applicable in the state of domicile of the health organization (or, if no RBC statute is in force in that
- 13 state, under the provisions this article), if the Insurance Commissioner of the state of domicile of the
- 14 foreign health organization fails to require the foreign health organization to file an RBC plan in the
- 15 manner specified under that state's RBC statute (or, if no RBC statute is in force in that state, under
- 6 section three of this article), the commissioner may require the foreign health organization to file an
- 7 RBC plan with the commissioner. In that event, the failure of the foreign health organization to file
- 18 an RBC plan with the commissioner is grounds to order the health organization to cease and desist
- 19 from writing new insurance business in this state.
- 20 (c) If there is a mandatory control level event with respect to a foreign health organization,
- 21 and no domiciliary receiver has been appointed with respect to the foreign health organization under
- 22 the rehabilitation and liquidation statute applicable in the state of domicile of the foreign health

- 1 organization, the commissioner may make application to the Circuit Court of Kanawha County
- 2 permitted under section two, article ten of this chapter with respect to the liquidation of property of
- 3 foreign health organizations found in this state, and the occurrence of the mandatory control level
- 4 even shall be considered adequate grounds for the application.

5 §33-40A-11. Immunity.

- There is no liability on the part of, and no cause of action may arise against, the
- 7 commissioner or the West Virginia insurance department or its employees or agents for any action
- 8 taken by them in the performance of their powers and duties under this article.

9 §33-40A-12. Notices.

- All notices by the commissioner to a health organization that may result in regulatory action
- 11 under this article are effective upon dispatch if transmitted by registered or certified mail, or in the
- 12 case of any other transmission shall be effective upon the health organization's receipt of notice.

13 **§33-40A-13.** Effective date.

14 This article becomes effective immediately upon its enactment.

NOTE: The purpose of this bill is to adopt a National Association of Insurance Commissioners' model to establish standards for minimum capital and surplus to be maintained by a health organization and provide for the early detection of a potentially hazardous or otherwise dangerous financial condition of a health organization in order to protect its enrollees and the general public.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.

Article 40A is new. Therefore it has been completely underscored.
