4 ARTICLE 8A. THE COMPASSIONATE USE ACT FOR MEDICAL CANNABIS.

5 **§16-8A-1. Findings.**

- 6 (a) Marihuana's recorded use as a medicine goes back nearly five thousand years. Modern
- 7 medical research has confirmed the beneficial uses for marihuana in treating or alleviating the pain,
- 8 nausea and other symptoms associated with a variety of debilitating medical conditions, including
- 9 cancer, multiple sclerosis and HIV/AIDS, as found by the National Academy of Sciences' Institute
- 10 of Medicine in March 1999.
- 11 (b) Studies, published since the 1999 Institute of Medicine report, have continued to show
- 12 the therapeutic value of marihuana in treating a wide array of debilitating medical conditions. These
- 13 include relief of the neuropathic pain caused by multiple sclerosis, HIV/AIDS and other illnesses and
- 14 injuries that often fails to respond to conventional treatments and relief of nausea, vomiting and other
- 15 side effects of drugs used to treat HIV/AIDS and hepatitis C, increasing the chances of patients
- 16 continuing on life-saving treatment regimens.
- 17 (c) Marihuana has many currently accepted medical uses in the United States, having been
- 18 recommended by thousands of licensed physicians to more than one million patients in states with
- 19 medical marihuana laws. Marihuana's medical utility has been recognized by a wide range of
- 20 medical and public health organizations, including the American Academy of HIV Medicine, the
- 21 American College of Physicians, the American Nurses Association, the American Public Health
- 22 Association, the Leukemia & Lymphoma Society and many others.

- 1 (d) Data from the Federal Bureau of Investigation's Uniform Crime Reports and the
- 2 Compendium of Federal Justice Statistics show that approximately ninety-nine out of every one
- 3 hundred marihuana arrests in the United States are made under state law, rather than under federal
- 4 <u>law. Consequently, changing state law will have the practical effect of protecting from arrest the vast</u>
- 5 majority of seriously ill patients who have a medical need to use marihuana.
- 6 (e) Alaska, Arizona, California, Colorado, Connecticut, Delaware, Hawaii, Illinois, Maine,
- 7 Massachusetts, Michigan, Montana, Nevada, New Hampshire, New Jersey, New Mexico, Oregon,
- 8 Vermont, Rhode Island, Washington state and the District of Columbia have removed state-level
- 9 criminal penalties from the medical use and cultivation of marihuana. West Virginia joins in this
- 10 effort for the health and welfare of its citizens.
- 11 (f) States are not required to enforce federal law or prosecute people for engaging in activities
- 12 prohibited by federal law. Therefore, compliance with this article does not put the State of West
- 13 Virginia in violation of federal law.
- 14 (g) State law should make a distinction between the medical and nonmedical uses of
- 15 marihuana. Hence, the purpose of this article is to protect patients with debilitating medical
- 16 conditions, as well as their practitioners and providers, from arrest and prosecution, criminal and
- 17 other penalties and property forfeiture, if the patients engage in the medical use of marihuana.
- 18 **§16-8A-2.** Definitions.
- 19 For purposes of this article, unless the context otherwise requires:
- 20 (a) "Bona fide practitioner-patient relationship" means:
- 21 (1) A practitioner and patient have a treatment or consulting relationship, during the course
- 22 of which the physician has completed a full assessment of the patient's medical history and current

- 1 medical condition, including an appropriate personal physical examination;
- 2 (2) The practitioner has consulted with the patient with respect to the patient's debilitating
- 3 medical condition; and
- 4 (3) The physician is available to or offers to provide follow-up care and treatment to the
- 5 patient, including, but not limited to, patient examinations.
- 6 (b) "Cardholder" means a qualifying patient or a designated caregiver who has been issued
- 7 and possesses a valid registry identification card.
- 8 (c) "Compassion center agent" means a principal officer, board member, employee or agent
- 9 of a registered compassion center who is twenty-one years of age or older and has not been convicted
- 10 of a disqualifying felony offense.
- 11 (d) "Debilitating medical condition" means:
- 12 (1) Cancer, glaucoma, positive status for human immunodeficiency virus, acquired immune
- 13 deficiency syndrome, hepatitis C, amyotrophic lateral sclerosis, Crohn's disease, agitation of
- 14 Alzheimer's disease, Parkinson's disease, post-traumatic stress disorder, depression, anxiety,
- 15 addiction to opiates or amphetamines or the treatment of these conditions;
- 16 (2) A chronic or debilitating disease or medical condition or its treatment that produces one
- 17 or more of the following: Cachexia or wasting syndrome; severe or chronic pain; severe nausea;
- 18 seizures; or severe and persistent muscle spasms, including, but not limited to, those characteristic
- 19 of multiple sclerosis; or
- 20 (3) Any other medical condition or its treatment added by the department, as provided in
- 21 section six of this article.
- (e) "Department" means the West Virginia Department of Health and Human Resources or

- 2 (f) "Designated caregiver" means a person who:
- 3 (1) Is at least twenty-one years of age;
- 4 (2) Has agreed to assist with a patient's medical use of marihuana;
- 5 (3) Has not been convicted of a disqualifying felony offense; and
- 6 (4) Assists no more than five qualifying patients with their medical use of marihuana.
- 7 (g) "Disqualifying felony offense" means:
- 8 (1) A violent crime that was classified as a felony in the jurisdiction where the person was
- 9 convicted; or
- 10 (2) A violation of a state or federal controlled substance law that was classified as a felony
- 11 in the jurisdiction where the person was convicted, not including:
- 12 (A) An offense for which the sentence, including any term of probation, incarceration or
- 3 supervised release was completed ten or more years earlier; or
- (B) An offense that consisted of conduct for which this article would likely have prevented
- 15 a conviction, but the conduct either occurred prior to the enactment of this article or was prosecuted
- 16 by an authority other than the State of West Virginia.
- 17 (h) "Enclosed, locked facility" means a closet, room, greenhouse, building or other enclosed
- 18 area that is equipped with locks or other security devices that permit access only by the cardholder
- 19 allowed to cultivate the plants or, in the case of a registered compassion center, the compassion
- 20 center agents working for the registered compassion center. Two or more registered qualifying
- 21 patients or registered designated caregivers who reside in the same dwelling and have a registry
- 22 identification card that removes state penalties for marihuana cultivation may share one enclosed,

- 1 <u>locked facility for cultivation.</u>
- 2 (i) "Marihuana" has the meaning given that term in section 101, article one, chapter sixty-a
- 3 of this code.
- 4 (j) "Mature marihuana plant" means a marihuana plant with one or more of the following
- 5 characteristics:
- 6 (1) The plant has flowers;
- 7 (2) The plant is twelve or more inches in height; or
- 8 (3) The plant is twelve inches or greater in diameter.
- 9 (k) "Medical use" includes the acquisition, administration, cultivation or manufacture in an
- 10 enclosed, locked facility, delivery, possession, transfer, transportation or use of marihuana or
- 11 paraphernalia relating to the administration of marihuana to treat or alleviate a registered qualifying
- 12 patient's debilitating medical condition or symptoms associated with the patient's debilitating
- 13 medical condition. It does not include cultivation by a visiting qualifying patient or cultivation by
- 14 a registered designated caregiver or registered qualifying patient who is not designated as being
- 15 allowed to cultivate.
- (1) "Practitioner" means a person who is licensed with authority to prescribe drugs to humans
- 17 under the provisions of section one-b, article five, chapter thirty of this code, except as otherwise
- 18 provided in this subsection. If the qualifying patient's debilitating medical condition is post-traumatic
- 19 stress disorder, the practitioner must be a licensed psychiatrist. In relation to a visiting qualifying
- 20 patient, "practitioner" means a person who is licensed with authority to prescribe drugs to humans
- 21 in the state of the patient's residence.
- (m) "Qualifying patient" means a person who has been diagnosed by a practitioner as having

- 2 (n) "Registered compassion center" means a not-for-profit entity registered pursuant to
- 3 section fourteen of this article that acquires, possesses, cultivates, manufactures, delivers, transfers,
- 4 transports, sells, supplies or dispenses marihuana, paraphernalia or related supplies and educational
- 5 materials to registered qualifying patients.
- 6 (o) "Registry identification card" means a document issued by the department that identifies
- 7 <u>a person as a registered qualifying patient or registered designated caregiver.</u>
- 8 (p) "Registered safety compliance facility" means an entity registered under section fifteen
- 9 by the department to provide one or more of the following services:
- 10 (1) Testing marihuana produced for medical use, including for potency and contaminants;
- 11 and
- 12 (2) Training cardholders and compassion center agents. The training may include, but need
- 13 not be limited to, information related to one or more of the following:
- 14 (A) The safe and efficient cultivation, harvesting, packaging, labeling and distribution of
- 15 marihuana;
- 16 (B) Security and inventory accountability procedures; and
- 17 (C) Up-to-date scientific and medical research findings related to medical marihuana.
- 18 (q) "Safety compliance facility agent" means a principal officer, board member, employee
- 19 or agent of a registered safety compliance facility who is twenty-one years of age or older and has
- 20 not been convicted of a disqualifying felony offense.
- 21 (r) "Seedling" means a marihuana plant that has no flowers, is less than twelve inches in
- 22 height and is less than twelve inches in diameter.

- 1 (s) "Usable marihuana" means the flowers of the marihuana plant and any mixture or
- 2 preparation thereof, but does not include the seeds, stalks and roots of the plant. It does not include
- 3 the weight of any nonmarihuana ingredients combined with marihuana, including ingredients added
- 4 to prepare a topical administration, food or drink.
- 5 (t) "Verification system" means a phone or Web-based system established and maintained
- 6 by the department that is available to law-enforcement personnel and compassion center agents on
- 7 a twenty-four-hour basis for verification of registry identification cards.
- 8 (u) "Visiting qualifying patient" means a person who:
- 9 (1) Has been diagnosed with a debilitating medical condition;
- 10 (2) Possesses a valid registry identification card, or its equivalent, that was issued pursuant
- 11 to the laws of another state, district, territory, commonwealth, insular possession of the United States
- 12 or country recognized by the United States that allows the person to use marihuana for medical
- 13 purposes in the jurisdiction of issuance; and
- 14 (3) Is not a resident of West Virginia or who has been a resident of West Virginia for less
- 15 than thirty days.
- (v) "Written certification" means a document dated and signed by a practitioner, stating that
- 7 in the practitioner's professional opinion the patient is likely to receive therapeutic or palliative
- 18 benefit from the medical use of marihuana to treat or alleviate the patient's debilitating medical
- 19 condition or symptoms associated with the debilitating medical condition. A written certification
- 20 shall affirm that it is made in the course of a bona fide practitioner-patient relationship and shall
- 21 specify the qualifying patient's debilitating medical condition.
- 22 §16-8A-3. Protections for the medical use of cannabis.

- 1 (a) A registered qualifying patient is not subject to arrest, prosecution or denial of any right
- 2 or privilege including, but not limited to, civil penalty or disciplinary action by a court or
- 3 occupational or professional licensing board or bureau, for the medical use of marihuana pursuant
- 4 to this article, if the registered qualifying patient does not possess more than:
- 5 (1) Six ounces of usable marihuana; and
- 6 (2) Twelve mature marihuana plants and twelve seedlings, if the qualifying patient has not
- 7 specified that a designated care giver will be allowed under state law to cultivate marihuana for the
- 8 qualifying patient.
- 9 (b) A registered designated caregiver is not subject to arrest, prosecution or denial of any
- 10 right or privilege including, but not limited to, civil penalty or disciplinary action by a court or
- 11 occupational or professional licensing board or bureau:
- 12 (1) For assisting a registered qualifying patient to whom he or she is connected through the
- 13 department's registration process with the medical use of marihuana if the designated caregiver does
- 14 not possess more than:
- 15 (A) Six ounces of usable marihuana for each qualifying patient to whom the registered
- 16 caregiver is connected through the department's registration process; and
- 17 (B) Twelve mature marihuana plants and twelve seedlings for each registered qualifying
- 18 patient who has specified that the designated caregiver will be allowed under state law to cultivate
- 19 marihuana for the qualifying patient.
- 20 (2) For receiving compensation for costs associated with assisting a registered qualifying
- 21 patient's medical use of marihuana if the registered designated caregiver is connected to the
- 22 registered qualifying patient through the department's registration process.

1 (c) All mature marihuana plants and seedlings possessed pursuant to this section must be kept in an enclosed, locked facility, unless they are being transported to a permissible location, including because the cardholder is moving, the registered qualifying patient has changed his or her designation of who can cultivate or the plants are being given to someone allowed to possess them pursuant to this article. 5 6 (d) A visiting qualifying patient is not subject to arrest, prosecution or denial of any right or privilege including, but not limited to, civil penalty or disciplinary action by a court or occupational or professional licensing board or bureau, for the medical use of marihuana pursuant to this article if the visiting qualifying patient does not possess more than six ounces of usable marihuana. 10 (e) A registered qualifying patient, visiting qualifying patient or registered designated caregiver is not subject to arrest, prosecution or denial of any right or privilege including, but not 11 limited to, civil penalty or disciplinary action by a court or occupational or professional licensing 13 board or bureau for: 14 (1) Possession of marihuana that is incidental to medical use, but is not mature marihuana 15 plants, seedlings or usable marihuana as defined in this article; 16 (2) Selling, transferring, or delivering marihuana seeds produced by the registered qualifying patient, visiting qualifying patient or registered designated caregiver to a registered compassion 18 center; 19 (3) Transferring marihuana to a registered safety compliance facility for testing; or 20 (4) Giving marihuana to a registered qualifying patient, a registered compassion center or a registered designated caregiver for a registered qualifying patient's medical use where nothing of

22 value is transferred in return or for offering to do this, if the person giving the marihuana does not

- 1 knowingly cause the recipient to possess more marihuana than is permitted by this section.
- 2 (f) (1) There is a presumption that a qualifying patient is engaged in, or a designated
- 3 caregiver is assisting with, the medical use of marihuana in accordance with this article if the
- 4 qualifying patient or designated caregiver:
- 5 (A) Is in possession of a valid registry identification card or, in the case of a visiting
- 6 qualifying patient, its equivalent; and
- 7 (B) Is in possession of an amount of marihuana that does not exceed the amount allowed
- 8 under the provisions of this section.
- 9 (2) The presumption may be rebutted by evidence that conduct related to marihuana was not
- 10 for the purpose of treating or alleviating the qualifying patient's debilitating medical condition or
- 11 symptoms associated with the debilitating medical condition in compliance with this article.
- 12 (g) A practitioner is not subject to arrest, prosecution or penalty in any manner or denied any
- 13 right or privilege including, but not limited to, civil penalty or disciplinary action by the West
- 14 Virginia Board of Medicine or by any other occupational or professional licensing board or bureau,
- 15 solely for providing written certifications or for otherwise stating that, in the practitioner's
- 16 professional opinion, a patient is likely to receive therapeutic or palliative benefit from the medical
- 17 use of marihuana to treat or alleviate the patient's serious or debilitating medical condition or
- 18 symptoms associated with the serious or debilitating medical condition: *Provided*, That nothing in
- 19 this article prevents a practitioner from being sanctioned for:
- 20 (1) Issuing a written certification to a patient with whom the practitioner does not have a bona
- 21 fide practitioner-patient relationship, or
- 22 (2) Failing to properly evaluate a patient's medical condition or otherwise violating the

1 standard of care.

- 2 (h) A person is not subject to arrest, prosecution or denial of any right or privilege including,
- 3 but not limited to, civil penalty or disciplinary action by a court or occupational or professional
- 4 licensing board or bureau, for:
- 5 (1) Selling marihuana paraphernalia to a cardholder upon presentation of a registry
- 6 identification card in the recipient's name that has not expired or to a compassion center agent or
- 7 registered safety compliance facility agent upon presentation of an unexpired copy of the entity's
- 8 registration certificate;
- 9 (2) Being in the presence or vicinity of the medical use of marihuana as allowed under this
- 10 article; or
- 11 (3) Assisting a registered qualifying patient with using or administering marihuana. For
- 12 purposes of illustration and not limitation, this includes preparing a vaporizer for a registered
- 13 qualifying patient's use or brewing tea for a registered qualifying patient. It does not include
- 14 providing marihuana to a patient that the patient did not already possess.
- (i) A registered compassion center is not subject to prosecution under state or municipal law,
- 16 search or inspection, except by the department pursuant to subsection (o) of this section, seizure or
- 7 penalty in any manner or be denied any right or privilege including, but not limited to, civil penalty
- 18 or disciplinary action by a court or business licensing board or entity, for acting pursuant to this
- 19 article and department regulations to: Sell marihuana seeds to similar entities that are registered to
- 0 dispense marihuana for medical use in other jurisdictions, acquire, possess, cultivate, manufacture,
- 21 deliver, transfer, transport, supply, sell or dispense marihuana or related supplies and educational
- 22 materials to registered qualifying patients and visiting qualifying patients who have designated the

- 1 compassion center to provide for them, to registered designated caregivers on behalf of the registered

- 4 (j) A registered compassion center agent is not subject to prosecution, search or penalty in

- 6 disciplinary action by a court or business licensing board or entity, for working for a registered
- 7 compassion center pursuant to this article and department rules to acquire, possess, cultivate,
- 8 manufacture, deliver, transfer, transport, supply, sell or dispense marihuana or related supplies and
- 9 educational materials to registered qualifying patients who have designated the registered
- 10 compassion center to provide for them, to registered designated caregivers on behalf of the registered
- 11 qualifying patients who have designated the registered compassion center, or to other registered
- 12 compassion centers.
- 13 (k) A registered safety compliance facility and registered safety compliance facility agents
- 14 acting on behalf of a registered safety compliance facility are not subject to prosecution, search,
- 15 except by the department pursuant to subsection (o) of this section, seizure or penalty in any manner
- 16 or be denied any right or privilege including, but not limited to, civil penalty or disciplinary action
- 17 by a court or business licensing board or entity, solely for acting in accordance with this article and
- 18 department regulations to provide the following services:
- 19 (1) Acquiring or possessing marihuana obtained from registered cardholders or registered
- 20 compassion centers;
- 21 (2) Returning the marihuana to registered cardholders or registered compassion centers;
- 22 (3) Transporting marihuana that was produced by registered cardholders and registered

- 1 compassion centers to or from those registered cardholders and registered compassion centers;
- 2 (4) The production or sale of educational materials related to medical marihuana;
- 3 (5) The production, sale or transportation of equipment or materials other than marihuana to
- 4 registered compassion centers or cardholders, including lab equipment and packaging materials, that
- 5 are used by registered compassion centers and cardholders;
- 6 (6) Testing of medical marihuana samples, including for potency, pesticides, mold and 7 contamination;
- 8 (7) Providing training to cardholders and prospective compassion center agents, provided that
- 9 only cardholders may be allowed to possess or cultivate marihuana and any possession or cultivation
- of marihuana must occur on the location registered with the department; and
- 11 (8) Receiving compensation for actions allowed under this section.
- 12 (1) Any marihuana, marihuana paraphernalia, licit property or interest in licit property that
- 13 is possessed, owned or used in connection with the medical use of marihuana as allowed under this
- 14 article, or acts incidental to such use, may not be seized or forfeited. This article does not prevent
- 15 the seizure or forfeiture of marihuana exceeding the amounts allowed under this article, nor does it
- 16 prevent seizure or forfeiture if the basis for the action is unrelated to the marihuana that is possessed,
- 17 manufactured, transferred, or used pursuant to this article.
- 18 (m) Mere possession of, or application for, a registry identification card or registration
- 19 certificate does not constitute probable cause or reasonable suspicion, nor may it be used to support
- 20 the search of the person, property or home of the person possessing or applying for the registry
- 21 identification card. The possession of, or application for, a registry identification card does not
- 22 preclude the existence of probable cause if probable cause exists on other grounds.

- 1 (n) For the purposes of West Virginia state law, the medical use of marihuana by a cardholder
- 2 or registered compassion center shall be considered lawful as long as it is in accordance with this
- 3 article.
- 4 (o) A law-enforcement officer may not be employed by an agency which receives state or
- 5 local government funds nor may expend any state or local resources, including the officer's time,
- 6 to effect any arrest or seizure of marihuana, or conduct any investigation, on the sole basis of activity
- 7 the officer believes to constitute a violation of the federal Controlled Substances Act if the officer
- 8 has reason to believe that such activity is in compliance with state medical marihuana laws, nor may
- 9 any such officer expend any state or local resources, including the officer's time, to provide any
- 10 information or logistical support related to such activity to any federal law-enforcement authority
- 11 or prosecuting entity.
- 12 (p) An attorney is not subject to disciplinary action by the State Bar association or other
- 3 professional licensing association for providing legal assistance to prospective or registered
- 14 compassion centers, prospective or registered safety compliance facilities or others related to activity
- 15 that is no longer subject to criminal penalties under state law pursuant to this article.

16 **§16-8A-4.** Limitations.

- 17 (a) This article does not authorize any person to engage in, and does not prevent the
- 18 imposition of any civil, criminal, or other penalties for engaging in, the following conduct:
- 19 (1) Undertaking any task under the influence of marihuana, when doing so would constitute
- 20 negligence or professional malpractice;
- 21 (2) Possessing marihuana, or otherwise engaging in the medical use of marihuana:
- 22 (A) In a school bus;

1	(B) On the grounds of any preschool or primary or secondary school; or
2	(C) In any correctional facility.
3	(3) Smoking marihuana:
4	(A) On any form of public transportation; or
5	(B) In any public place.
6	(4) Operating, navigating or being in actual physical control of any motor vehicle, aircraft
7	or motorboat while under the influence of marihuana, except that a registered qualifying patient or
8	visiting qualifying patient may not be considered to be under the influence of marihuana solely
9	because of the presence of metabolites or components of marihuana that appear in insufficient
10	concentration to cause impairment.
11	(5) Using marihuana, if that person does not have a serious or debilitating medical condition.
12	§16-8A-5. Discrimination prohibited.
13	(a) Except as provided in this article, a registered qualifying patient who uses marihuana for
14	medical purposes shall be afforded all the same rights under state and local law, including those
15	guaranteed under the provisions of article eleven, chapter five of this code relating to human rights,
16	as the individual would have been afforded if he or she were solely prescribed pharmaceutical
17	medications, as it pertains to:
18	(1) Any interaction with a person's employer;
19	(2) Drug testing by one's employer; or
20	(3) Drug testing required by any state or local law, agency, or government official.

(b) (1) The rights provided by this section do not apply to the extent that they conflict with

- 1 an employer from a monetary or licensing-related benefit under federal law or regulations.
- 2 (2) An employer is not required to allow the ingestion of marihuana in any workplace or to
- 3 allow any employee to work while under the influence of marihuana. A registered qualifying patient
- 4 may not be considered to be under the influence of marihuana solely because of the presence of
- 5 metabolites or components of marihuana that appear in insufficient concentration to cause
- 6 impairment.
- 7 (c) A school or landlord may not refuse to enroll or lease to, or otherwise penalize, a person
- 8 solely for his or her status as a registered qualifying patient or a registered designated care giver,
- 9 unless failing to do so would violate federal law or regulations or cause the school or landlord to lose
- 10 a monetary or licensing-related benefit under federal law or regulations.
- (d) For the purposes of medical care, including organ transplants, a registered qualifying
 - 2 patient's authorized use of marihuana in accordance with this article is the equivalent of the
- 13 authorized use of any other medication used at the direction of a physician, and does not constitute
- 14 the use of an illicit substance or otherwise disqualify a qualifying patient from needed medical care.
- (e) A person otherwise entitled to custody of or visitation or parenting time with a minor may
- 16 not be denied such a right and there is no presumption of neglect or child endangerment for conduct
- 17 allowed under this article unless the person's actions in relation to marihuana were such that they
- 18 created an unreasonable danger to the safety of the minor as established by clear and convincing
- 19 evidence.
- 20 (f) A school, landlord or employer may not be penalized or denied any benefit under state law
- 21 for enrolling, leasing to or employing a cardholder.
- 22 §16-8A-6. Addition of debilitating medical conditions.

- Any citizen may petition the department to add conditions or treatments to the list of
- 2 debilitating medical conditions listed in section two(d) of this article. The department shall consider
- 3 petitions in the manner required by department rule, including public notice and hearing. The
- 4 department shall approve or deny a petition within one hundred eighty days of its submission. The
- 5 approval or denial of any petition is a final decision of the department subject to judicial review.
- 6 Jurisdiction and venue are vested in the circuit court.

7 §16-8A-7. Acts not required; acts not prohibited.

- 8 (a) Nothing in this article requires:
- 9 (1) A government medical assistance program or private insurer to reimburse a person for
- 10 costs associated with the medical use of marihuana, or
- 11 (2) Any person or establishment in lawful possession of property to allow a guest, client,
- 12 customer or other visitor to smoke marihuana on or in that property.
- 13 (b) Nothing in this article prohibits an employer from disciplining an employee for ingesting
- 4 marihuana in the workplace or working while under the influence of marihuana.

15 §16-8A-8. Registration of qualifying patients and designated care givers.

- 16 (a) The department shall issue registry identification cards to qualifying patients who submit
- 17 the following, in accordance with the department's rules:
- 18 (1) A written certification issued by a practitioner within ninety days immediately preceding

- 20 (2) If the patient is not a visiting qualifying patient, documentation required by department

- 9 (8) The name of the registered compassion center the qualifying patient designates, if any;
- 10 (9) If the qualifying patient designates a designated caregiver, a designation as to whether the
- 11 qualifying patient or designated caregiver will be allowed under state law to possess and cultivate
- 12 marihuana plants for the qualifying patient's medical use;
- 13 (10) A statement signed by the qualifying patient, pledging not to divert marihuana to anyone
- 14 who is not allowed to possess marihuana pursuant to this article; and
- 15 (11) A signed statement from the designated caregiver, if any, agreeing to be designated as
- 16 the patient's designated caregiver and pledging not to divert marihuana to anyone who is not allowed

- 18 (b) The application for qualifying patients' registry identification cards shall ask whether the
- 19 patient would like the department to notify him or her of any clinical studies needing human subjects

- 22 §16-8A-9. Issuance of registry identification cards.

- 1 (a) Except as provided in subsection (b) of this section, the department shall:
- 2 (1) Verify the information contained in an application or renewal submitted pursuant to this
- 3 article, and approve or deny an application or renewal, within fifteen days of receiving a completed
- 4 application or renewal application;

- 20 §16-8A-12. Notifications to department and responses; Civil penalty.

- 22 if a physical address had not been finalized when it applied, its physical address.

- 1 (f) The department shall issue each safety compliance facility a registration certificate, which

5 §16-8A-16. Compassion center and safety compliance facilities suspension and revocation.

- 6 (a) The department may on its own motion or on complaint, after investigation and
- 7 opportunity for a public hearing at which the compassion center or safety compliance facility has
- B been afforded an opportunity to be heard, suspend or revoke a registration certificate for multiple or
- 9 serious violations by the registrant or any of its agents of this article or any rules promulgated

- 9 (b) A registered compassion center or safety compliance facility agent must have
- 10 documentation when transporting marihuana on behalf of the registered safety compliance facility
- 11 or registered compassion center that specifies the amount of marihuana being transported, the date
- 12 the marihuana is being transported, the registry ID certificate number of the registered compassion
- 13 center or registered safety compliance facility and a contact number to verify that the marihuana is
- 14 being transported on behalf of the registered compassion center or registered safety compliance
- 15 facility.

16 §16-8A-19. Requirements, prohibitions, penalties.

- 17 (a) A registered compassion center shall be operated on a not-for-profit basis. The bylaws
- 18 of a registered compassion center shall contain such provisions relative to the disposition of revenues
- 19 to establish and maintain its not-for-profit character. A registered compassion center need not be
- 20 recognized as tax-exempt by the Internal Revenue Service and is not required to incorporate pursuant
- 21 to the provisions of chapter thirty-one-e of this code.
- 22 (b) The operating documents of a registered compassion center shall include procedures for

- 1 the oversight of the registered compassion center and procedures to ensure accurate record keeping.
- 2 (c) A registered compassion center and a registered safety compliance facility shall
- 3 implement appropriate security measures to deter and prevent the theft of marihuana and
- 4 unauthorized entrance into areas containing marihuana.
- 5 (d) A registered compassion center and a registered safety compliance facility may not be
- 6 located within one thousand feet of the property line of a preexisting public or private school.
- 7 (e) A registered compassion center is prohibited from acquiring, possessing, cultivating,
- 8 manufacturing, delivering, transferring, transporting, supplying or dispensing marihuana for the
- 9 purposes of distributing marihuana to any person except registered qualifying patients directly or
- 10 through their designated caregivers.
- 11 (f) All cultivation of marihuana for registered compassion centers must take place in an
- 12 enclosed, locked location at the physical address or addresses provided to the department during the
- 13 registration process, which can only be accessed by compassion center agents working on behalf of
- 14 the registered compassion center.
- 15 (g) A registered compassion center may not acquire usable marihuana or mature marihuana
- 16 plants from any person other than another registered compassion center, a registered qualifying
- 7 patient or a registered designated caregiver. A registered compassion center is only allowed to
- 18 acquire usable marihuana or mature marihuana plants from a registered qualifying patient or a
- 19 registered designated caregiver if the registered qualifying patient or registered designated caregiver
- 20 receives no compensation for the marihuana.
- 21 (h) Before marihuana may be dispensed to a designated care giver or a registered qualifying
- 22 patient, a registered compassion center agent must make a diligent effort to verify each of the

1 following:

- 2 (1) That the registry identification card presented to the registered compassion center is valid,
- 3 including by checking the verification system if it is operational;
- 4 (2) That the person presenting the card is the person identified on the registry identification
- 5 card presented to the registered compassion center agent, including by examining government-issued
- 6 photo identification; and
- 7 (3) That the registered compassion center the compassion center agent is working for is the
- 8 designated compassion center for the registered qualifying patient who is obtaining the marihuana
- 9 directly or via his or her designated caregiver.
- 10 (i) A registered compassion center may not dispense more than three ounces of marihuana
- 11 to a registered qualifying patient, directly or via a designated care giver, in any fourteen-day period.
- 12 Registered compassion centers shall ensure compliance with this limitation by maintaining internal,
- 13 confidential records that include records specifying how much marihuana is being dispensed to the
- 14 registered qualifying patient and whether it was dispensed directly to the registered qualifying patient
- 15 or to the designated caregiver. Each entry must include the date and time the marihuana was
- 16 dispensed.
- 17 (j) A registered compassion center or registered compassion center agent may only dispense
- 18 marihuana to a visiting qualifying patient if he or she possesses a valid West Virginia registry
- 19 identification card and if the procedures in subsections (h) and (i) are followed.
- 20 (k) A person may not advertise medical marihuana sales in printed materials, on radio or
- 21 television or by paid in-person solicitation of customers. This does not prevent appropriate signs on
- 22 the property of the registered compassion center, listings in business directories including phone

- 1 books, listings in marihuana-related or medical publications or the sponsorship of health or not-for-
- 2 profit charity or advocacy events.
- 3 (1) A registered compassion center may not share office space with nor refer patients to a4 practitioner.
- 5 (m) A practitioner may not refer patients to a registered compassion center or registered
- 6 designated caregiver, advertise in a registered compassion center or, if the practitioner issues written
- 7 <u>certifications, hold any financial interest in a registered compassion center.</u>
- 8 (n) Any person who has been convicted of a disqualifying felony offense may not be a
- 9 registered compassion center agent.
- 10 (o) Registered compassion centers and registered safety compliance facilities must display
- 11 their registration certificates on the premises at all times.
- 12 (p) The department may issue a civil fine of up to \$3,000 for violations of this section.
- 13 (q) The suspension or revocation of a certificate is a final department action, subject to
- 14 judicial review. Jurisdiction and venue for judicial review are vested in the circuit court.
- 15 (r) Any cardholder who sells marihuana to a person who is not allowed to possess marihuana
- 16 for medical purposes under this article shall have his or her registry identification card revoked and
- 17 is subject to other penalties for the unauthorized sale of marihuana.
- 18 (s) The department may revoke the registry identification card of any cardholder who
- 19 knowingly commits multiple or serious violations of this article.
- 20 (t) Registered compassion centers are subject to reasonable inspection by the department. The
- 21 department shall give a reasonable notice of an inspection under this paragraph.
- 22 §16-8A-20. Confidentiality.

- 1 (a) The following information received and records kept by department rules for purposes
- 2 of administering this article are confidential and exempt from the West Virginia Freedom of
- 3 Information Act, and not subject to disclosure to any individual or public or private entity, except
- 4 <u>as necessary for authorized employees of the department to perform official duties pursuant to this</u>
- 5 article:
- 6 (1) Applications and renewals, their contents and supporting information submitted by
- 7 qualifying patients and designated care givers, including information regarding their designated care
- 8 givers and practitioners.
- 9 (2) Applications and renewals, their contents and supporting information submitted by or on
- 10 behalf of compassion centers and safety compliance facilities in compliance with this article,
- 11 including their physical addressees.
- 12 (3) The individual names and other information identifying persons to whom the department
- 13 has issued registry identification cards.
- 14 (4) Any dispensing information required to be kept under the provisions of section nineteen
- 15 of this article or department rule shall identify cardholders and registered compassion centers by their
- 16 registry identification numbers and may not contain names or other personal identifying information.
- 17 (5) Any department hard drives or other data-recording media that are no longer in use and
- 18 that contain cardholder information must be destroyed.
- 19 (6) Data subject to this section may not be combined or linked in any manner with any other
- 20 list or database and it may not be used for any purpose not provided in this article.
- 21 (b) Nothing in this section precludes the following:
- 22 (1) Department employees may notify state or local law enforcement about falsified or

- 1 fraudulent information submitted to the department or of other apparently criminal violations of this
- 2 article if the employee who suspects that falsified or fraudulent information has been submitted
- 3 conferred with his or her supervisor and both agree that circumstances exist that warrant reporting.
- 4 (2) Department employees may notify the West Virginia Board of Medicine if the
- 5 department has reasonable suspicion to believe a practitioner did not have a bona fide practitioner-
- 6 patient relationship with a patient for whom he or she signed a written certification, if the department
- 7 has reasonable suspicion to believe the practitioner violated the standard of care, or for other

- 9 (3) Compassion center agents may notify the department of a suspected violation or

- 11 (4) The department may verify registry identification cards pursuant to section twenty-one

- 13 (5) The submission of the report to the Legislature required by the provisions of section
- 14 twenty-two of this article.
- 15 (c) Any person, including an employee or official of the department or another state agency
- 16 or local government, who breaches the confidentiality of information obtained pursuant to this
- 17 article is guilty of a misdemeanor and, upon conviction thereof, shall be fined \$1,000 or confined
- 18 in jail up to one hundred eighty days, or both fined and confined.
- 19 §16-8A-21. Registry identification and registration certificate verification.
- 20 (a) The department shall maintain a confidential list of the persons to whom the department
- 21 has issued registry identification cards and their addresses, phone numbers and registry identification
- 22 numbers. This confidential list may not be combined or linked in any manner with any other list or

1 database, nor may it be used for any purpose not provided in this article.

- (b) Within one hundred twenty days of the effective date of this article, the department shall

 setablish a verification system. The verification system must allow law-enforcement personnel,

 compassion center agents and safety compliance facility agents to enter a registry identification

 number to determine whether or not the number corresponds with a current, valid registry

 identification card. The system shall only disclose whether the identification card is valid; whether

 the cardholder is a registered qualifying patient or a registered designated care giver; whether the

 cardholder is permitted to cultivate under this act; and the registry identification number of the

 registered compassion center designated to serve the registered qualifying patient who holds the card

 or the registry identification number of the patient who is assisted by the registered designated
- (c) The department shall, at a cardholder's request, confirm his or her status as a registered
 qualifying patient or registered designated caregiver to a third party, such as a landlord, employer,
 school, medical professional or court.
- (d) The department shall disclose the fact that a registry identification card was revoked to
 a prosecutor or court personnel in any case where the prosecutor or court personnel inquires about
 a specific person who is seeking to assert the protections of the provisions of section thirteen of this
 article. The prosecutor or court personnel must provide the department with the person's name and
 date of birth.

20 **§16-8A-22.** Annual reports.

21 (a)(1) The Legislature shall appoint a nine-member oversight committee comprised of: One 22 member of the House of Delegates; one representative of the department; one member of the Senate;

- 1 one physician with experience in medical marihuana issues; one nurse; one board member or
- 2 principal officer of a registered safety compliance facility; one individual with experience in policy
- 3 development or implementation in the field of medical marihuana; and three registered patients.
- 4 (2) The oversight committee shall meet at least two times a year for the purpose of evaluating
- 5 and making recommendations to the Legislature and the Department of Health and Human
- 6 Resources regarding:
- 7 (A) The ability of qualifying patients in all areas of the state to obtain timely access to high-
- 8 quality medical marihuana.
- 9 (B) The effectiveness of the registered compassion centers, individually and together, in

- (D) The sufficiency of the regulatory and security safeguards contained in this article and
- 17 adopted by the department to ensure that access to and use of marihuana cultivated is provided only
- 18 to cardholders.
- 19 (E) Any recommended additions or revisions to the department rules or this article, including
- 20 relating to security, safe handling, labeling and nomenclature.
- 21 (F) Any research studies regarding health effects of medical marihuana for patients.
- 22 (b) The department shall submit to the Legislature an annual report that does not disclose any

- 1 identifying information about cardholders, registered compassion centers or practitioners, but does
- 2 contain, at a minimum, all of the following information:
- 3 (1) The number of applications and renewals filed for registry identification cards;
- 4 (2) The number of registered qualifying patients who are residents of West Virginia at the
- 5 <u>time of the report;</u>
- 6 (3) The number of registry identification cards that were issued to visiting qualifying patients
- 7 at the time of the report;
- 8 (4) The nature of the debilitating medical conditions of the qualifying patients;
- 9 (5) The number of registry identification cards revoked for misconduct;
- 10 (6) The number of practitioners providing written certifications for qualifying patients; and
- 11 (7) The number of registered compassion centers.
- 12 §16-8A-23. Department to issue rules.
- 13 (a) Not later than one hundred twenty days after the effective date of this article, the
- 4 department shall propose rules for legislative approval in accordance with the provisions of article
- 15 three, chapter twenty-nine-a of this code, which rules shall include:
- 16 (1) Governing the manner in which the department shall consider petitions from the public
- 17 to add debilitating medical conditions or treatments to the list of debilitating medical conditions set
- 18 forth in section two-d of this article, including public notice of and an opportunity to comment in
- 19 public hearings on the petitions;
- 20 (2) Establishing the form and content of registration and renewal applications submitted
- 21 under this article;
- 22 (3) Governing the manner in which it shall consider applications for and renewals of registry

- 1 identification cards, which may include creating a standardized written certification form; and
- 2 (4) Governing the following matters related to registered compassion centers, with the goal
- 3 of protecting against diversion and theft, without imposing an undue burden on the registered

- 10 (D) Electrical safety requirements;
- 11 (E) The competitive scoring process addressed in section fourteen of this article;
- 12 (F) Procedures for suspending or terminating the registration certificates or registry
- 13 identification cards of cardholders, registered compassion centers and registered safety compliance
- 14 facilities that commit multiple or serious violations of the provisions of this article or the rules
- 15 promulgated pursuant to this section; and
- (G) Labeling requirements for marihuana and marihuana products sold by compassion
- 17 centers.
- 18 (5) Application and renewal fees for registry identification cards, and application and
- 19 registration fees for compassion center and safety compliance facility certificates, according to the
- 20 following:
- 21 (A) The total fees collected must generate revenues sufficient to offset all expenses of
- 22 implementing and administering this article, except that fee revenue may be offset or supplemented

- 1 by private donations: Provided, That any excess revenue from fees and private donations shall be

- 3 (B) The department may establish a sliding scale of patient application and renewal fees

- 13 §16-8A-24. Enforcement of this article.
- 14 (a) If the department fails to promulgate rules to implement this article within the times
- 15 provided in this article, any citizen may commence an action in circuit court to compel the
- 16 department to perform the actions mandated pursuant to the provisions of this article.
- 17 (b) If the department fails to issue a valid registry identification card in response to a valid
- 18 application or renewal submitted pursuant to this article within twenty days of its submission, the
- 19 registry identification card shall be considered granted, and a copy of the registry identification
- 20 application or renewal and proof of receipt of the mailing shall be deemed a valid registry
- 21 identification card.
- 22 (c) If at any time after the one hundred forty days following the effective date of this article

- 1 the department has not established a process for accepting and approving or denying applications,
- 2 a notarized statement by a qualifying patient containing the information required in an application
- 3 pursuant to section eight of this article, together with a written certification issued by a practitioner
- 4 within ninety days immediately preceding the notarized statement, shall be considered a valid
- 5 registry identification card for all purposes under this article.

NOTE: The purpose of this bill is to create the "Compassionate Use Act for Medical Cannabis. It provides protections for the medical use of cannabis; defines debilitating medical conditions for which medical cannabis may be used; and authorizes the addition of debilitating medical conditions. The bill sets out limitations of this article. It prohibits discrimination against persons entitled to the protection of this article. The bill requires the registration of qualifying patients and designated caregivers and requires issuance of registry identification cards. The bill affords an affirmative defense and dismissal of proceedings for medical marihuana. It provides a misdemeanor offense and criminal penalties for disclosing certain information. And, the bill otherwise provides for enforcement of the provisions of this article.

This article is new; therefore it has been completely underscored.
