AN ACT to repeal §51-4-9 and §51-4-11 of the Code of West Virginia, 1931, as amended, relating to outdated provisions containing circuit clerk responsibilities with regard to indexes of books and reports concerning claims against the state.

*Be it enacted by the Legislature of West Virginia:*

**ARTICLE 4. GENERAL PROVISIONS RELATING TO CLERKS OF COURTS.**

**§1. Repeal of outdated provisions relating to circuit clerk responsibilities.**

- 1 §51-4-9 and §51-4-11 of the Code of West Virginia,
- 2 1931, as amended, are hereby repealed.
