1	A BILL supplementing, amending line items and transferring between items of the existing		
2	appropriations of Lottery Net Profits from the balance of moneys remaining as an		
3	unappropriated balance in Lottery Net Profits to the Bureau of Senior Services - Lottery		
4	Senior Citizens Fund, fund 5405, fiscal year 2016, to line 15a, dedicated to the Greater		
5	Weirton Area Senior Center, by supplementing, amending and transferring the		
6	appropriations for the fiscal year ending June 30, 2016.		
1	Whereas, The Governor submitted the Executive Budget Document to the Legislature or		
2	January 13, 2016, which included a Statement of the Lottery Fund setting forth therein the		
3	unappropriated cash balance as of July 1, 2015, and further included the estimate of revenues		
4	for the fiscal year 2016, less regular appropriations for fiscal year 2016; and		
5	Whereas, It appears from the Governor's Statement of the Lottery Fund, there now		
6	remains an unappropriated balance in the State Treasury which is available for appropriation		
7	during the fiscal year ending June 30, 2016; and		
8	Whereas, It appears that there is a need for funding the Greater Weirton Area Senior		
9	Center; therefore		
10	Be it enacted by the Legislature of West Virginia:		
11	That the total appropriation for the fiscal year ending June 30, 2016, to fund 5405, fiscal year		
12	2016, be supplemented and amended by adding line item 15a dedicated to the Greater Weirton		
13	Area Senior Center and increasing an existing item of appropriation as follows:
