1 A BILL to amend and reenact §18A-4-2 of the Code of West Virginia, 1931, as amended, relating  
2 to increasing salaries for teachers through fiscal year 2020.

*Be it enacted by the Legislature of West Virginia:*

1 That §18A-4-2 of the Code of West Virginia, 1931, as amended, be amended and  
2 reenacted to read as follows:

**ARTICLE 4. SALARIES, WAGES, AND OTHER BENEFITS.**

**§18A-4-2. State minimum salaries for teachers.**

1 ~~(a) It is the goal of the Legislature to increase the state minimum salary for teachers with~~  
2 ~~zero years of experience and an A. B. degree, including the equity supplement, to at least \$43,000~~  
3 ~~by fiscal year 2019.~~

4 ~~(b)~~ (a) Beginning July 1, 2014, and continuing thereafter, each teacher shall receive the  
5 amount prescribed in the state Minimum Salary Schedule as set forth in this section, specific  
6 additional amounts prescribed in this section or article and any county supplement in effect in a  
7 county pursuant to section five-a of this article during the contract year.
