1 A BILL to amend and reenact §24-2-2 of the Code of West Virginia, 1931, as amended, relating  
2 generally to public service districts; prohibiting shifting future development costs onto  
3 existing public service district customers.

*Be it enacted by the Legislature of West Virginia:*

1 That §24-2-2 of the Code of West Virginia, 1931, as amended, be amended and reenacted  
2 to read as follows:

**ARTICLE 2. POWERS AND DUTIES OF PUBLIC SERVICE COMMISSION.**

**§24-2-2. General power of commission to regulate public utilities.**

1 (a) The commission is hereby given power to investigate all rates, methods and practices  
2 of public utilities subject to the provisions of this chapter; to require them to conform to the laws  
3 of this state and to all rules, regulations and orders of the commission not contrary to law; and to  
4 require copies of all reports, rates, classifications, schedules and timetables in effect and used by  
5 the public utility or other person, to be filed with the commission, and all other information desired  
6 by the commission relating to the investigation and requirements, including inventories of all  
7 property in such form and detail as the commission may prescribe. The commission may compel  
8 obedience to its lawful orders by mandamus or injunction or other proper proceedings in the name  
9 of the state in any circuit court having jurisdiction of the parties or of the subject matter, or the  
10 Supreme Court of Appeals direct, and the proceedings shall have priority over all pending cases.  
11 The commission may change any intrastate rate, charge or toll which is unjust or unreasonable  
12 or any interstate charge with respect to matters of a purely local nature which have not been  
13 regulated by or pursuant to an act of Congress and may prescribe a rate, charge or toll that is just  
14 and reasonable, and change or prohibit any practice, device or method of service in order to  
15 prevent undue discrimination or favoritism between persons and between localities and between  
16 commodities for a like and contemporaneous service. But in no case shall the rate, toll or charge  
17 be more than the service is reasonably worth, considering the cost of the service. Every order  
18 entered by the commission shall continue in force until the expiration of the time, if any, named

19 by the commission in the order, or until revoked or modified by the commission, unless the order  
20 is suspended, modified or revoked by order or decree of a court of competent jurisdiction:  
21 *Provided*, That in the case of utilities used by emergency shelter providers, the commission shall  
22 prescribe such rates, charges or tolls that are the lowest available. "Emergency shelter provider"  
23 means any nonprofit entity which provides temporary emergency housing and services to the  
24 homeless or to victims of domestic violence or other abuse.

25 (b) Notwithstanding any other provision of this code to the contrary, rates are not  
26 discriminatory if, when considering the debt costs associated with a future water or sewer project  
27 which would not benefit existing customers, the commission establishes rates which ensure that  
28 the future customers to be served by the new project are solely responsible for the debt costs  
29 associated with the project. For water and sewer utilities, improvements that increase flow  
30 capacity for new customers and provide new infrastructure for new customers may not increase  
31 rates for existing customers.

NOTE: The purpose of this bill is to prohibit increasing rates of existing public service district customers to provide for increased services for new customers.
